GOVERNMENT NOTICE No. 463

HIS Excellency the Governor in Council has approved of the following Bill being introduced into the Legislative Council.

A Bill to Make Provisions for Regulating the Employment of Shop Assistants in the Municipality of Mombasa

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

- This Ordinance may be cited as the Mombasa Shop Short title. Assistants' Employment Ordinance, 1937.
- This Ordinance shall apply only to the Municipality Application of of Mombasa from such date as the Governor may by notice in the Gazette appoint.

3. In this Ordinance, unless the context otherwise Interpretation. requires-

"employer" means the person, company, association or partnership having charge of any shop or owning the business thereof or employing any person in or in connexion with any shop and includes the manager, agent or other person acting or apparently acting in the general management or control of any shop;

"shop" means any premises in which any retail, wholesale or both retail and wholesale trade or business is carried on, and includes any office, whether situated on the same premises or not, which is used in connexion with such trade or business;

"shop assistant" means any person employed for hire in a shop as a clerk or salesman, but does not include the staff of a licensed shipping agent connected with the agency work of ships;

"week" means the period between midnight on Saturday and midnight on the succeeding Saturday.

4. (1) On at least one day in each week a shop assistant Conditions of shall not be employed about the business of a shop after employment and meals. twelve o'clock noon.

- (2) An employer shall fix and shall specify in a notice in the prescribed form, which shall be affixed in the shop in such manner and at such time as may be prescribed, the day of the week on which his shop assistants are not employed after twelve o'clock noon, and may fix different days for different shop assistants.
- (3) Every shop assistant shall be allowed on each full working day a daily interval from work which shall be a continuous period of not less than two hours.
- (4) No shop assistant shall be required to work for a continuous period of more than five hours before or after such daily interval.

Hours of employment.

5. No shop assistant shall be employed in or about a shop for more than forty-nine hours, exclusive of intervals for meals, in any one week or for more than nine hours, exclusive of intervals for meals, in any one day.

Documents to be exhibited by an employer.

- 6. Every employer shall exhibit in a conspicuous place in his shop—
 - (a) a copy of this Ordinance translated into the language understood by the majority of the shop assistants employed therein and signed by the Superintendent of Police, Mombasa;
 - (b) a list in the form prescribed of the shop assistants employed therein; and
 - (c) a table in the form prescribed of the working hours of the shop assistants employed therein.

Power of police.

- 7. (1) It shall be the duty of the police to investigate and prosecute all offences under this Ordinance.
- (2) Any police officer, not below the rank of Assistant Inspector, may enter any shop to which this Ordinance applies and demand information for the purpose of ascertaining whether or not the provisions of this Ordinance are being observed.
 - (3) Any person wilfully-
 - (a) delaying or obstructing a police officer in the exercise of his powers under this Ordinance; or
 - (b) failing to supply the information demanded by a police officer; or

(c) preventing, or concealing in order to prevent, any shop assistant from appearing before or from being examined by a police officer,

shall be guilty of an offence against this Ordinance and shall be liable on conviction to a fine not exceeding ten pounds or in default of payment to imprisonment without hard labour for a period not exceeding one month.

8. Any employer contravening or failing to comply Penalties where with the provisions of this Ordinance or of any Rules made no other thereunder for which no penalty is expressly provided shall provided. be liable on conviction to a fine not exceeding—

- (a) in the case of a first conviction five pounds or in default of payment to imprisonment without hard labour for a period not exceeding fourteen days;
- (b) in the case of a second conviction ten pounds or in default of payment to imprisonment without hard labour for a period not exceeding one month;
- (c) in the case of a third or subsequent conviction thirty pounds or in default of payment to imprisonment without hard labour not exceeding one month.
- The Governor in Council may make rules—

Power to make Rules.

- (a) for prescribing anything which under this Ordinance may be prescribed; and
- (b) generally for carrying into effect the provisions of this Ordinance.
- The Governor in Council may exempt any person Power of or classes of person from all or any of the provisions of this Ordinance.

OBJECTS AND REASONS

The object of this Bill is to regulate the hours of employment of shop assistants in Mombasa.

- 2. Special legislation is necessary as the Shop Hours Ordinance, 1925, which has been applied to various centres in the Colony, is unsuitable for application to Mombasa.
- 3. No expenditure of public moneys will be involved if the provisions of this Bill become law.

Sub-section (1) of section 5 of the Principal Ordinance which it is proposed to replace:—

Hours of employment.

5. (1) No shop assistant shall be employed in or about a shop for more than fifty hours including meal times in any one week or more than nine hours in any one day:

Provided that for the purpose of stocktaking or other special emergency work that cannot be done during the usual hours, the working hours of shop assistants may be extended on days other than public holidays for periods not exceeding a total of one hundred hours in any year.

A Bill to Amend the Shop Hours Ordinance, 1925

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

1. This Ordinance may be cited as the Shop Hours short title. (Amendment) Ordinance, 1937, and shall be read as one with No. 24 of 1925. the Shop Hours Ordinance, 1925, hereinafter referred to as the Principal Ordinance.

Sub-section (1) of section 5 of the Principal Ordin-Repeal and ance is hereby repealed and the following is substituted therefor: --

replacement of Section 5 (1) of the Principal Ordinance.

employment of

shop assistants.

- "5. (1) An occupier shall not permit a shop assist Hours of tant to work in a shop—
 - (a) for more than eight hours in any one day, exclusive of intervals for meals, but so that such eight hours work together with such intervals for meals shall be completed within nine hours from the commencement of a day's work of such assistant;
 - (b) for more than fifty hours, inclusive of intervals for meals, in any one week;
 - (c) subject to the provisions of sub-sections (2) and (4) of this section, after one o'clock on any weekly half holiday;
 - (d) subject to the provisions of sub-sections (2) and (4) of this section, on any Sunday;
 - (e) subject to the provisions of sub-section (4) of this section, on any public holiday.
- (2) Where a shop is permitted to remain open—
 - (a) under the provisions of section 7 of this Ordinance, after one o'clock in the afternoon on any weekly half holiday; or

- (b) under the provisions of section 8 of this Ordinance, on any Sunday; or
- (c) under the provisions of section 9 of this Ordinance, after the time fixed for closing by a closing order,

any shop assistant may, subject to the provisions of paragraphs (a) and (b) of sub-section (1) of this section, be permitted to work in such shop during the hours that such shop is permitted to remain open.

- (3) Notwithstanding the provisions of paragraphs (a) and (b) of sub-section (1) of this section, the working hours of any shop assistant may, solely for the purpose of stocktaking, be extended for not more than two hours on any one day (other than on a Sunday or a public holiday) on not more than four days in any one week and on not more than thirty days in any one year.
- (4) Notwithstanding the provisions of paragraph (b) of sub-section (1) of this section an occupier, upon giving reasonable notice to the officer in charge of the police station of the district in which the shop is situate of the names of the assistants concerned and the dates upon which he intends to extend their working hours, may (on not more than two occasions in any year and solely for the purpose of stocktaking) permit such shop assistants, in any case where a Monday is a public holiday, to work on the Saturday afternoon, on the Sunday immediately preceding such Monday, and on such Monday. An occupier who avails himself of the provisions of this sub-section shall not be permitted to extend the hours of his shop assistants under the provisions of sub-section (3) of this section.
- (5) Save as is provided in this section, and that a shop assistant may remain in a shop for a period of fifteen minutes after the prescribed closing hour or after the hours permitted for his employment for the purpose of serving a customer who has entered the shop before the prescribed closing hour, or for the purpose of closing the shop, an occupier shall not permit an assistant to remain in his shop for a greater number of hours than those permitted under, or after the closing hour prescribed by, this Ordinance.

Sub-sections (2) and (3) of section 5 of the Principal Ordinance which it is proposed to amend:—

- (2) In each year of continuous service from the commencement of this Ordinance under the same employer a shop assistant shall be granted leave of absence on full pay for twelve clear working days to be taken in a consecutive period: Provided that the employer may fix the time of leave for the different shop assistants with reasonable regard to the exigencies of his business.
- (3) For the purpose of this section the expression "the same employer" shall include in case of the death of an employer, the legal reprsentative, heir or legatee of that employer, or in the case of insolvency or liquidation of the employer the receiver or liquidator, so long as such representative, heir, legatee, receiver or liquidator continues to carry on the business of that shop and to employ that shop assistant therein.

Section 8 of the Principal Ordinance which it is proposed to amend:—

Sunday closing.

8. All shops in townships and other areas to which this Ordinance applies shall be closed for the serving of customers on Sundays: Provided that where any local authority applies for exemption from Sunday closing the Governor in Council may grant such exemption either as to the whole or part of Sunday and either generally or in respect of any particular class of shops or trades.

Sub-section (1) of section 11 of the Principal Ordinance which it is proposed to amend:—

Approval of Governor in Council.

11. (1) After any order has been passed by a local authority it shall be submitted for the approval of the Governor in Council who shall consider any objections to the order and may either disallow the order or confirm the order with or without amendment. Every order so confirmed shall be published in the Gazette and thereupon shall have the force of law.

- (6) Any shop assistant found in a shop after the closing hour prescribed by this Ordinance or after the hours permitted for his employment under this Ordinance shall be deemed to be in the employment of such occupier until the contrary is proved by such occupier."
- Section 5 of the Principal Ordinance is hereby Amendment of amended by renumbering sub-section (2) and (3) thereof as section "5A (1)" and sub-section "(2)" respectively; and by Principal adding a marginal note thereto as follows-

Section 5 (2) and (3) of the Ordinance.

"Annual leave of absence."; and by renumbering sub-section (1) thereof as section "3".

4. Section 8 of the Principal Ordinance is hereby Amendment of amended by the deletion of the words "for the serving of Section 8 of the customers" which occur in the second line thereof.

5. Sub-section (1) of section 11 of the Principal Ordin- Amendment of ance is hereby amended by inserting therein, between the Section 11 (1) of the Principal word "any" and the word "order", which appear in the first Ordinance. line thereof, the word "closing".

Section 15 of the Principal Ordinance which it is proposed to amend:—

Penalties.

- 15. In the case of any contravention of or failure to comply with the provisions of this Ordinance the occupier of the shop shall be guilty of an offence punishable with a fine not exceeding:—
 - (a) In the case of a first conviction five pounds (or in default of payment to simple imprisonment for a period not exceeding fourteen days);
 - (b) In the case of a second conviction ten pounds (or in default of payment to simple imprisonment for a period not exceeding one month);
 - (c) In the case of a third or subsequent conviction thirty pounds (or in default of payment to simple imprisonment for a period not exceeding two months):

Provided that in the case of a shop assistant employed after hours in contravention of the Ordinance the occupier shall not be guilty of an offence against the Ordinance if he proves that his shop assistant was engaged only in serving customers whom he was already serving or who were in the shop before the closing hour or that there was reasonable ground for believing that the article supplied to the customer was required in case of illness.

6. Section 15 of the Principal Ordinance is hereby Amendment of amended by deleting therefrom the proviso thereto.

Section 15 of the Principal Ordinance.

OBJECTS AND REASONS

Although the Shop Hours Ordinance, 1925, provides that a shop shall not be open for serving customers after a certain hour, yet, in fact, employees are frequently kept at work in the shop long after that hour behind closed doors. object of this Bill is to remedy this state of affairs.

Section 5 of the Principal Ordinance at present provides that no shop assistant shall be employed in or about a shop for more than fifty hours including meal times in any one week or more than nine hours in any one day. In this Bill provision is made to the effect that subject to the exceptions hereafter mentioned no person shall employ any shop assistant for more than fifty hours in any one week including intervals for meals, or for more than eight hours in any one day excluding intervals for meals to be completed within nine hours from the commencement of the assistant's work, or on any Sunday or public holiday.

Provision is also made for the extension of the working hours of shop assistants during stocktaking and other emergency work which cannot be performed during the usual hours. There is a further provision to the effect that, except in exceptional circumstances, no assistant shall be permitted to remain in a shop for more than a quarter of an hour after closing time.

Finally, as the Principal Ordinance stands at present, all shops affected by it must be closed "for the serving of customers" on Sundays—it is provided in this Bill that such shops must be physically closed on Sundays.

No expenditure of public moneys will be involved if the provisions of this Bill become law.
