THE following correspondence between His Excellency the Governor and the General Officer Commanding, East Africa Force, is published for general information:—

> EAST AFRICA FORCE HEADQUARTERS, NAIROBI, KENYA, 22nd July, 1941.

Your Excellency,

The campaign in Abyssinia has now to all intents and purposes ended, and I wish to take this opportunity of tendering to Your Excellency my sincere thanks for the invaluable assistance which you and your Officers have always so readily given me. The loyal co-operation, given under Your Excellency's guidance, whole-heartedly and open-handedly by the residents of Kenya, irrespective of calling, race or creed, reflects the greatest credit on all concerned.

You will be doing me a great favour if you will convey to the Officers of your Government, and the non-official community, my very real thanks for all they have done. May the Indian, Arab and African Authorities who have so ably and willingly collaborated be included, since without their generous assistance the present successful conclusion could not have been reached.

It is, I am afraid, impossible for me to particularize in this matter, since the response by Kenya to the many calls made upon her has been in every respect magnificent.

There are, however, outstanding contributions to the common cause which I acknowledge with gratitude. These include the placing at the disposal of the military authorities of buildings, including schools and hospitals; the organization and control of supplies of military requirements of foodstuffs and materials. In the latter case the Kenya Supply Board, within the E.A. Supplies Board's organization, has given service of real value. The sound pre-war organization of the white personnel of the Colony enabled me to draw upon both the 1st Battalion, The Kenya Regiment, and the Kenya Defence Force for trained officers and non-commissioned officers to meet the increasing demands of the Force.

Unfortunately the war as a whole is not yet over but I am sure from what I have seen since I came to East Africa that Kenya's share in the common effort will go from strength to strength.

The tributes which you have been good enough to pay to the work of the Civil Government and to the voluntary assistance rendered by members of all communities are very much appreciated, and I propose to publish this correspondence in the Official Gazette for general information. The recognition which you have been good enough to give to the work of the Kenya Supply Board and to the part played by the European personnel of the Kenya Regiment and the Kenya Defence Force will be particularly appreciated.

The Governor's Deputy, during my absence in South Africa, has already conveyed to you and the officers and men under your command on behalf of the Government and peoples of Kenya an expression of the deep admiration of the notable military achievements of the campaign, but I should like to take this opportunity of associating myself personally with those sentiments, and of reaffirming the eager determination of the peoples of Kenya to meet with cheerfulness and resolution whatever demands may be made upon them till final victory is ours.

IN HIS MAJESTY'S COURT OF APPEAL FOR EASTERN AFRICA

THE next Sessions of His Majesty's Court of Appeal for Eastern Africa have been fixed to be holden at Mombasa to commence on Tuesday the 22nd day of July, 1941, at 10 a.m. or as soon thereafter as cases can be heard.

APPLICATIONS—THE Licensing Authority is not responsible for the contents of applications; its responsibility is confined to seeing that the notices in this publication agree with the applications received.

These published notices will be the only notice which will be given of these applications. This notice as printed will be in accordance with the particulars supplied by the applicants. The original applications, which in some cases give fuller details, can be inspected at the office of the Licensing Authority, c/o the Attorney General's Office, Nairobi, between the hours of 8.30 a.m. and 4 p.m. from Monday to Friday and between the hours of 8.30 a.m. and 12 noon on Saturday.

Any person who wishes to object to the grant of any of the licences applied for must submit his objection, on the prescribed form, so as to reach the Licensing Authority not later than fourteen days from the date hereof. A copy of every such objection must be sent by the objector to the applicant at the same time as it is sent to the Licensing Authority. The Licensing Authority may at its discretion consider objections, notwithstanding that they may not have been received within the prescribed period, but it is particularly requested that, so far as possible, all objections shall be made within the prescribed period.
