A Bill to Amend the Indian Succession Act, 1865, as Applied to the Colony

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title and commencement.

Amendment of

Section 248 of

the Principal

Act.

- 1. This Ordinance may be cited as the Succession Act (Amendment) Ordinance, 1941, and shall be read as one with the Indian Succession Act, 1865, as applied to the Colony, hereinafter referred to as the Principal Act, and shall be deemed to have come into force on the first day of August, 1941.
- 2. Section 248 of the Principal Act is hereby amended by adding thereto, at the end thereof, the following proviso:—

"Provided that no such verification shall be 10 required in the case of a will which contains an attestation clause showing that the will has been attested in accordance with the third rule prescribed by section 50 of this Act."

OBJECTS AND REASONS

Section 248 of the Indian Succession Act, 1865, as applied to the Colony, provides that, where an application is made for probate the petition shall be verified by at least one of the witnesses to the will. This requirement has, in the case of wills executed outside the Colony, always led to delay, and under war conditions is almost impossible of fulfilment. It is proposed, therefore, that, in cases where there is a proper attestation clause as required by English law or where the attestation clause shows that the requirements of the 3rd Rule to section 50 of the Act have been complied with, the verification required by the section shall be dispensed with. This Bill is designed to give effect to this suggestion.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

A Bill to Amend the Savings Bank Ordinance, 1936

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

This Ordinance may be cited as the Savings Bank Short title and (Amendment) Ordinance, 1941, and shall be read as one with commencethe Savings Bank Ordinance, 1936, hereinafter referred to as No. 29 of 1936. the Principal Ordinance, and shall come into operation on 5 the first day of January, 1942.

Section 5 of the Principal Ordinance is hereby Amendment of amended by deleting therefrom the words "post office" which section 5 of the Principal occur in the second line thereof and by substituting therefor Ordinance. the word "place."

3. Section 9 of the Principal Ordinance is hereby Repeal and *10* repealed and the following section is substituted therefor:—

replacement of section 9 of the Principal Ordinance.

"9. (1) Interest shall be payable on deposits at the Interest. rate of two and a half per centum per annum, or at such other rate as may be fixed from time to time by the Governor in Council with prior approval of the Secretary of State:

Provided that not less than three months' notice of any change of rate shall be given in the Gazette:

Provided further that such interest shall not be payable on any account the credit balance of which is less than twenty shillings or on any fraction of twenty shillings and shall not commence to accrue until the first day of the month next following the day of deposit, and shall cease in respect of any part of a deposit on the last day of the month preceding that in which authority to withdraw such part of the deposit shall have been given, or such part of the deposit shall be withdrawn, whichever shall first happen:

Provided further that in any case where a warrant for withdrawal issued in pursuance of such authority to withdraw is cancelled before payment has been made, interest on the amount specified in the warrant shall recommence to accrue from the first day of the month next following the day on which such warrant of withdrawal was issued.

(2) Interest on deposits shall, subject to the provisions of sub-section (1) of this section, be calculated to the thirty-first day of December in every year and shall then be added to and become part of any principal money remaining on deposit.

(3) The reference to "deposit" and "deposits" in this section shall include any interest credited to the account."

OBJECTS AND REASONS

It is desired to extend savings bank facilities in native reserves. In some centres where it is wished to provide these facilities no post office exists, though there is an administrative office or sub-office. In order to permit the establishment of savings banks in such places, the proposed amendment to section 5 of the Principal Ordinance is required.

Clause 3 amends the law to regularize the existing practice, which is in conformity with that adopted in the United Kingdom that the accretion of interest shall cease on the last day of the month preceding the date of the giving of the authority to withdraw rather than the date of actual withdrawal of part of a deposit.

Clause 3 is also designed to regularize the existing practice that when interest is credited to the capital sum that interest is to be regarded as a deposit for the purpose of the calculation of interest.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

Such plans, etc., shall be submitted in triplicate to the District Commissioner, Thika, for necessary action.

- 4. The grantee shall not at any time divide the plot without the permission of the Commissioner of Lands.
