#### THE TROUT PROTECTION ORDINANCE

TROUT-FISHING IN THE NORTH CHANIA RIVER IN THE NYERI DISTRICT

IN EXERCISE of the powers thereunto enabling me, I hereby declare that:

Government Notice No. 597 of 30th day of June 1943, and Government Notice No. 271 of 14th day of March, 1941, are cancelled.

That portion of the river upstream from the Forest Reserve boundary is closed for the purpose of trout-fishing.

That portion of the river downstream from the Forest Reserve boundary is opened for the purpose of trout-fishing.

In the North Chania River no person shall kill more than eight trout in any one day of which not more than four may be killed on that portion of the river downstream from the bridge at the fishing camp to the First Gorge (both points being defined by notice boards).

On that portion of the North Chania River downstream from the Forest Reserve boundary to the bridge at the fishing camp no trout less than ten inches in length shall be killed.

On that portion of the North Chania River downstream from the bridge at the fishing camp no trout less than 14 inches in length shall be killed.

No bait nor lure other than an artificial fly dressed on a single hook shall be used on the North Chania River throughout its length.

#### A Bill to Amend the Widows and Orphans Pension Ordinance

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Citation and commencement

- 1. (1) This Ordinance may be cited as the Widows and Orphans Pension (Amendment) Ordinance, 1945, and shall be read as one with the Widows and Orphans Pension Ordinance (Chapter 34 of the Revised Edition), hereinafter referred to as the principal Ordinance.
- (2) Subject to the provisions of sub-section (2) of section 2 of 5 this Ordinance, this Ordinance shall be deemed to have come into operation on the 1st day of January, 1944.

Amendment of section 2 (1) of the principal Ordinance.

- 2. (1) Sub-section (1) of section 2 of the principal Ordinance shall be amended as follows:—
  - (a) In the definition of the expression "Of a pensionable age" for 10 the word "eighteen" in both places in which it occurs there shall be substituted the word "twenty-one";
  - (b) For the definition of the word "Contributor" the following shall be substituted:—
    - "Contributor' means a contributor to the Scheme and 15 includes a person who has ceased to contribute in such circumstances that he continues to rank for benefit under this Ordinance":
  - (c) The following definitions shall be inserted immediately after the definition of the expression "East African Service":—

    "'Public Service' means service in a civil capacity under the Government of the Colony or the Government of any part of His Majesty's Dominions, or of any British Protected State or Protectorate, or of any territory in respect of which a mandate on behalf of the League of Nations has been 25 accepted by His Majesty or of the Anglo-Egyptian Sudan, or under the High Commissioner for Transport in Kenya and Uganda, or any other service which the Secretary of State may determine to be public service for the purposes of this Ordinance;

'Other public service' means public service not under the Government of the Colony";

- (d) The following definition is hereby inserted immediately after the definition of the "The Scheme":—
  - "'Approved scheme' means a scheme or fund for the 35 granting of pensions to the widows and children of officers in the public service, which has been declared by the Secretary of State to be an approved scheme for the purposes of this Ordinance".
- (2) Paragraph (a) of sub-section (1) of this section shall be 40 deemed to have come into operation on the 8th day of May, 1942:

Provided that where, before the date of the commencement of this Ordinance, by reason of the attainment of the age of eighteen years by a child of a deceased contributor, pension payable to any other person from the funds of the Colony has been increased, this 45 increase shall cease to be payable on the date aforesaid and not earlier.

(3) For the avoidance of doubts it is hereby declared that where any child of a deceased contributor shall have attained the age of eighteen years on or before the 7th day of May, 1942, the pension 50 thereupon ceasing to be payable to such child shall not become again payable by reason of provisions of paragraph (a) of sub-section (1) of this section.

Amendment of section 4 of the principal Ordinance.

- 3. Section 4 of the principal Ordinance is hereby amended—
- (a) by repealing paragraph (b) of sub-section (1) thereof and 55 substituting therefor the following paragraphs—
  - "(b) Officers, non-commissioned officers and men on the active list of the Royal Navy, the Regular Army or the Royal Air Force temporarily employed by an East African Government in either a military or a civil capacity and 60 not holding pensionable appointments under this Government;
  - (bb) persons in the service of this Government by reason only of their membership of any Naval, Military or Air Force constituted by local legislation in force in the Colony;";

(b) by repealing sub-section (3) thereof and substituting therefor the following sub-section:

"(3) Where an officer who is a contributor to an approved When officer scheme in other public service is transferred from such other public service to service under this Government-

And provided further that any such officer who prior to the 20 1st day of January, 1944, has been exempted under the provisions of the Ordinance then in force from becoming a contributor under this Ordinance and who marries subsequently to that date may at his option become a contributor under this Ordinance notwithstanding that he continues to contribute to such approved 25 scheme".

4. Sub-section (1) of section 5 of the principal Ordinance is hereby amended by inserting therein immediately after paragraph (d) thereof the following new paragraph:-

Amendment of section 5 (1) of the principal Ordinance.

"(e) the provisions of paragraph (b) of this sub-section shall not 30 apply to any officer who becomes a contributor after the 1st day of January, 1944".

5. Sub-section (2) of section 7 of the principal Ordinance is Amendment of hereby amended by deleting therefrom the words "The Government 35 shall deduct the contributions from the salaries of contributors" which occur in the first and second lines thereof and by substituting therefor the words:

section 7 (2) of the principal Ordinance.

"The Crown Agents shall deduct the contributions from the salaries of contributors when they are on leave, or when their salaries are wholly paid through the Crown Agents or from the pensions of contributors who retire on pension and elect to contribute under this Ordinance and whose pensions are payable through the Crown Agents. When a contributor's salary or pension is not wholly paid through the Crown Agents, his contributions shall be deducted from his salary or pension as the 45 case may be by the Government".

The principal Ordinance is hereby amended by inserting therein the following new section immediately after section 11 thereof:-

"11A. Upon the death of a contributor who is married or a widower with children of a pensionable age, the full pension registered in his name shall be payable subject to the other provisions of this Ordinance".

Amendment of the principal Ordinance.

Pension when officer with beneficiaries

The principal Ordinance shall have effect as if the following sub-sections were substituted for sub-section (1) of section 16 thereof:

(1) No widow of a contributor whose marriage with him is contracted after he has left the public service (unless he has elected to contribute under section 8 of the Widows and Orphans Pension (Amendment) Ordinance, 1932, and at the date of the No. 28 of 1932 marriage is so contributing or has ceased to do so by virtue of section 7 (1) or has attained the age of fifty-five and no issue of such marriage shall constitute a beneficiary for the purpose of this Ordinance or become entitled to pension.

Amendment of the principal Ordinance.

(1A) Sub-section (1) of this section

(a) shall not be inapplicable (notwithstanding the previous operation of that part of section 27 of the principal Ordinance which is repealed by this Ordinance) by reason only of a contributor's having ceased to contribute before the date of his marriage and before the commencement of this Ordinance; but

(b) shall not apply in respect of any contributor dying before the 8th day of May, 1942, or, save with the approval of the Secretary of State, in respect of any contributor who ceased to rank for benefit before the 1st day of January, 1934".

Repeal and replacement of section 17 of the principal Ordinance.

Provisions consequent upon an officer being dismissed for misconduct. 8. Section 17 of the principal Ordinance is hereby repealed and the following section is substituted therefor:—

- "17. Notwithstanding any other provisions of this Ordinance a contributor who is dismissed from the East African Service or other public service for misconduct shall cease to contribute under 5 this Ordinance, and
  - (a) where such contributor is a bachelor the total amount of his contributions under the Ordinance shall be repaid to him without interest subject to the deduction of any sums due by him to the Government; and
  - (b) where such contributor is a widower without children of a pensionable age the total amount of the contributions which he has paid since the death of his last wife or the ceasing to be of a pensionable age of his last child, whichever event shall have last happened, shall be repaid to him 15 without interest subject to the deduction of any sums due by him to the Government; and
  - (c) where such contributor is married or is a widower with a child of pensionable age he shall continue to rank for benefit to the extent of such part of the pension 20 registered in his name as his past contributions have earned."

9. Section 26 of the principal Ordinance is hereby repealed and the following section is substituted therefor:—

Repeal and replacement of section 26 of the principal Ordinance.
Refund of contribution to bachelor and widower without

children of pensionable age

"26. (1) If a contributor being-

(a) a bachelor, or

(b) a widower without children of pensionable age, leaves, attains the age of 55 years while still serving in, or dies in, the East African Service, there shall be payable to him or his legal representative—

(A) if such contributor is a bachelor, the total amount of his contributions together with compound interest thereon calculated with annual rests at the rate of two and one-half per centum, and

(B) if such contributor is a widower without children of 35 a pensionable age the total amount of contributions which he has paid since the death of his last wife or the ceasing to be of a pensionable age of his last child whichever event shall have last happened, together with compound interest 40 thereon calculated with annual rests at the rate of two and one-half per centum:

Provided that if any such contributor leaves the East African Service and is, without break of service, transferred to other public service in which an approved scheme has been established, 45 he may, at his option exercisable within three months, after he ceases to draw salary from this Government, elect not to receive a refund of his contributions with interest thereon as hereinbefore provided. The total amount to which he would be entitled on such refund shall thereupon remain as part of the funds of the scheme, 50 and, together with an amount representing compound interest calculated as from the date of his transfer with annual rests at the rate of two and one-half per centum, shall—

(a) if the contributor marries, be taken into account for the purpose of calculating any pension under this Ordinance; 55 or

(b) if the contributor dies or retires from the public service, be paid to him or to his legal representative:

And provided further that if any such contributor who so leaves the East African Service is transferred to any other public 60 service in which no approved scheme has been established, he may, at his option exercisable within three months after he ceases to draw salary from this Government, elect not to receive a refund with interest thereon as hereinbefore provided but to continue to contribute under this Ordinance at the rate at which 65 he was contributing immediately before he left the East African Service:

Such contributor may at any time thereafter cease to continue his contributions and in the event of his so ceasing to contribute—

(a) if he is then married or is a widower with children of a pensionable age, any pension payable on his death shall be reduced so as to correspond with the payments he has made; and

(b) in any other case, the first paragraph of this section shall apply as if he had left the East African Service at the date on which he so ceased to contribute.

(2) A contributor who has become entitled to a refund of contributions shall cease to rank for benefit by way of pension

under this Ordinance.

(3) Where a contributor is entitled to elect under this Ordinance not to receive such refund he shall not become entitled to a refund unless and until the time prescribed for the exercise of the election has expired and the election has not been exercised."

10. Sub-section (1) of section 27 of the principal Ordinance is Repeal and hereby repealed and the following sub-section is substituted there-

(2) Where any such contributor who has elected under (a) Full pension of sub-section (1) of this section ceases contributing under this Ordinance dies within two years of his retirement on pension on retires on on the day immediately preceding his retirement shall be payable subject to the other provision of the content of the other provision of the content of the other provision of the content subject to the other provisions of this Ordinance.

If a contributor who is married or who is a widower with children of pensionable age and who has not served the period necessary to qualify him for pension but who is otherwise eligible therefor retires from the East African Service or 15 other public service on a medical certificate before his period of contribution has expired, ceases to contribute and dies within two years, of the date of his retirement the full pension registered in his name on the date immediately preceding his retirement shall be payable subject to the other provisions of this Ordinance."

Repeal and replacement of section 28 of the principal Ordinance.

Registered pension in the case of nonpensionable officers leaving the service.

- 12. Section 28 of the principal Ordinance is hereby repealed and the following section is substituted therefor:—
  - "28. (1) A contributor who is married or who is a widower with children of a pensionable age and—
    - (a) whose service is not of such a nature or is not of such 25 length as would render him eligible for a pension if retired from the East African Service on a medical certificate and who retires from the East African Service or other public service; or
    - (b) whose service is of such a nature and of such length as 30 would have rendered him eligible for pension if he had retired from the East African Service on a medical certificate and who, being an officer who became a contributor under this Ordinance on or after the 1st day of January, 1944, retires from the East African Service 35 otherwise than on pension,

shall have registered in his name the pension actually earned by his past contributions and shall not be eligible to continue to contribute after the date of his retirement:

Provided that-

- (i) any such contributor may at his option exercisable as hereinafter provided in lieu of having registered such pension
  elect to have registered the full pension which was registered in his name at the date of his retirement for a
  period commencing from such date and equal to one-half
  of the period during which he contributed under this
  Ordinance and if he is alive on the expiration of the
  above-mentioned period during which he was entitled to
  rank for benefit under the scheme, he shall cease to be
  entitled to rank for benefit whether by way of pension 50
  or return of contributions; and
- (ii) where any such contributor who has exercised his option and elected under the preceding proviso to have the full pension registered in his name is appointed or reappointed to the service of this Government before the 55 expiration of the period for which the full pension is registered as aforesaid he shall as from the date of his appointment or reappointment commence or recommence to pay contributions under this Ordinance or if he so elects within three months of his appointment or 60 reappointment as from the expiration of the said period.
- (2) (a) The option referred to in proviso (i) of the preceding sub-section shall be exercisable not later than three months after the date on which the contributor ceases to draw salary.
- (b) The date of the exercise of the options under this section 65 shall be deemed to be the date of the receipt of the officer's written notification addressed either to the Accountant General in the Colony or to the Crown Agents."

Amendment of section 8 (1) of Ordinance No. 28 of 1932

- 13. Sub-section (1) of section 8 of the Widows and Orphans Pension (Amendment) Ordinance, 1932, is hereby amended—
  - (a) by deleting therefrom the word "and" which occurs in the second line of paragraph (c) thereof; and
  - (b) by deleting therefrom paragraph (d) thereof

In paragraph (b) of sub-section (1) of section 8 and section 9 of the Widows and Orphans Pension (Amendment) Ordinance, No. 28 of 1932. 1932, the words "public service" are hereby substituted for the words "service under the Crown".

15. (1) Where an officer shall be on leave from the service of this Government for the purpose of serving with His Majesty's Forces in time of war, or in consequence of having so served, then, notwithstanding anything contained in the principal Ordinance, his salary shall, for the purpose of computing his contributions under the principal 10 Ordinance, be deemed to be the salary which he would have received had he remained on duty in his substantive office.

Position of officers on war service.

(2) Where an officer shall, with the approval of the Governor or the Secretary of State, have left the service of this Government for the purpose aforesaid, then, notwithstanding anything contained in 15 the principal Ordinance, so long as it shall be the expressed intention of this Government and of the officer that he should, as soon as practicable after the termination of his service with His Majesty's Forces, return to the service of this Government, he may, by electing in such manner and within such time as may be directed by the 20 Governor, continue to contribute. If he so elects his salary shall, for the purpose of computing his contributions be deemed to be the salary which he would have received, with all increments for which he would have been eligible, if he had continued to hold the substantive office held by him immediately before so leaving the service of this Govern-25 ment:

#### Provided that-

- (a) if and so long as the officer shall be in receipt from the funds of this Government of payment in the nature of salary or other emoluments equivalent to, or greater than, the contributions which would be due from him if he elected under this sub-section to continue to contribute, he shall continue to contribute as aforesaid whether he shall or shall not elect so to do; and
- (b) where and so long as the provisions of this sub-section relating to the return of the officer to the service of this Government are inapplicable by reason only of a proposal that such officer should be appointed to other service under the Crown, this sub-section shall continue to apply to him until he is so appointed; and when he shall be so appointed he shall be deemed, for the purposes of the principal Ordinance, to have been transferred to such other service.
- (3) Where in any case to which sub-section (1) or sub-section (2) of this section applies, payment is being made from the funds of this Government to the officer in the nature of salary or other emolu-45 ments, his contributions may be deducted from the sums so payable; and where no such payment is being made, or if the contributions of the officer exceed such payments, the contributions or the balance thereof, as the case may be, shall be paid by the officer
- 4) If any officer who is entitled, under sub-section (2) of this 50 section, to elect to continue to contribute does not duly so elect, or if any officer fails to pay when due any sum payable by him under sub-section (3) of this section, the Governor or the Secretary of State may give either or both of the following directions, that is to say
  - (a) that the officer shall cease to contribute as from a date (which may be prior to the date of the direction) to be specified in the direction, and
    - (b) that the Pensions (War Service) Ordinance, 1940, shall not apply to this case,

and any such direction shall have the force of law.

(5) This section, notwithstanding anything contained therein, shall not apply where the office in the service of this Government last held by the officer prior to service in His Majesty's Forces was not a pensionable office for the purposes of the European Officers' Pensions No. 11 of 1927. Ordinance, 1927, except where in any particular case the Governor otherwise directs.

#### **OBJECTS AND REASONS**

The objects of this Bill, which is based on a model prepared in the Colonial Office, are-

(a) to clarify certain points in the principal Ordinance:

(b) to provide for certain adjustments in benefits on lines recommended by a Committee under the Chairmanship of the Government Actuary; and

(c) (by clause 15) to preserve the rights and set out the position of officers who are serving with His Majesty's Forces.

Under the present law a male child ceases to be eligible for benefit on attaining the age of 18 years. It is proposed to extend this to the age of 21 years under Clause 2 (1) (a) of the Bill.

Under section 4 (3) of the principal Ordinance an officer contributing to an approved scheme may claim exemption (unless he is already a contributor to the Kenya scheme) from becoming a contributor to the Kenya scheme and when such exemption has been claimed he may not subsequently become a contributor to the Kenya scheme unless he either ceases to contribute to the approved scheme or marries or leaves the service of the Government of the Colony and is subsequently reappointed to it. Under Clause 3 (b) of the Bill an officer contributing to an approved scheme is not eligible to become a contributor to the Kenya scheme except where his contributions to such approved scheme are less than he would have contributed to the Kenya scheme. In that case, under the proposed amendment he would pay the difference to the Kenya scheme and become a contributor as from the date of such payment.

Under section 5 of the principal Ordinance an officer may in certain circumstances elect to make an annual additional contribution of one-half of the contribution normally payable. Clause 4 of the Bill withdraws this election in the case of future contributors.

Under section 17 of the principal Ordinance an officer dismissed for misconduct is not entitled to rank for benefit whether by way of pension or return of contributions. Under Clause 8 of the Bill, if the officer is a bachelor the total amount of his contributions would be repaid to him without interest, and if a widower without children of pensionable age, the amount of the contributions paid by him since his wife died or since his last child ceased to be of pensionable age (whichever happened last) would be repaid to him without interest since the time he ceased to have a beneficiary. In the case of a married man or a widower with a child of pensionable age, registered pension would be adjusted to the contributions paid.

Under section 26 of the principal Ordinance if a bachelor or widower without children of a pensionable age attains the age of 55 years or dies in the East African service, half the total contributions in the former case and half the contributions since the ceasing to have beneficiaries in the latter must be refunded without interest. Under Clause 9 of the Bill full contributions would be refunded with compound interest at  $2\frac{1}{2}$  per cent per annum.

Under section 28 of the principal Ordinance if a non-pensionable contributor with beneficiaries whose period of payment of contributions has not expired dies in the East African service the beneficiaries receive four-fifths of the amount given in the Pension Tables. If such a contributor leaves the East African service otherwise than on transfer and dies within a period dating from the day of his leaving the service and equal to one-third of the number of completed months during which he contributed, his beneficiaries receive a pension at the same rate. Under Clause 12 of the Bill the reduction to four-fifths of the amount given by the Pension Tables would be abolished, the contributor on retirement would have registered in his name the pension actually earned by his past contributions and would not be eligible to contribute after the date of his retirement. He would, however, be able to elect to have the full pension in lieu of the reduced registered pension registered in his name for a period equal to one-half of the period which he contributed, and if he is alive at the expiration he would cease to be entitled to rank for benefit whether by way of pension or return of contributions.

The remaining amendments are of a minor character.

It is not possible to state what expenditure of public moneys would be involved if this Bill becomes law.
