##### PROPERTY CLAIMS IN GERMANY

IT IS notified for general information that the following advice has been received from the Secretary of State for the Colonies regarding claims in respect of property in Germany:—

“Any claims or inquiries from British subjects or British protected persons in the territory or territories with which you are concerned regarding property owned by them in Germany may be forwarded to me (in duplicate) for transmission to the Property Control Branch of the Control Commission of Germany.

Investigation of the property will be made, so far as circumstances permit, by specialist officers of the Control Commission, and all practicable steps will be taken to preserve it. Any information which may become available regarding the condition of any relevant property will be forwarded to you for transmission to the owner concerned.

Claims by other than British subjects or British protected persons or by refugees are not eligible for registration in the United Kingdom; and such claims including claims in respect of loss of property through anti-Semitic legislation before the war should not be forwarded to me.”

**A Bill to Amend the Personal Tax Ordinance, 1940**

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

No. 45 of 1940.

Amendment of section 3 (2) of the principal Ordinance.

Increase of tax payable by Europeans for the year 1946.

Provisions of section 6 of the principal Ordinance not to apply.

1. This Ordinance may be cited as the Personal Tax (Amendment No. 2) Ordinance, 1945, and shall be read as one with the Personal Tax Ordinance, 1940, hereinafter referred to as the principal Ordinance.

2. Sub-section (2) of section 3 of the principal Ordinance is hereby amended by deleting the word "sub-section", which appears in line two thereof, and by substituting therefor the word "section". 5

3. (1) The tax payable, under the provisions of section 3 of the principal Ordinance, for the year 1946, by every European resident in the Colony in that year, is hereby increased as follows— 10

(a) where the individual's total income does not exceed £60 per annum, by Sh. 5;

(b) where the individual's total income exceeds £60 but does not exceed £120 per annum, by Sh. 10;

(c) where the individual's total income exceeds £120, by Sh. 20. 15

(2) In this section, the expression "European" means any person of pure European origin or descent.

4. The provisions of section 6 of the principal Ordinance shall not apply to any increase in the amount of tax payable under the provisions of this Ordinance.

**MEMORANDUM OF OBJECTS AND REASONS**

The Report of the Select Committee of Legislative Council on the Hospital Scheme, which has been adopted by Council, recommended that the Scheme be brought into operation on the 1st January, 1946. Owing to heavy pressure of Council business it is not practicable to introduce and enact a comprehensive Bill covering the whole of the Scheme, before the end of this year.

The Report recommended that part of the Hospital contribution should be paid by reference to Personal Tax liability and since that tax falls due for payment on the 1st January, 1946, it is essential that legislation to enable such contributions to be collected should be enacted before the end of this year.

This Bill gives effect to the recommendations contained in sub-paragraph (a) of paragraph 4 and sub-paragraph (a) of paragraph 6 of the Select Committee's Report, by increasing the amount of Personal Tax payable for the year 1946 by Europeans resident in the Colony by Sh. 5, Sh. 10 and Sh. 20 (according to the amount of tax payable by each person). Clause 4 of the Bill exempts such additional payments from the penalty provisions contained in section 6 of the principal Ordinance.

A comprehensive measure, containing provisions designed to cover the complete Hospital Scheme, including the financing of it, will be introduced early in the new year.

It is not intended that this Bill shall in any way commit the Government to any particular method of financing the Hospital Scheme. The method of financing such Scheme will depend upon the recommendations made by the Select Committee of the Legislative Council, which it is proposed to appoint to consider the comprehensive measure, referred to above.

Pending the enactment of comprehensive legislation it is the intention of Government to forthwith appoint a provisional Hospital Authority which will take steps to ensure that contributors to the Scheme will obtain, as from the 1st January, 1946, benefits along the lines set out in paragraphs 39 and 46 of the Majority Report of the Hospital Committee, dated the 2nd August, 1944.

It is estimated that upon the introduction of the Hospital Scheme some £12,000 will be payable out of public funds but that there will be a saving on other expenditure estimated at £9,000, for 1946.

**A Bill to Amend the Bills of Exchange Ordinance, 1927**

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

1. This Ordinance may be cited as the Bills of Exchange (Amendment) Ordinance, 1945, and shall be read as one with the Bills of Exchange Ordinance, 1927, hereinafter referred to as the principal Ordinance. Short title.  
No. 7 of 1927.
- 5 2. Section 4 of the principal Ordinance is hereby amended as follows— Amendment of  
section 4 of  
the principal  
Ordinance.
  - (a) by the deletion of the words "the Colony" which occur in paragraphs (a) and (b) of sub-section (1) thereof and by the substitution therefor of the words "East Africa"; and
  - 10 (b) by the addition thereto of the following sub-section:—
 

"(3) For the purposes of this section 'East Africa' means the Colony and Protectorate of Kenya, the Tanganyika Territory, the Uganda Protectorate and the Zanzibar Protectorate."

**MEMORANDUM OF OBJECTS AND REASONS**

By virtue of the definition in section 4 of the principal Ordinance, i.e. the Bills of Exchange Ordinance, 1927 (No. 7 of 1927), bills of exchange drawn within East Africa but outside Kenya are foreign bills and, when dishonoured, require the formalities of protest to preserve a right of action against drawers and indorsers. This is inconvenient in an area comprising four territories so closely connected in their commercial relations as Kenya, Tanganyika, Uganda and Zanzibar. The effect of the amendment of the principal Ordinance now proposed will be to enlarge the scope of the definition of an inland bill so as to include a bill drawn in any one of those territories and payable in, or drawn upon a person resident in, another of them. Similar provision is contained in the Bills of Exchange Act, 1882, in respect of bills drawn in the United Kingdom, Isle of Man and the Channel Islands.

Legislation along similar lines is being enacted in the Tanganyika Territory, the Uganda Protectorate and the Zanzibar Protectorate.

No expenditure of public moneys will be involved if the provisions of this Bill become law.
