## GENERAL PRICE LEVEL—FEBRUARY, 1946

The general level of retail prices of consumers goods in Nairobi on 28th February, 1946, as measured by returns received from representative dealers, was 62.4 per cent above the pre-war level, while the corresponding figure for December, 1945, was 61.9 per cent. Imported articles were 72.3 per cent above the pre-war level and local products 54.3 per cent, while the corresponding figures for December, 1945, were 73 per cent and 53 per cent respectively.

Among local products, sugar, nicoline and most of the vegetables showed increases while macaroni, vermicelli, rice and ghee recorded slight decreases.
