# A BILL TO PROVIDE FOR THE REPATRIATION FROM THE COLONY OF EX-PRISONERS OF WAR

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows —

Short title

1. This Ordinance may be cited as the Repatriation of Ex-Prisoners of War Ordinance, 1947

Interpretation

2. In this Ordinance, unless the context otherwise requires, "ex-prisoner of war" means a person who entered or was brought into the Colony on or after the 3rd day of 5 September, 1939, as a prisoner of war and who is in the Colony on or after such date as the Governor may, by notice in the Gazette, appoint, unless such person has been readmitted to the Colony under the provisions of any law then in force relating to immigration or is in possession of a permit 10 signed by the Governor authorizing such person to remain in the Colony for such period as may be prescribed in such permit

Governor's power to repatriate

- 3. (1) The Governor may, by order under the hand of a person authorized by him for the purpose, order any ex- 15 prisoner of war to be repatriated from the Colony to such place as may be specified in such order
- (2) No appeal shall lie from any order made under the provisions of this section

Procedure

4. An ex-prisoner of war in respect of whom an order 20 has been made under the provisions of section 3 of this Ordinance may be arrested without a warrant and, pending his repatriation, be detained in such manner as may be directed in the order and thereafter may be placed on board any aircraft, ship or vehicle about to leave the Colony and, 25 while so detained, and until such aircraft, ship or vehicle is outside the borders of the Colony, shall be deemed to be in lawful custody, and no such person shall be admitted to bail except with the consent of the Governor

Power of arrest without order

- 5. (1) Notwithstanding anything hereinbefore contained, 30 any police officer may arrest without a warrant any person whom he has reasonable cause to suspect to be an ex-prisoner of war and shall detain such person pending the Governor's instructions concerning his disposal
- (2) Any police officer who has arrested any person under 35 the powers contained in sub-section (1) of this section shall forthwith report the details of such arrest to the Commissioner of Police who, immediately upon the receipt of such report, shall notify the Governor

# MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to confer upon the Governor power to repatriate ex-prisoners of war from the Colony

It is impossible to state what additional expenditure of public moneys will be involved if the provisions of this Bill become law
