Wardmaster, Medical Department

When the salary exceeds £360 per annum but does not exceed £520 per annum, house allowance is payable up to $7\frac{1}{2}$ per cent of salary, which may be increased to $17\frac{1}{2}$ per cent of the salary.

Candidates should have a knowledge of and experience in the organization and ordering of medical stores, drugs and dressings. The possession of a qualification in dispensing would be an advantage.

Inspecting Technician—East African Posts and Telegraphs Department

Applicants should be thoroughly conversant with the working of internal combustion engines, particularly modern high-speed Diesels and have had considerable experience of, and be skilled in, the practical work, *inter alia*, of installation and maintenance of Diesel-electric sets of not less than 40 horse-power; they should, preferably, have served an apprenticeship with a Diesel engine manufacturer or service agent of repute.

The candidate appointed to the post will be required to travel from time to time to all parts of East Africa but he will normally be stationed in a township; at the present time, the station is Nairobi.

CLAIMS BY VICTIMS OF NAZI OPPRESSION

IT IS notified for general information that a General Order has been promulgated by Military Government in the British Zone of Occupation ordering any person who has, or at any time since 30th January, 1933, has had, possession, custody or control of identifiable property of which any person was deprived under duress during the Nazi regime, by reason of his race, nationality, religion or political opinions, whether authorized by legislation or procedures which purported to follow forms of law or otherwise, to make, within six months from the date of this Order, a declaration of such possession, custody or control and to deliver it (in triplicate) to the Landrat of the Kreis or Oberbürgermeister of the Stadtkreis in which he resides.

Similar declarations must be made by any person who has knowledge of any specific transfer since 30th January, 1933, of such property, and must be delivered (in triplicate) to the Landrat of the Kreis or Oberbürgermeister of the Stadtkreis in which he resides.

In order to ensure that declared property is adequately protected, the Landrat or Oberbürgermeister to whom the declaration has been made has received detailed instructions of what steps he has to take. These include forwarding one copy of the declaration to:—

Das Zentralamt für Vermögensverwaltung,
(Britische Zone),
Bad Nenndorf,
Land Niedersachsen.

In the case of property situated in Berlin or elsewhere outside the British Zone of Occupation, all three copies of declarations are to be forwarded to the above address and the Landrat or Oberbürgermeister will hold such property in custody pending further directions.

The General Order also provides for the submission of claims by persons in respect of property of which they were dispossessed under the Nazi regime. Such claims will be forwarded (in triplicate) direct to Das Zentralamt für Vermögensverwaltung, and must be filed on or before 31st December, 1948. Claims filed after that date will be inadmissible.

Many dispossessed persons now living outside Germany have already submitted claims either to Norfolk House or to Stadthagen. These claims are in the course of being acknowledged but it has been found that in a large number of cases the necessary essential information has not been supplied. Members of the public who have already submitted claims are, therefore, advised to obtain copies of the forms mentioned below and to determine whether the information provided in the original claims met the full requirements as set out in the forms. If it did not, they are recommended to register their claims and forward them to the address given in paragraph 3.

The Order does not relate to any property having at the date of transfer a total value of less than 1,000 Reichsmarks.

The relevant forms for either giving information regarding property which has been transferred or for making specific claims to property may be obtained from Section G, the Secretariat, P.O. Box 621, Nairobi.
