A BILL TO AMEND THE SISAL INDUSTRY ORDINANCE, 1945

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

No. 21 of 1945.

1. This Ordinance may be cited as the Sisal Industry (Amendment) Ordinance, 1948, and shall be read as one with the Sisal Industry Ordinance, 1945, hereinafter referred to as the principal Ordinance.

Amendment of section 3 of the principal Ordinance.

- 2. Section 3 of the principal Ordinance is hereby 5 amended—
 - (a) by deleting paragraph (e) of sub-section (1) and substituting therefor the following paragraph:—
 - "(e) eight members to be appointed by the Association at a general meeting of the Association;"; 10 and
 - (b) by substituting the word "four" for the word "two" which appears in the first line of paragraph (a) of sub-section (3) thereof.

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance, the Sisal Industry Ordinance, 1945, in order to increase the number of members of the Kenya Sisal Growers Association on the Sisal Board from five to eight.

- 2. The Bill also seeks to amend the principal Ordinance by increasing the number of members of the Board who are required to retire annually, from two to four.
- 3. The above amendments are being made at the request of the Association.
- 4. No expenditure of public moneys will be involved if the provisions of this Bill become law.

BILL TO CONSOLIDATE AND **AMEND** LAW RELATING TO INTERPRETATION AND GENERAL CLAUSES

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

This Ordinance may be cited as the Interpretation Short title and and General Clauses Ordinance, 1948, and shall come into operation upon such date as the Governor may, by notice in the Gazette, appoint.

2. In this Ordinance and in every other Ordinance, and Interpretation in all public documents enacted, made or issued before or after the coming into operation of this Ordinance, the following words and expressions shall have the meanings hereby assigned to them respectively, unless there is something in 10 the subject or context inconsistent with such construction or unless it is therein otherwise expressly provided—

"act" used with reference to an offence or civil wrong, includes a series of acts, and words which refer to acts done extend to illegal omissions;

"administrative officer" means any Provincial Commis-15 sioner, deputy Provincial Commissioner, Officer in Charge of a District not included in a province, District Commissioner, District Officer, any officer appointed by the Governor to be an African Assistant Administrative Officer and any other 20 public officer who may be declared by the Governor by notice in the Gazette to be, or to be empowered to exercise the powers and duties of, an Administrative Officer, either generally or for the purposes of any specific Ordinance;

"advocate" means a person entitled to practise as such 25 in the Supreme Court or courts subordinate thereto under the provisions of the law for the time being applicable to advocates;

"Central Assembly" means the East Africa Central Legislative Assembly established under the East Africa (High 30 Commission) Order in Council, 1947;

"chapter", "part", "section" and "schedule" denote respectively a chapter, part and section of, and schedule to the Ordinance in which the word occurs, and "sub-section" denotes a sub-section of the section in which the word occurs:

"cognizable to the police" and "cognizable" used with 35 reference to an offence shall mean that any police officer may arrest without warrant any person whom he suspects upon reasonable grounds of having committed that offence;

"coin" means gold, silver and bronze or other coin 40 legally current in the Colony;

"Colony" means the Colony of Kenya and "Protectorate" means the Protectorate of Kenya: Provided that the expression "Colony" shall be taken as including the expression "Protectorate" unless the contrary intention is stated;

"commencement" used with reference to an Ordinance means the date on which the Ordinance comes into operation;

"common law" means the common law of England;

"court" means any court of the Colony of competent jurisdiction;

"Court of Appeal" means His Majesty's Court of Appeal for Eastern Africa or any court substituted therefor for the hearing and determining of appeals from the Supreme Court; 5

"Crown Agents" means the persons for the time being acting as Crown Agents for the Colonies in England or any of them:

"Crown lands" means all public lands in the Colony which are for the time being subject to the control of His Majesty, all lands which have been acquired by His Majesty for the public service or otherwise howsoever, and, with the exception of the areas of land the boundaries of which are set out in the First Schedule to the Native Lands Trust Ordinance, 1938, all lands occupied by the African tribes of the Colony 15 and all lands reserved for the use of the members of any such African tribe;

"district" means any of the administrative districts into which the Colony is divided by the Governor with the approval

"District Commissioner" means the district officer in charge of a district;

of the Secretary of State;

"District Officer" means any administrative officer subordinate to a deputy Provincial Commissioner;

"financial year" and "calendar year" mean the period 25 from the first day of January to the thirty-first day of December inclusive in the same year;

"Gazette" means the Official Gazette of the Colony and includes any Supplement thereto or any Gazette Extraordinary;

"Government" means the Government of the Colony; 30

"Government Analyst" includes any assistant or other analyst employed by the Government;

"Government Printer" means the Government Printer and includes any printer purporting to be the printer authorized to print Ordinances and other documents of the 35 Government;

"Governor" means the Governor of the Colony or any officer for the time being administering the government of the Colony;

"Governor in Council" or any cognate phrase means the 40 Governor acting with the advice of the Executive Council of the Colony, but not necessarily acting in such Council assembled, nor necessarily in accordance with such advice;

"High Commission" means the East Africa High Commission established by the East Africa (High Commis-45 sion) Order in Council, 1947;

"His Majesty" or "the King" includes His Majesty the King, His heirs and successors;

"immovable property" includes land, benefits to arise out of land, and things attached to the earth or permanently 50 fastened to anything attached to the earth;

"Imperial Parliament" and "Parliament" mean the Parliament of the United Kingdom;

"Judge" means a judge of the Supreme Court;

"Legislative Council" means the Legislative Council of 55 the Colony;

"magistrate" means a judge or magistrate of a subordinate court or of a Muslim subordinate court, constituted by the Courts Ordinance, 1931;

"medical practitioner" means a medical practitioner duly registered as such under the provisions of any law for the time being applicable to medical practitioners;

"Member" means any ex-officio member of the Executive 5 Council of the Colony;

"month" means calendar month;

"movable property" means property of every description except immovable property;

"oath" and "affidavit", in the case of persons for the time being allowed by law to affirm or declare instead of swearing, include affirmation or declaration, and "swear", in the like case, includes "affirm" or "declare";

"or", "other" and "otherwise" shall, unless a contrary intention appears, be construed disjunctively and not as implying similarity, unless the word "similar" or some other word of like meaning is added;

"Ordinance" shall include any order, proclamation, rule, regulation, or by-law, duly made under the authority of an Ordinance and in force; and the expression "the Ordinance", when used in any such order, proclamation, rule, regulation, or by-law, means the Ordinance under the authority of which such order, proclamation, rule, regulation, or by-law, as the case may be, has been made;

"person" includes any company or association or body 25 of persons, corporate or unincorporate;

"prescribed" means prescribed by the Ordinance in which the word occurs or by any rules made thereunder;

"province" means any of the provinces of the Colony into which it is divided by the Governor with the approval of the 30 Secretary of State;

"Provincial Commissioner" means the officer in charge of a province and includes a deputy Provincial Commissioner;

"registered" used with reference to a document means registered under the provisions of the law for the time being applicable to the registration of such document;

"rule" includes by-law and regulation;

"rules of court", when used in relation to any court, means rules made by the authority having for the time being power to make rules or orders regulating the practice and procedure of such court;

"Secretary of State" means one of His Majesty's Principal Secretaries of State;

"service by post"—Where any Ordinance authorizes or requires any document to be served by post, whether the expression "serve" or the expression "give" or "send" or any other expression is used, then, unless a contrary intention appears, the service shall be deemed to be effected by properly addressing, prepaying and posting, by registered post, a letter containing the document, and, unless the contrary is proved, to have been effected at the time at which the letter would be delivered in the ordinary course of the post;

"ship" includes every description of vessel used in navigation not propelled by oars;

"sign", with its grammatical variations and cognate expressions, with reference to a person who is unable to write his name, includes "mark", with its grammatical variations and cognate expressions;

"statutory declaration", if made-

(a) in the Colony, means a declaration made under the Statutory Declarations Ordinance, 1926;

(b) in the United Kingdom or any British possession beyond the Colony, means a declaration made before a justice of the peace, notary public or other person

having authority therein under any law for the time being in force to take or receive a declaration;

(c) in any other place, means a declaration made before a British consul or vice-consul, or before any person having authority under any Act of Parliament for the 5 time being in force to take or receive a declaration;

"subsidiary legislation" means any order in council, proclamation, rule, regulation, order, notice, by-law or other instrument made under any Ordinance or other lawful authority and having legislative effect;

"Supreme Court" means His Majesty's Supreme Court of Kenya;

"territorial waters" means any part of the open sea within three nautical miles of the coast of the Colony measured from low water mark, and includes any inland waters of the Colony; 15

"United Kingdom" means Great Britain and Northern Ireland;

"vessel" includes any ship or boat or any other description of vessel used in navigation;

"will" includes codicil;

words importing the masculine gender include females; words in the singular include the plural and words in the plural include the singular;

"writing" and expressions referring to writing include printing, photography, lithography, typewriting and any other 25 modes of representing or reproducing words in visible form;

"year" means a year reckoned according to the British calendar.

Ordinances to be public Ordinances.

- 3. Every Ordinance shall be a public Ordinance and shall be judicially noticed as such, unless the contrary is 30 expressly provided by the Ordinance.
- Ordinances to be divided into sections without any introductory words.
- 4. All Ordinances shall be divided into sections, if there be more enactments than one, which sections shall be deemed to be substantive enactments without any introductory words.

Date of coming into operation.

5. The Clerk of the Legislative Council shall inscribe on 35 every Ordinance the day, month and year when the same shall have received the Governor's assent, and such inscription shall be taken to be a part of such Ordinance and to be the date of its coming into operation where no other commencement shall be therein provided.

Mode of citing Ordinance.

6. Where any Ordinance is referred to, it shall be sufficient for all purposes to cite such Ordinance either by the short title, if any, by which it is made citable, or by the year in which it was made and its number among the Ordinances of that year, or, in the case of any revised edition of the 45 Ordinances issued under any Ordinance providing for the issue of a revised edition, by its short title or its number; and the reference may in all cases be made according to the copies of Ordinances printed in England or by the Government Printer.

Time when Ordinance or subsidiary legislation comes into operation. 7. Where any Ordinance, or part of an Ordinance, or any subsidiary legislation, came or comes into operation on a particular day, it shall be deemed to have come or shall come into operation immediately on the expiration of the day next preceding such day.

Repealed Ordinances not revived. 8. Where any Ordinance repealing in whole or in part any former Ordinance is itself repealed, such last repeal shall not revive the Ordinance or provisions before repealed unless words be added reviving such Ordinance or provisions.

Where an Ordinance repeals wholly or partially any Repeal and former enactment and substitutes provisions for the enactment repealed, the repealed enactment shall remain in force until the substituted provisions come into operation.

10. (1) Where in any Ordinance a reference is made to another Ordinance, such reference shall, except where the context otherwise requires, be deemed to include a reference to such last-mentioned Ordinance as the same may from repealing time to time be amended.

Provisions with respect to amended Ordinance and effect of Ordinance.

- (2) Where an Ordinance repeals and re-enacts, with or without modification, any provision of a former Ordinance, references in any other Ordinance to the provision so repealed shall, unless the contrary intention appears, be construed as references to the provision so re-enacted.
- (3) Where an Ordinance repeals any other enactment, then, unless the contrary intention appears, the repeal shall not-
 - (a) revive anything not in force or existing at the time at which the repeal takes effect; or
 - (b) affect the previous operation of any enactment so repealed or anything duly done or suffered under any enactment so repealed; or
 - (c) affect any right, privilege, obligation or liability acquired, accrued or incurred under any enactment so repealed; or
 - (d) affect any penalty, forfeiture, or punishment incurred in respect of any offence committed against any enactment so repealed; or
 - (e) affect any investigation, legal proceedings, or remedy in respect of any such right, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid, and any such investigation, legal proceeding, or remedy may be instituted, continued or enforced, and any such penalty, forfeiture or punishment may be imposed, as if the repealing Ordinance had not been made.
- 11. (1) Where one Ordinance amends another Ordinance, Construction of the amending Ordinance shall, so far as it is consistent with the tenor thereof, and unless the contrary intention appears, rules with 40 be construed as one with the amended Ordinance.

Ordinance or amended Ordinance or rules.

- (2) Where rules amend other rules the amending rules shall, so far as is consistent with the tenor thereof, and unless the contrary intention appears, be construed as one with the amended rules.
- 12. Where an Ordinance confers power on any authority 45 to make subsidiary legislation the following provisions shall, unless the contrary intention appears, have effect with reference to the making of such subsidiary legislation—
 - (a) subsidiary legislation may at any time be amended, varied, rescinded or revoked by the same authority and in the same manner by and in which it was made;
 - (b) there may be annexed to the breach of any subsidiary legislation such penalty not exceeding one hundred pounds or such term of imprisonment not exceeding two months, or both, as the authority making the subsidiary legislation may think fit, subject to disallowance by His Majesty;
 - (c) no subsidiary legislation shall be inconsistent with the provisions of any Ordinance;
 - (d) subsidiary legislation shall be published in the Gazette and shall have the force of law upon such publica-

General provisions with respect to power given to any authority to make subsidiary legislation.

- tion thereof or from the date named therein, subject to disallowance by His Majesty;
- (e) where any Ordinance confers power on any authority to make subsidiary legislation for any general purpose, and also for any special purposes incidental thereto, the enumeration of the special purposes shall not be deemed to derogate from the generality of the powers conferred with reference to the general purpose.

Construction of subsidiary legislation.

13. Where any Ordinance confers power to make any 10 subsidiary legislation, expressions used in the subsidiary legislation shall, unless the contrary intention appears, have the same respective meanings as in the Ordinance conferring the power.

Effect of repeal of Ordinance on subsidiary legislation made under it. 14. Where any Ordinance or part of an Ordinance is 15 repealed, subsidiary legislation issued under or made in virtue thereof shall remain in force so far as it is not inconsistent with the repealing Ordinance and, unless the contrary intention appears, until it has been revoked or repealed by subsidiary legislation, issued or made under the provisions of such repeal- 20 ing Ordinance.

Acts done under subsidiary legislation to be deemed done under Ordinance by which subsidiary legislation authorized.

15. An act shall be deemed to be done under any Ordinance or by virtue of the powers conferred by any Ordinance or in pursuance or execution of the powers of or under the authority of any Ordinance, if it is done under or by virtue 25 of or in pursuance of subsidiary legislation made under any power contained in that Ordinance.

Signification of orders, etc., of the Governor in Council.

16. Where any Ordinance confers upon the Governor in Council power to make any subsidiary legislation or appointment, give any directions, issue any order, authorize any thing 30 or matter to be done, grant any exemption, remit any fee or penalty or exercise any other power, it shall be sufficient if the exercise of such power by the Governor in Council be signified under the hand of the Clerk to the Executive Council:

Signification of orders, etc., of the Governor

17. Where any Ordinance confers upon the Governor power to make any subsidiary legislation or appointment, give any directions, issue any order, authorize any thing or matter to be done, grant any exemption, remit any fee or penalty or exercise any other power, it shall be sufficient if the exercise 40 of such power by the Governor be signified under the hand of a Member:

Provided always that the foregoing shall not apply to the power of the Governor to make or issue any warrants or proclamations which shall be made or issued only under the hand 45 of the Governor himself.

Deviation from forms.

18. Save as is otherwise expressly provided, whenever any form is prescribed, an instrument or document which purports to be in such form, shall not be void by reason of any deviation therefrom which does not affect the substance 50 of such instrument or document, or which is not calculated to mislead.

Appointment of officers by name or office.

19. Where by or under any Ordinance the Governor or any public officer or body is empowered to appoint or name a person to have and exercise any powers or perform any 55 duties, the Governor or such public officer or body may either appoint a person by name or direct the person for the time being holding any office designated by the Governor, or by such public officer or body, to have and exercise such powers and perform such duties; and thereupon, or from the date 60 specified by the Governor or by such public officer or body, the person appointed by name or the person holding the office aforesaid shall have and may exercise such powers and perform such duties accordingly.

20. Where by or under any Ordinance a power to make Power to any appointment is conferred, then, unless the contrary inten- include power tion appears, the authority having power to make the to suspend or appointment shall also have power to suspend or dismiss any 5 person appointed by it in exercise of the power.

21. Where by or under any Ordinance, any powers are Power of conferred or any duties are imposed upon a public officer, the Governor may direct that if during any period owing to absence or inability to act from illness or any other cause such 10 public officer shall be unable to exercise the powers or perform the duties of his office in any place under his jurisdiction or control, such powers shall be had and may be exercised and such duties shall be performed in such place by a person named by or by the public officer holding any office designated 15 by the Governor; and thereupon such person or public officer, during any period as aforesaid, shall have and may exercise the powers and shall perform the duties aforesaid, subject to such conditions, exceptions and qualifications as the Governor may direct.

Governor to provide for execution of duties of public officer during temporary absence or inability.

20 22. (1) Where reference is made in any Ordinance to any Official public officer by the term designating his office, such term designation to shall include the officer for the time being executing the duties executing duties. of such office or any portion of such duties.

- (2) Any civil or criminal proceedings taken by or against 25 any person in virtue of his office shall not be discontinued or abated by his death, resignation, or absence or removal from office, but may be carried on by or against, as the case may be, the person appointed to perform the duties of the office.
- 23. Where by any Ordinance the Governor is empowered Power of 30 to exercise any powers or perform any duties, he may, unless Governor to by law expressly prohibited from so doing, depute any person by name or the person for the time being holding any office designated by him to exercise such powers or perform such duties on his behalf, subject to such conditions, exceptions and 35 qualifications as the Governor may prescribe, and thereupon or from the date specified by the Governor the person so deputed shall have and exercise such powers and perform such duties subject as aforesaid: Provided that, subject to the provisions of any Letters Patent or Royal Instructions relating to 40 the appointment of a Governor's Deputy, nothing herein contained shall authorize the Governor to depute any person—

- (a) other than a Member, to make rules;
- (b) to issue warrants or proclamations or to hear any appeal,
- 45 under the power in that behalf conferred upon him by any Ordinance.
- 24. Where any law confers any power or imposes any duty, then, unless a contrary intention appears, the power may be exercised and the duty shall be performed from time to 55 time as occasion requires.

Powers to be exercised and duties to be performed from time to time.

25. Where any Ordinance which is not to come into Power to make operation immediately on the passing thereof confers power regulations, etc., to make rules, regulations, or by-laws, or to issue orders with respect to the application of the Ordinance, or for the in force. 60 appointment of any officer, or for the establishment of any office thereunder, or with respect to the person by whom, or the time when, or the place where, or the manner in which, or the fees for which, anything is to be done under the Ordinance, the power may be exercised at any time after the 65 passing of the Ordinance, but the rules, regulations or bylaws so made or the orders so issued shall not take effect until the Ordinance comes into operation.

Computation of time.

- 26. In computing time for the purposes of any Ordinance, unless the contrary intention appears—
 - (a) a period of days from the happening of an event or the doing of any act or thing shall be deemed to be exclusive of the day on which the event happens or 5 the act or thing is done;
 - (b) if the last day of the period is Sunday or a public holiday (which days are in this section referred to as excluded days) the period shall include the next following day, not being an excluded day;
 - (c) where any act or proceeding is directed or allowed to be done or taken on a certain day, then, if that day happens to be an excluded day, the act or proceeding shall be considered as done or taken in due time if it is done or taken on the next day afterwards, not 15 being an excluded day;

27. Where any expression of time occurs in any Ordinance, deed or other legal instrument, the time referred to shall, unless it is otherwise expressly provided, be held to signify the standard time adopted for the Colony.

Provisions where no time prescribed.

28. Where no time is prescribed or allowed within which 25 anything shall be done, such thing shall be done with all convenient speed, and as often as the prescribed occasion arises.

Measurement of distances.

29. In the measurement of any distance for the purposes of any Ordinance, that distance shall, unless the contrary intention appears, be measured in a straight line on a horizontal 30 plane.

Imperial Acts and other applied laws to be read with necessary modifications. 30. Where by any Order of the King in Council or Ordinance, any Act of the Imperial Parliament or the law of any other country is extended or applied to the Colony such Act or law shall be read with such formal alterations as to 35 names, localities, courts, officers, persons, moneys, penalties or otherwise as may be necessary to make the same applicable to the circumstances.

Provisions as to offences under two or more laws.

31. Where an act or omission constitutes an offence under two or more Ordinances, or both under an Ordinance 40 and under any other law which applies to the Colony, the offender shall, unless the contrary intention appears, be liable to be prosecuted and punished under either or any of those Ordinances or under such other law, but shall not be liable to be punished twice for the same offence.

Application of Ordinances to Protectorate.

32. Every Ordinance, whether enacted or issued before or after the commencement of this Ordinance, shall be taken as applying both to the Colony and to the Protectorate unless its application is otherwise limited either expressly or by necessary implication.

Power of officers in charge of extra-provincial districts. 33. Where under the provisions of any Ordinance powers are conferred on or duties are appointed to be performed by a Provincial Commissioner, then, in districts which are not included in any province, such powers shall be exercised or such duties performed by the officer in charge of such district, 55 and in any such case the word "province" shall be construed as if it were equivalent to the word "district".

Power of majority of more than two persons.

34. Save as is otherwise expressly provided by any Ordinance, where any act or thing is required to be done by more than two persons, a majority of them may do it.

MEMORANDUM OF OBJECTS AND REASONS

The Ordinance relating to Interpretation and General Clauses has been amended on so many occasions since its enactment in 1912 and is so out of date, that it is considered desirable to repeal the existing Ordinance and introduce new legislation more consistent with present day requirements. In view of the fact that a general revision of the Colony's Ordinances and subsidiary legislation is now being made, the present time is considered opportune for the taking of such action, and this Bill is therefore being introduced for that purpose.

BILL TO AMEND THE TRADE UNIONS AND TRADE DISPUTES ORDINANCE, 1943

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:

1. This Ordinance may be cited as the Trade Unions Short title. and Trade Disputes (Amendment) Ordinance, 1948, and shall be read as one with the Trade Unions and Trade Disputes Ordinance, 1943, hereinafter referred to as the principal No. 1 of 1943. 5 Ordinance.

2. Section 8 of the principal Ordinance is hereby re- Repeal and pealed and the following section substituted therefor:—

replacement of section 8 of the principal Ordinance.

"8. (1) Every trade union shall apply for registration in accordance with the provisions of this Ordinance within three months after the date of its formation and shall be dissolved within three months after the date of-

Compulsory registration and dissolution.

- (a) a notification by the Registrar that he has refused, under the provisions of sub-section (1) of section 10 of this Ordinance, to register the trade union, provided no appeal has been taken against such refusal under the provisions of sub-section (3) of section 10 of this Ordinance; or
- (b) the dismissal of an appeal taken under the provisions of sub-section (3) of section 10 of this Ordinance.
- (2) Every trade union required to be dissolved under the provisions of sub-section (1) of this section which is not so dissolved and every officer thereof, and every trade union which fails to apply for registration within three months of its formation and every officer and member thereof, shall be liable on summary conviction to a fine of five pounds for every day it remains undissolved or for every day, in excess of three months, after the date of its formation, in respect of which it fails to apply for registration.".

3. Section 10 of the principal Ordinance is hereby amended—

- (a) by deleting the comma, which appears at the end of Ordinance. paargraph (c) of sub-section (1), and substituting therefor a semi-colon and the word "or"; and

 - (e) the principal purposes of the combination seeking registration are not in accord with those set out in the definition of "trade union" contained in section 2 of this Ordinance; or
 - (f) the combination seeking registration is an organization consisting of persons engaged in, or working at, more than one trade or calling, and that its constitution does not contain suitable provision for the protection and promotion of their respective sectional industrial interests,".

 - (2) Any officer of a registered trade union who fails ²⁵ to comply with a request made by the Registrar, under the provisions of sub-section (1) of this section, shall be guilty of an offence and shall, on conviction therefor, be liable to a fine not exceeding twenty-five pounds.

Inspection of accounts and other documents by Registrar.

- 13B. (1) The account books, list of members and 30 other documents of a registered trade union may be inspected by the Registrar or any person duly authorized by him, in writing, in that behalf, at all reasonable times.
- (2) Any person who opposes, obstructs or impedes the Registrar, or any person duly authorized by him, in 35 the carrying out of an inspection under the provisions of sub-section (1) of this section, shall be guilty of an offence and shall, on conviction therefor, be liable to a fine not exceeding twenty-five pounds."

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance, the Trade Unions and Trade Disputes Ordinance, 1943.

Clause 2 seeks to repeal section 8 of the principal Ordinance and substitute a new section therefor. Sub-clause (1) of the new Clause is designed to clarify the position regarding applications for registration and sub-clause (2) seeks to enlarge the scope of the penalties for failure to apply for registration within the period laid down in sub-clause (1).

Clause 3 seeks to enlarge the powers of the Registrar to refuse registration by enabling him to decline to register a trade union if he is satisfied that—

- (a) any other trade union already registered is sufficiently representative of the whole or of a substantial proportion of the interests in respect of which the applicants seek registration; or
- (b) the principal purposes of the combination seeking registration are not in accord with those set out in the definition of "trade union" contained in section 2 of the principal Ordinance; or
- (c) the combination seeking registration is an organization consisting of persons engaged in or working at more than one

trade or calling, and that its constitution does not contain suitable provisions for the protection and promotion of their respective sectional industrial interests.

- (a) is designed to prevent duplication of Trade Unions;
- (b) is designed to make it clear that a combination applying for registration must have as its principal object the regulation of the relations between workmen and masters, or between workmen and workmen, or between masters and masters;
- (c) is designed to protect the sectional industrial interests of workers when a combination seeking registration as a Trade Union embraces persons engaged in a number of different trades or callings.

Clause 4 seeks to enlarge the Registrar's powers to cancel the registration of a trade union by providing that such registration can be cancelled if he is satisfied that the trade union is being used for an unlawful purpose or a purpose not authorized by the principal Ordinance, and that the rules of the trade union or that the funds of the trade union are being expended in an unlawful manner or on an unlawful object or on an object not authorized by the principal Ordinance and the rules of the trade union.

Clause 5 seeks to add two new sections to the principal Ordinance, to be numbered 13A and 13B. The proposed new section 13A seeks to enable the Registrar to call for accounts. This provision is designed to protect the interests of members of a trade union in so far as the finances of a trade union are concerned. The new section 13B seeks to enable the Registrar, or any person duly authorized by him, in writing, in that behalf, at all reasonable times to inspect the account books, the list of members and other documents of a registered trade union. It is considered that this provision is a necessary one, particularly in the early days of the formation of trade unions.

No additional expenditure of public moneys will be involved if the provisions of this Bill become law.

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend sub-sections (60), (62), (63) and (65) of the Local Government (Municipalities) Ordinance, 1928, to enable Municipal Councils to make regulations—

- (a) specifying the conditions upon which any person may remain in a municipality, requiring persons in certain circumstances to be in possession of a permit to remain in a municipality and for regulating the issue of such permits;
- (b) regulating the use of streets and public places in a municipality by any person; and
- (c) regulating the housing and licensing of labour within a municipality.

It is considered that the present sub-section (65) does not confer the powers which it was intended to confer when the principal Ordinance was first enacted, and the present sub-sections (60), (62), (63) and (65) only enable by-laws to be made for the purpose of regulating natives whereas, under present circumstances, and in the interests of order and good government, it is considered desirable to enable Municipal Councils to make such regulations for the purpose of regulating any person within a municipality.

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the National Parks Ordinance, 1945, by substituting the designation "national reserve" for the designation "park adjunct" throughout the Ordinance. The name "park adjunct" was originally suggested by the Game Policy Committee which was, no doubt, influenced by the proposal to include the Ngong Hills as a park adjunct to the adjoining Nairobi National Park. As, however, it is contemplated that the National Park Trustees will assume certain control over other areas, which do not adjoin a National Park, the term "park adjunct" is considered to be a misnomer and the term "national reserve" more appropriate.

No additional expenditure of public moneys will be involved if the provisions of this Bill become law.


