VACANCIES IN TANGANYIKA TERRITORY

Assistant Superintendent of Prisons, Class 1

PLANNING FOR COLONIAL DEVELOPMENT

IN VIEW of the continued shortage of capital goods of all types a working party on Colonial Development has been established in the United Kingdom under the aegis of the Central Economic Planning Staff to review colonial requirements for capital equipment and to make proposals for determining relative priorities in existing and new projects.

- 2. Box 621, Nairobi, marking the letter "Capital Require-
- 4. Information is only required in respect of projects estimated to cost individually £10,000 or over; firms are particularly requested not to submit returns covering miscellaneous items, even if the total of these adds up to £10,000 or over. Information is not required in respect of the following types of project, as returns of requirements under these headings are being compiled separately:-
 - 1. Agricultural projects of any type.

2. Mining projects.

3. Electricity undertakings.

5. Returns should be made in the following form:

(1) Nature of project.

(2) Rough estimate of total cost, separating estimated value of material and capital equipment to be imported. (Where it is difficult to estimate total costs, some other indication of magnitude of project should be given; for example, in the case of an industrial undertaking estimated productive capacity to be created.)

- (3) Types of main materials and major capital equipment to be imported by following categories:-
 - (i) Tonnage of iron and steel.
 - (ii) Tonnage of rails.
 - (iii) Tonnage of cement.
- (iv) Approximate quantities or value of machinery, industrial, earth-moving, general agricultural, locomotives, rolling stock, generating equipment, etc. (only rough indications of principal items are required, e.g. kilowatts of generating capacity, numbers of locomotives, etc.).
