## VACANCIES IN TANGANYIKA TERRITORY

*Control Officers, Department of Economic Control*

IMMEDIATE vacancies exist for two Control Officers in the Department of Economic Control, Tanganyika Territory. Appointments would be on normal overseas agreement terms on a provident fund basis with a commencing salary in the scale £600 by £30 to £720 and would be for a tour of from 24 to 36 months. In default of such payments within the specified time, the Commissioner of Lands may order the deposit paid by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot; provided that the balance of the purchase money shall not be payable within the time stated or thereafter, unless and until the Commissioner of Lands can present the purchaser the grant duly executed.
8. Subject to the proviso contained in Condition 7, if the amounts therein mentioned are not paid as therein laid down within seven days of a demand being made therefor, the Commissioner of Lands may order the deposit made by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot.

(b) Conditions of Grant

1. The purchaser shall erect, within two years of the commencement of his grant, a building of approved design, constructed of stone, burnt brick or concrete on proper foundations.
2. No building shall be erected on any plot unless plans (including block plans showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the authority, and by the Commissioner of Lands or such other person as he may appoint. 3. The plot shall be used for private residential purposes only.
