A BILL TO AMEND THE GOVERNMENT STAFF PROVIDENT FUND ORDINANCE, 1944

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

1. This Ordinance may be cited as the Government Staff Provident Fund (Amendment) Ordinance, 1948, and shall be read as one with the Government Staff Provident Fund Ordinance, 1944, hereinafter referred to as the principal Ordinance.

No. 2 of 1944.

Amendment of section 13 of the principal Ordinance.

2. Section 13 of the principal Ordinance is hereby amended by deleting the words "such amount as may be prescribed", which appear in the fourth and fifth lines thereof, and substituting therefor the following words and comma: "the total amount due to him from the Fund, or a lump sum 10 of such amount as may be prescribed".

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance, the Government Staff Provident Fund Ordinance, 1944, in order to make it clear that a depositor may receive, in cash, the full amount of the deposits he has made to the fund.

No expenditure of public moneys will be involved if the provisions of this Bill become law.
