### AWARD OF THE COLONIAL POLICE MEDAL FOR GALLANTRY

MR. JOHN HOWARD WALKER, Assistant Superintendent of Police No. 766 SERGEANT KAMITU WAITA

HIS MAJESTY the King has been graciously pleased to approve the award of the Colonial Police Medal for Gallantry to Mr. John Howard Walker, Assistant Superintendent of Police, and to No. 766 Sergeant Kamitu Waita of the Kenya Police.

As a result of an outbreak of lawlessness in the Kitosh native area which was typified by the threat by a mob of 800 followers of the "Dini la Msambwa" sect to burn a Mission Station in the tribal area, considerable police activity took place, resulting in a number of arrests. On the 10th February, 1948, a mob of some thousand followers of the sect advanced on a small police post at Malakisi with the avowed object of rescuing some members of the sect who had been arrested. Mr. Walker had arrived at the post shortly before the arrival of the mob. Mr. Walker had five Kenya police and three tribal police under his command. In an effort to avoid bloodshed, Mr. Walker went forward alone to meet the advancing mob and endeavoured to persuade them to disperse. He must have been fully aware of the risk he ran in doing so. He was attacked by a small section of the mob and was injured. He was compelled to fire in selfdefence, but was again attacked and felled by a blow on the head, which inflicted a severe wound. He then ordered fire to be opened but, owing to his injuries, he was unable to continue to take any further part in dealing with the incident for a short time. After the dispersal of the mob by force and his partial recovery he took steps to afford assistance to the members of the mob who had been wounded as a result of the police action taken to disperse them.

Sergeant Kamitu had arrived at the post shortly before the mob and before the arrival of Mr. Walker, Assistant Superintendent of Police. Aware of the intentions of the mob he made preparations to defend the post and to keep a crowd of curious onlookers clear of the mob. After the mob had attacked and incapacitated Mr. Walker, Sergeant Kamitu assumed command of the small body of police and tribal police, and directed the very effective fire which had to be opened to disperse the mob. This control he maintained so effectively in highly exciting circumstances that he was able to effect the "cease fire" immediately the mob broke. He himself received a stab wound in the chest during the affray which subsequently necessitated his admission to hospital, but he made no mention of it until the incident was over.


