BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title and commencement.

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance, the Customs Management Ordinance, 1926 (No. 25 of 1926), in order to enable administrative effect to be given to the proposal for the amalgamation of the Customs Department of Kenya and Uganda with the Customs Department of Tanganyika.

Before such amalgamation can be effected, the approval, signified by resolution of the Legislative Councils of the three territories, has to be obtained. The necessary resolution will be moved in the Legislative Council of Kenya during the session which is scheduled to commence on 13th July, 1948.

No additional expenditure of public moneys will be incurred if the provisions of this Bill become law.

It has therefore been decided that, provided that the provisions of the Ordinance are now properly complied with by such persons having so contravened the same and that the contraventions in so far as the building of dwelling-houses is concerned do not offend principles of health and sanitation, the Board shall not prosecute such persons.

The Board, however, takes the opportunity of once more and finally warning members of the public that any further contraventions will be rigorously dealt with according to law and of reminding the public that the penalties prescribed by the Ordinance entail penal amounts up to £100 and £5 additional for each day of continuance as well as liability to demolition of the unauthorized building.
