THE CROWN LANDS ORDINANCE

THIKA TOWNSHIP PLOTS—PUBLIC AUCTION

NOTICE is hereby given that grants in respect of the plots in Thika as described in the Schedules hereto will be sold by public auction at the offices of the District Commissioner, Thika, on Tuesday, 21st September, 1948, at 11 a.m.

The plan of the plots contained in the Schedule may be seen at the offices of the Commissioner of Lands, Nairobi, or at the office of the District Commissioner, Thika, as the case may be, or may be obtained on application to the Commissioner of Lands, P.O. Box 89, Nairobi, on payment of Sh. 3, post free.

The right to withdraw any plot from the sale is reserved to the Commissioner of Lands.

In the following conditions of sale the term "authority" means the District Commissioner, Thika, or such authority as may be hereafter established by law.

(a) General Conditions

1. Each plot will be auctioned separately.
2. The amount of the advance of each bid will be regulated by the auctioneer and no bidding shall be retracted.
3. The highest bidder will be declared the purchaser of the plot, but if any dispute arises as to any bid the plot will be reoffered at the last undisputed bid.
4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer, 25 per cent of the amount of his bid. In default of such payment, the plot may be immediately reoffered for sale and any subsequent bid by the person who has made default may be ignored or refused.
5. Each purchaser shall, on paying the deposit, inform the auctioneer the name or names of the person or persons on whose behalf the plot is purchased, and any subsequent grant that may be made will be issued in accordance with this information.
6. The amount bid in respect of the plot shall be considered as the stand premium thereon.
7. The balance of the amount bid, together with the roads and drains contribution in respect of the plot, the survey fees and the rent due to 31st December, 1948, shall be paid to the Commissioner of Lands within seven days of the date of the auction, together with the fees payable in respect of the preparation and registration of the grant (Sh. 120) and the stamp duty payable in respect of the grant (approximately 2 per cent on the amount bid and the rent). In default of such payments within the specified time, the Commissioner of Lands may order the deposit paid by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot; provided that the balance of the purchase money shall not be payable within the time stated or thereafter, unless and until the Commissioner of Lands can present the purchaser the grant duly executed.
8. Subject to the proviso contained in Condition 7, if the amounts therein mentioned are not paid as therein laid down within seven days of a demand being made therefor, the Commissioner of Lands may order the deposit made by the purchaser to be forfeited and the purchaser shall have no further claim to the grant of the plot.

(b) Conditions of Grant

1. The purchaser shall erect, within two years of the commencement of his grant, a building of approved design, constructed of stone, burnt brick or concrete on proper foundations.
2. No building shall be erected on any plot unless plans (including block plans showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the authority, and by the Commissioner of Lands or such other person as he may appoint. Such plans, etc., shall be submitted in triplicate to the District Commissioner, Thika, within three months of the date of sale.
3. Grants will be made under the Crown Lands Ordinance (Chapter 140 of the Revised Edition of the Laws of Kenya) and titles will be issued under the Registration of Titles Ordinance. The term of the grants will be 99 years from the 1st day of October, 1948, at the annual rents specified in the Schedule.
4. The grantee shall not, at any time, subdivide the plot, or assign, sublet or otherwise dispose of any portion of the plot.
5. Any building erected shall conform to a building line decided upon by the authority.
6. The grantee shall not at any time transfer the plot, nor enter into any agreement for sale thereof within five years of the date of commencement of the grant, but the grantee shall be permitted to raise a mortgage charge for the purposes of building with the written consent of the Commissioner of Lands, Mines and Surveys.
7. All out-buildings, offices, etc., shall be properly sited and screened from view to the satisfaction of the authority or such other person as may be appointed and shall be kept so screened during the term of the grant.
8. The Government or such person of authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, service pipes, telegraph or telephone wires, and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.
9. Grantees will be required to pay municipal rates upon the whole of the rateable interest and Government's contribution in lieu of rates assessed on the plots. A condition will, therefore, be embodied in each grant providing for the necessary adjustment between the grantee and the Government.

10. Under Government Notice No. 20 of 1945 the permission of the Supply Board is required for the erection of a building exceeding £50 in value, but no guarantee can be given that a building permit will be issued in respect of the building required to be erected under the conditions of the grant.

(c) Special Conditions in respect of Business Plots—Schedule I

1. The plot and the buildings to be erected thereon shall be for business purposes only and at no time during the term of the grant shall any building erected on the plot be used for residential purposes.
  2. The grantee shall not at any time during the term of the grant erect any building or buildings so as to cover more than 90 per cent of the area of the plot as qualified by these special conditions.
  3. In no case shall the area of the plot required to remain unbuild on be less than 10 per cent of the area, and the said area shall be free from any erection thereon above the level of the ground except latrine accommodation constructed in accordance with all laws and by-laws in force relating thereto and in accordance with a design approved by the authority.
- Such open space shall be at the rear of the building and shall extend along the entire width of the building, or for a distance of not less than 30 feet, whichever shall be the less, and the distance across such open space from every part of the building to the rear boundary of the plot shall be not less than ten feet.
4. At no time during the term of the grant shall the plot or any portion thereof, or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by notice in the Official Gazette.
  5. A veranda may be erected within the road reserve with the previous consent of the authority, and must conform to a building line decided upon by such authority.

(d) Special Conditions in respect of Plots—Schedule II

1. The plot and the buildings to be erected thereon shall be for artisan purposes only and at no time during the term of the grant shall any building erected on the plot be used for residential purposes.
  2. The grantee shall not at any time during the term of the grant erect any building or buildings so as to cover more than 75 per cent of the area of the plot as qualified by these special conditions.
  3. In no case shall the area of the plot required to remain unbuild on be less than 25 per cent of the area, and the said area shall be free from any erection thereon above the level of the ground except latrine accommodation constructed in accordance with all laws and by-laws in force relating thereto and in accordance with a design approved by the authority.
- Such open space shall be at the rear of the building and shall extend along the entire width of the building, or for a distance of not less than 30 feet, whichever shall be the less, and the distance across such open space from every part of the building to the rear boundary of the plot shall be not less than ten feet.
4. At no time during the term of the grant shall the plot, or any portion thereof, or any building erected on the plot be used for the purpose of carrying on any trade which has been or may be declared to be dangerous or offensive by notice in the Official Gazette.

## VACANCIES IN TANGANYIKA TERRITORY

*Field Officers Under the Development Commission*

THREE Field Officers are required in the Development Commission, Tanganyika Territory, in connexion with the Sukumaland Development Scheme in the Lake Province. The posts will carry a scale of £550 by £20 to £690 by £25 to £840 and will be on normal overseas terms of service with compulsory contribution to the Government employees' provident fund, and 10 per cent of salary will be deducted for rent. Engagement would be for one tour of from 24 to 36 months in the first instance. Applicants of not more than 45 years would be preferred.

Candidates should preferably possess a good general knowledge of East African agriculture and/or animal husbandry, while knowledge of simple building construction would be an additional recommendation. In the case of one post a knowledge of forestry would be an advantage. The duties of these posts will entail living under camp conditions for most of the time and applicants must be prepared to rough it.

Applicants should apply to the Secretary, European Civil Service Board, the Treasury, Dar es Salaam, before 17th September, 1948. Serving Government officers should submit their applications through normal service channels with a copy direct to the Secretary of the Board and should enclose an up-to-date copy of a Personal Record Form (P.2). All other applicants should submit full details giving age, education, experience, etc., and should enclose copies of any testimonials which they hold.

*Senior Examining Officer, H.M. Customs, Kilindini*

APPLICATIONS are invited for the post of Senior Examining Officer, H.M. Customs, Kilindini. They should be sent to the Secretary, European Civil Service Advisory Board, P.O. Box 621, Nairobi, to reach him not later than 30th September, 1948.

Applicants in Government employment should apply in terms of Secretariat Circular No. 30 of 1944.

The scale of salary is £600 by £20 to £720 per annum (initial salary according to age, qualifications and experience) on Kenya European Civil Service terms and conditions of service, which include—

- (a) payment of cost of living allowance varying according to salary, at rates in force from time to time; the following are the current rates—
  - single officer, Sh. 125 per month;
  - married officer without children, Sh. 169 to Sh. 200 per month;
  - married officer with children, Sh. 227 to Sh. 402 per month;
- (b) participation in a contributory pensions scheme;
- (c) eighteen days' local leave per annum, and vacation leave at the rate of 3½ days for each month of residential service;
- (d) free passages to the United Kingdom, after four-year tour, for officer and wife;
- (e) free medical treatment by the Government medical services;
- (f) when not in occupation of Government quarters, housing allowance is payable to the limit of 5 per cent of salary; in cases of hardship due to payment of a high rental, supplementary assistance may be given.
