

RETAIL PRICE INDEX FOR AUGUST, 1948

THE East African Statistical Department's general level of retail prices of consumers' goods in Nairobi, as at 31st August, 1948, measured by returns received from representative dealers, was 86.7 per cent above the pre-war level, while the corresponding figure for 30th June, 1948, was 87.1 per cent.

Excluding imported tobacco and cigarettes, the price of which has been increased for special reasons, and omitting the seasonal increase in the price of vegetables, the increase was 79.5 per cent, as compared with 78.6 per cent in June, 1948.

Increases in price were recorded for petrol, ghee, vegetable oils, paraffin and cocoa, and a decrease was recorded for some items in the clothing group. The prices of vegetables, for which a seasonal increase was recorded in April, have begun to show a tendency to return to normal.
