A BILL TO AMEND THE NATIVE POLL TAX ORDINANCE, 1942

ARRANGEMENT OF SECTIONS

SECTION

- 1—Short title.
- 2—Amendment of section 6 of the principal Ordinance.
- 3—Repeal and replacement of section 9 of the principal Ordinance.
- 4—Repeal and replacement of section 10 of the principal Ordinance.

SECTION

- 5—Addition of new section to the principal Ordinance.
- 6—Repeal and replacement of section 16 of the principal Ordinance.
- 7—Repeal and replacement of section 18 of the principal Ordinance.
- 8—Amendment of section 21 of the principal Ordinance.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

1. This Ordinance may be cited as the Native Poll Tax (Amendment) Ordinance, 1948, and shall be read as one with the Native Poll Tax Ordinance, 1942, hereinafter referred to as the principal Ordinance.

2. Section 6 of the principal Ordinance is hereby amended—

(a) by deleting sub-section (1) and substituting therefor the following sub-section:—

“(1) The amount due from each native for poll tax shall, in respect of any year, be payable to a collector on or before the 31st day of January in that year at the place appointed for the purpose under the provisions of section 5 of this Ordinance. Any native who fails to pay the poll tax due from him in respect of any year by the 30th day of September of that year shall, subject to the provisions of section 11A of this Ordinance, be liable, in addition to payment of such poll tax, to a penalty of one half of the amount of the tax due, which shall be deemed to be poll tax and recoverable accordingly.”;

(b) by inserting the word “first-mentioned” immediately after the word “such”, which appears in the first line of sub-section (2) thereof;

(c) by substituting the words “court costs” for the word “penalty”, which appears in the fifth line of sub-section (2) thereof; and

(d) by deleting sub-section (3) and substituting therefor the following sub-section:—

“(3) Where proceedings are taken, under the provisions of sub-section (2) of this section, for the recovery of any poll tax, the court may order the person in default to pay such sum, not exceeding six shillings, by way of court costs as the court, in its discretion, may determine.

Where such proceedings are taken before a Native Tribunal, any sum recovered by way of court costs shall, where a local native council is established over the area of the jurisdiction of the Native Tribunal, be credited to the funds of such council, or, where no such local native council is established, to the Native Trust Fund established under the provisions of the Native Trust Fund Ordinance, 1942.”.

No. 22 of 1942.

3. Section 9 of the principal Ordinance is hereby repealed and the following substituted therefor:—

Repeal and replacement of section 9 of the principal Ordinance.

5 “9. (1) Every employer of a native, if he has not been exempted under the provisions of sub-section (3) of this section, shall, unless and until such native produces to his employer a receipt for, or a certificate of exemption from, the payment of poll tax for that year, on and after the 31st day of January in each year—

Employees may pay wages partly in kodi stamps.

10 (a) in the case of a native employed on a verbal or written contract of service for a period of one month or longer, at the end of each month,

(b) in the case of a ticket contract, on the completion of such contract,

15 pay to such native, in part payment of the wages due to such native, the sum of four shillings in *kodi* stamps by affixing them to a card in the prescribed form (hereinafter referred to as a “*kodi* card”), until the value of such stamps equals the amount of poll tax payable by such native for that year.

20 (2) When an employer has affixed any *kodi* stamp to a *kodi* card, under the provisions of sub-section (1) of this section, he shall then hand such card to the native employee concerned:

25 Provided that an employer may, at the request of a native employee, retain such card in his possession, but shall surrender it to such native at his request or when such native leaves the service of such employer.

30 (3) Where arrangements, satisfactory to a District Commissioner, have been made between an employer and his native employees for the collection by the employer of poll tax due from such employees, he shall, in writing, exempt such employer from the provisions of this section.

35 (4) The Governor may, by notice in the Gazette, exempt from the provisions of this section any employer or class of employers.

(5) Any employer, to whom the provisions of sub-section (1) of this section applies, who—

40 (a) fails to pay a portion of any of his native employees' wages in *kodi* stamps as required by the provisions of such sub-section, shall, unless he proves to the satisfaction of the court that he had reasonable grounds for believing that such employee had paid, or had been exempted from paying, his poll tax for the current year, be guilty of an offence;

45 (b) having possession of a *kodi* card under the provisions of the proviso to sub-section (2) of this section, fails to surrender such card to the native employee at such native's request or when such native leaves his service, shall be guilty of an offence,

50 and shall be liable, on conviction therefor, to a fine not exceeding five pounds, or, in default of payment, to imprisonment for a term not exceeding one month.”

55 4. Section 10 of the principal Ordinance is hereby repealed and the following substituted therefor:—

Repeal and replacement of section 10 of the principal Ordinance.

“10. *Kodi* stamps shall, on surrender thereof to a court or to a collector, be taken into account in respect of the poll tax due from the native concerned, in any proceedings instituted for the recovery thereof, under the provi-

sions of section 6 of this Ordinance, or for the purpose of assessing the amount due from such native when he pays or is called upon to pay his poll tax.”.

Addition of new section to the principal Ordinance.

5. The principal Ordinance is hereby amended by inserting, immediately after section 11 thereof, the following new section:—

“Powers of remission of penalty.

11A. (1) A Provincial Commissioner may, in his discretion, by notice in the Gazette, remit the whole or any portion of the penalty prescribed under the provisions of sub-section (1) of section 6 of this Ordinance in respect of any person or class of persons, or the members of any tribe or the inhabitants of any district, area or place:

Provided that nothing in this section contained shall affect any exemption granted under the provisions of any other Ordinance.

(2) A District Officer may, in his discretion, in respect of any person, remit the whole or any portion of the penalty prescribed under the provisions of sub-section (1) of section 6 of this Ordinance and in such case shall make an endorsement, to that effect, on the current poll tax receipt form of such native.”.

Repeal and replacement of section 16 of the principal Ordinance.

“Tax roll and penalty for failing to give information.

6. Section 16 of the principal Ordinance is hereby repealed and the following substituted therefor:—

16. (1) Every District Commissioner shall cause to be maintained, a complete roll of all natives in his district who, under the provisions of this Ordinance, are liable to pay poll tax and, for that purpose, a collector may require any employer of native labour, or any owner or occupier of alienated land, in such district, to give to him such information as he may consider necessary for the purpose of the maintenance of such roll.

(2) Any such employer, owner or occupier who, when so required by a collector, wilfully fails to give such collector information as required under the provisions of sub-section (1) of this section, shall be guilty of an offence and shall be liable, on conviction therefor, to a fine not exceeding five pounds, or, in default of payment, to imprisonment for a term not exceeding one month.”.

Repeal and replacement of section 18 of the principal Ordinance.

“Power to order natives to appear before collector or to arrest such natives.

7. Section 18 of the principal Ordinance is hereby repealed and the following substituted therefor:—

18. (1) Any collector, chief or headman, may order any native subject to his jurisdiction, who he has reasonable cause to believe has not paid the poll tax due from him in respect of any year, at the time and place appointed by the District Commissioner, either to attend before the collector or to send the amount of the tax payable by him to such collector, or if he has reasonable grounds for believing that such order will not be obeyed, he may, without warrant, arrest such native and take him without undue delay to the place appointed by the collector under the provisions of section 5 of this Ordinance.

(2) Any native who, without lawful excuse, fails to obey the order of a collector, chief or headman given under the provisions of sub-section (1) of this section, shall be guilty of an offence and shall be liable, on conviction therefor, to a fine not exceeding three pounds, or, in default of payment, to imprisonment for a term not exceeding one month.”.

8. Section 21 of the principal Ordinance is hereby amended—

(a) by substituting a comma for the full stop which appears at the end thereof; and

5 (b) by adding, immediately after such comma, the following words:—

“and produce to him such evidence of identity as he may require.”.

MEMORANDUM OF OBJECTS AND REASONS

This Bill seeks to amend the principal Ordinance, the Native Poll Tax Ordinance, 1942, in order to provide for the more effective collection of Native Poll Tax.

Clause 2 (a) of the Bill seeks to provide for an automatic penalty of one half of the tax due, to be added to the rate of tax payable by any African who fails to pay the Poll Tax due from him by the 30th day of September, in any year.

In view of the imposition of an automatic penalty it is considered desirable to substitute court costs for the 50 per cent penalty which could previously be imposed, and to limit the amount of court costs to Sh. 6.

Clause 3 of the Bill seeks to repeal and replace section 9 of the principal Ordinance, the new Clause provides that every employer, not specifically exempted by a District Commissioner, shall deduct the sum of Sh. 4 from the wages of each of his employees and attach the equivalent value in kodi stamps to the kodi card of each employee, until the value of the stamps equals the amount of tax to be paid by the employee. If, however, an employee produces a valid tax receipt, the employer is relieved of this obligation.

It also seeks to enable a District Commissioner to permit an employer to collect the tax due from his employees without using kodi stamps.

The Clause also seeks to provide that the Governor may exempt any employer or class of employer from the provisions relating to the use of kodi stamps, and creates a penalty for contraventions of its provisions.

Clause 4 seeks to repeal and replace section 10 of the principal Ordinance. It provides that kodi stamps affixed to the kodi card of an employee shall be taken into account as part payment of the tax due by the employee concerned.

Clause 5 seeks to add a new section, 11A, to the principal Ordinance. It authorizes a Provincial Commissioner to remit the whole or any portion of penalties in respect of any person or class of persons, for non-payment of Poll Tax, and a District Officer to remit the whole or any portion of such a penalty in the case of any individual taxpayer.

Clause 6 by repealing and replacing section 16 of the principal Ordinance seeks to enable a District Commissioner to obtain sufficient information from employers to enable him to prepare a tax roll of Africans in employment, and provides a penalty for wilful failure to give any such information.

Clause 7 seeks to repeal and replace section 18 of the principal Ordinance. It empowers a collector, chief or headman to order an African to attend before a collector, or to arrest, without a warrant, any African whom he has reasonable cause to believe has not paid the Poll Tax due from him in respect of any year, but an arrest can only be effected if there are reasonable grounds for believing that the African will not obey an order to attend before a collector. It is considered necessary that these powers should be provided in order to enable taxes to be collected more effectively and to prevent the evasion of payment.

Clause 8 seeks to amend section 21 of the principal Ordinance, to enable a collector to call upon an African, who produces a tax receipt, to furnish him with evidence of identity. Considerable difficulty has been experienced in the past in connexion with identification of the holder of the receipt which he produces.

No additional expenditure of public moneys will be incurred if the provisions of this Bill become law.
