### THE DEFENCE (CONTROL OF SUGAR) REGULATIONS MANUFACTURE OF JAGGERY

IN EXERCISE of the powers conferred upon him by regulations 2, 3 and 4 of the Defence (Control of Sugar) Regulations, 1944, and all other powers enabling him, the Deputy Sugar Controller hereby declares as follows:—

Manufacturers of jaggery in Nyanza Province are hereby notified that it has been found necessary to revise all permits to manufacture and dispose of this commodity and which have been issued previous to the date of this notice.
