#### ASIAN OFFICERS' FAMILY PENSIONS FUND, 1946

REPORT AND STATEMENT OF ACCOUNT FOR THE YEAR ENDED 31st DECEMBER, 1946

In the Report for the year ending 31st December, 1945, the number of contributors to the Fund was 549 of which 148 members had transferred from the Asiatic Widows' and Orphans' Pension Fund. Secretariat Circular No. 9 of 3rd June, 1946, gave the latter Officers an opportunity to revoke their option to join the Asian Officers' Family Pensions Fund, and 83 Members therefore revoked their option and reverted to the Asiatic Widows' and Orphans' Pension Fund. This reduced the membership of the Asian Officers' Family Pensions Fund from 549 to 466.

During the year 1946 there was an increase of 252 members giving a total of 718 contributors at 31st December, 1946. Included in the 252 new contributors were 42 members of the Asiatic Widows' and Orphans' Pension Fund who had opted to transfer to the new Fund in terms of paragraph 4 of Secretariat Circular No. 30 of 28th August, 1945. Options were required to be exercised before the 12th November, 1945, but these Officers could not become members of the new Fund in 1945 as they were not medically examined until 1946.

At 31st December, 1946, the number of pensioners was two, an increase of one over the preceding year.

Interest due from the Asiatic Widows' and Orphans' Pension Fund on account of contributions of those members who transferred to the Asian Officers' Family Pensions Fund, which was under consideration by Government, was fixed at 3½ per cent resulting in a transfer of £2,208-7-97.

#### THE CROWN LANDS ORDINANCE

TENDERS FOR THE GRANT OF CROWN LAND AT MOLO FOR DEVELOPMENT AS A RESIDENTIAL ESTATE

TENDERS in terms of premium per acre (the rate of rent being fixed as hereinafter stated) are invited on the conditions hereinafter appearing for the purpose of development as a residential estate of the grant of a lease in respect of a piece of land having a gross area of approximately 500 acres, subject to the exclusion, therefore of a five-area plot to be reserved. to the exclusion therefrom of a five-acre plot to be reserved for public purposes to be selected by the Development Com-mittee hereinafter referred to, known as Land Reference No. 533, situate at Molo in the Molo District of the Highlands.

- 3. The tender and development will be under the control on behalf of the Government of the Commissioner of Lands with the assistance and advice of a Development Committee. The requirements and decision of the Commissioner of Lands in consultation with this Committee shall be accepted by the
- 4. Tenders must be accompanied by a detailed description of the tenderer's proposals for the development of the area as a residential estate based on a subdivisional scheme for the provision of 20/25 plots of not less than 15 acres and not more than 25 acres each, and for the construction and maintenance of roads serving each plot up to district council standards together with a layout plan illustrating the proposals.
- 5. The successful tenderer will be required within a stated period after acceptance of his tender to
  - (a) submit a detailed layout plan based on a contour survey and showing also the water reticulation and drainage system for the approval of the Commissioner of Lands in accordance with the provisions of section 23 of the Town Planning and Development Ordinance, 1931;
  - (b) provide an adequate borehole supply of piped water to the boundaries of each plot with main storage reservoirs for at least three days' normal supply for the whole estate and to produce to the Commissioner of Lands a certificate signed by the Government Hydraulic Engineer certifying that the reticulation system and borehole tests have been approved by him.
- 6. Applications for plots will be made to the Development Committee which shall be responsible for determining the allocation of plots and shall inform the grantee of such allocation. tion of plots and shall inform the grantee of such allocation. When this has been done negotiations for purchase will be made direct between the grantee and the applicant for the plot, but the sale price of the plots shall be subject to the approval of the Commissioner of Lands, and no plot shall be sold until authority shall be given, and in any event not until the roads shall have been made up and the water supply installed to the satisfaction of the Commissioner of Lands.
- 7. The successful tenderers will be required to pay to the Commissioner of Lands, within seven days of the notification that his tender has been accepted, 20 per cent of the amount tendered as premium.
- 8. The successful tenderer will also be required to deposit with the Commissioner of Lands upon receiving notification that his tender has been accepted any one of the following securities:
  - (a) One-third of the amount stated in his tender, as the estimated cost of development;
  - (b) a bank guarantee for the total amount of the estimated cost of development;
  - (c) an approved security to a value not less than one-third of the development costs.
- 9. The survey fees for the whole area and the fees (Sh. 120) payable in respect of the preparation of the title deeds together with the stamp duty (which is approximately 2 per cent on the purchase price and the rent) in respect of the grant must be paid within seven days of a demand therefor. Titles will be issued as soon as conveniently may be.
- 10. The term of the grant will be 99 years from such date as may be recommended to the Commissioner of Lands by the Development Committee as the date of the actual commencement of beneficial user, which shall not in any event be later than 1st July, 1949, from the earlier of which dates rent also will be payable, and the grant will be issued under the provisions of the Crown Lands Ordinance (Cap. 140 of the Revised Edition, especially Part V thereof) and the Registration of Titles Ordinance (Cap. 142 of the Revised Edition). The annual rental which shall be payable in respect of the whole grant shall be which shall be payable in respect of the whole grant shall be at the rate of Sh. 16 per acre per annum and, except as hereinafter provided, such rental shall be payable to the Crown by the

The grantee's deeds of sale shall make provisions binding plot purchasers to pay municipal or district council rates, if imposed, including any Government contribution in lieu thereof, and such rates covering roads and water supply and the maintenance thereof by the successful tenderer as may be approved by the Development Committee.
- 15. At no time during the continuance of the term will any subdivision of a subdivisional plot be permitted except with the prior written approval of the Commissioner of Lands first had and obtained.
- 16. Each subdivisional plot shall be assigned for the construction thereon of one house only for the personal occupation as a residence by the assignee, and no further assignment or sale will be permitted within five years of the date of the first sale of each subdivisional plot and a clause will be inserted in the title deeds requiring personal residence by the first pur-chaser of each of the subdivisional plots for three out of the first five years from the date of the first sale.
- 17. The development to be effected on the land by the success ful tenderer will be subject to a time limit to be fixed by the Commissioner of Lands in consultation with the Development
- 18. The successful tenderer will be responsible for the adequate supply and maintenance of water and satisfactory road construction and maintenance until such time as other arrangements may have been made by him with the approval of the Development Committee for the maintenance of such services or either of them, and will be required to enter into a bond in a sum at least equal to the estimated cost of installation and/or construction to the satisfaction of the Commissioner of Lands to secure compliance with the provisions of this clause. Such maintenance service shall be covered by, *inter alia*, provision of road and water rate conditions embodied in the deeds of sale issued by the grantee, with the approval of the Development Committee.
- 19. Sealed tenders marked "Tender for Grant and Development of Molo Estate" must be deposited with the Commissioner of Lands, Nairobi, before noon on 8th April, 1949. The highest or any tender will not necessarily be accepted.
