## VACANCIES IN GOVERNMENT DEPARTMENTS

*Clerk (Female), Egerton School of Agriculture, Njoro, Department of Agriculture*

APPLICATIONS are invited for the post of Clerk (Female) at the Egerton School of Agriculture, Njoro. They should be sent to the Director of Agriculture, P.O. Box 338, Nairobi, so as to reach him not later than 25th April, 1949. The appointment is to date from 1st May, 1949.

Applicants in Government service should apply through their heads of department. If candidates are single the appointment is on a two-year probationary period before admittance to the permanent and pensionable establishment. Salary scale is £295 by £15 to £370 (efficiency bar), by £15 to £460. Candidates will enter the scale at a point commensurate with their age, qualifications and previous experience. The minimum age of entry is 20 years.

The revised terms of service for single candidates include vacation and local leave, free passages, free medical attention and free pension. For married candidates the terms of service include eighteen days' local leave per annum and vacation leave on the termination of appointment at the rate of two and a half days for each completed month of residential service and free medical treatment by the Government Medical Service for the officer.

Full board and lodging is available at the school, for which the candidate will have to pay £11 per month.

Candidates must be qualified stenographers who have passed the Government examination in senior shorthand and typing or can produce evidence of having passed examinations of an equivalent standard.

*Stenographer, Forest Department*

APPLICATIONS are invited for the post of female (European) Stenographer in the Forest Department, Nairobi. The appointment is temporary in the first instance with prospects of permanent appointment for a suitable applicant. The salary scale of the post is £385 by £15 to £460, initial salary to be determined in the light of previous experience. The selected candidate to be in possession of certificates with speeds of shorthand and typing of at least 110 words a minute and 50 words a minute for five minutes and ten minutes respectively.

Terms of service include free medical attention by the Government medical service. *Junior Laboratory Assistant (Male), Agricultural Department*

## TENDERS FOR THE RIGHT TO MILL CYPRESS THINNINGS IN KERITA AND SOUTH KINANGOP FOREST DISTRICTS

TENDERS are invited for the right to install a mill and convert cypress thinnings marked by the Forest Department in the Kerita and South Kinangop forest districts.

The period of the right licence will be for five years. All thinnings marked shall be felled and removed systematically from the plantations in accordance with the directions of the Conservator of Forests or his representative, and failure to do so may result in cancellation of the licence.

The site, layout and equipment of the mill shall be to the satisfaction of the Conservator of Forests.

Applicants may be called upon by the Conservator of Forests to install milling equipment embodying a minimum loss in conversion, e.g. gang, band or other small saws to minimize loss in kerf during manufacture.

The installation of the mill shall be begun within three months of the acceptance of tender and substantial production shall be begun within six months.
