ARRANGEMENT OF SECTIONS

SECTION 1—Short title. 2—Amendment of section 4 of Ordinance 13 of 1934.

A BILL TO AMEND THE SPECIAL DISTRICTS (ADMINISTRATION) ORDINANCE, 1934

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

1. This Ordinance may be cited as the Special Districts (Administration) (Amendment) Ordinance, 1949, and shall be read as one with the Special Districts (Administration) Ordinance, 1934, hereinafter referred to as the principal Ordinance.

No. 13 of 1934.

Amendment of section 4 of Ordinance 13 of 1934.

2. Section 4 of the principal Ordinance is amended 5 by adding thereto the following new definition—

"cattle" includes camels, sheep, goats, mules and donkeys.

MEMORANDUM OF OBJECTS AND REASONS

Power exists under the Special Districts (Administration) Ordinance, 1934, to seize the cattle of tribesmen who come into the Northern Province and commit offences there. This Bill enlarges the definition of cattle so as to make it clear that camels, sheep, goats, mules and donkeys may also be seized.

No additional expenditure of public moneys will be involved if the proivsions of this Bill become law.
