## VACANCIES IN GOVERNMENT DEPARTMENTS

(a) *Record Draughtsman*, (b) *Assistant Draughtsman*, *Lands Department*

APPLICATIONS are invited for posts of (a) Record Draughtsman, and (b) Assistant Draughtsman. Application for (a) should be sent to the Secretary, European Civil Service Advisory Board, P.O. (a) *Record Draughtsman*

Salary scale: £740 by £20 to £800 per annum.

Applicants should be between 30 and 40 years of age. The duties of the post entail the reorganization of the plan records of the department, the institution of a system of recording all transactions in Crown land, and the maintenance of such a system. Applicants should have had experience of record draughtsmanship and have a working knowledge of legal documents and phraseology.

(b) *Assistant Draughtsman*

Salary scale: £295 by £22-10 to £565 per annum.

Applicants should be between 22 and 30 years of age. Applicants will require to have been trained as draughtsmen; evidence of efficiency should be tendered.

Terms and conditions of service for the above appointments are as follows:—

- (a) For applicants not in Government service, appointment on probation for two years before admission to the permanent and pensionable establishment.
- (b) Eighteen days' local leave per annum; vacation leave after 48 months' tour at the rate of  $4\frac{1}{2}$  days for each completed month of residential service for officers under 40, or after 40 months' tour at the rate of  $5\frac{1}{2}$  days for each completed month of service for officers over 40.

- (e) Free medical treatment by the Government medical service for the officer, wife and unmarried dependent children under 21.

*Junior Entomological Field Officer, Medical Department*

APPLICATIONS are invited for appointment as Junior Entomological Field Officer (European male) based on the Insect-borne Diseases Division of the Medical Research Laboratory, Nairobi.

The scale of salary attached to the post is £340 by £22-10 to £452-10 (efficiency bar) by £22-10 to £520. Initial salary will be according to age, qualifications and experience. The post will be on probation for two years before admission to the pensionable establishment.

When in occupation of Government quarters, 10 per cent of salary will be charged as rent if the quarters are furnished and  $7\frac{1}{2}$  per cent of salary if they are unfurnished. 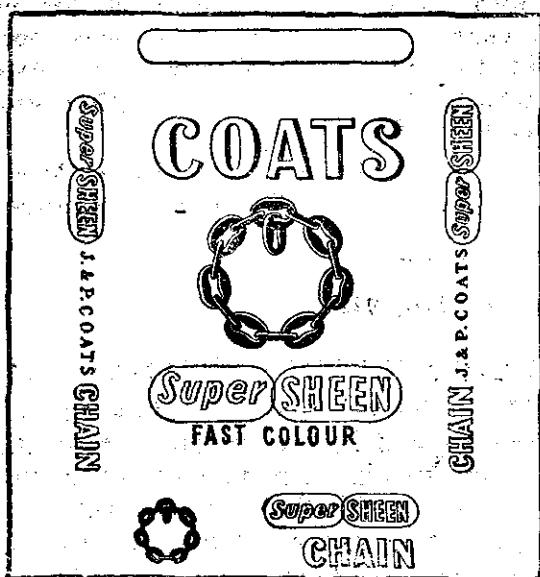
