POSTHUMOUS AWARD OF THE COLONIAL POLICE
 MEDAL FOR GALLANTRY—No. 1550 SERGEANT
 MUINDE MUISIO

HIS MAJESTY the King has been graciously pleased to approve the posthumous award of the Colonial Police Medal for Gallantry to Sergeant Muinde Muisio of the Kenya Police.

On 3rd April, 1949, a party of Police consisting of one African Inspector, Sergeant Muinde and seven constables surrounded a Masai *manyatta* about 16 miles from Narok which was suspected to be harbouring three wanted criminals. While a search was progressing a Masai armed with a spear suddenly broke out from the back of a hut, attacked Sergeant Muinde, who was just outside the hut, and transfixed him with the spear before he could do anything to defend himself. The Masai then absconded. With the spear still through the middle of his body and despite the fact that he must have realized that his wound would probably prove fatal, Sergeant Muinde took careful aim and fired three shots at the difficult target presented by the fleeing figure. He wounded the Masai in the shoulder. It was due to this wound that the Police were subsequently able to effect the arrest and identification of the Masai. Sergeant Muinde died on the night of 3rd April, 1949.

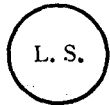

5. The plot and dwelling-house shall be used as a private residence for the grantee and his family only.
