## OBITUARY

By the death of Paramount Chief Mumia, which occurred on 24th April, 1949, the Colony has lost one of its outstanding African personalities, and His Excellency the Governor wishes to place on record an appreciation of the late Paramount Chief's long and devoted service.

His first contact with Europeans was when Joseph Thomson in 1883 found him established as a leader of his tribe.

The late Mumia son of Shundu was outstanding in that as Chief of the Wanga tribe he and his family were from the first faithful and helpful friends of the British when the latter first appeared on the caravan route to Uganda which passed his village, since known as Mumias. During his long lifetime and amid the tremendous changes which have taken place, Mumia never wavered in his loyalty to the Government, nor did he ever fail in his duties to his people. His name has become legendary throughout many of the tribes in Kenya, while he was held in peculiar affection by his own particular people, the Bantu tribes of North Nyanza.

He was awarded the King's Medal for Native Chiefs in 1922. By his death there has passed the last surviving personality of the days even before the Chartered Company entered the territory.

BY AN exchange of Notes dated 6th/17th April, 1949, between His Majesty's Government in the United Kingdom and the Egyptian Government, the latter have agreed to grant to physical persons who are "British Nationals", and to legal persons, who are, or are owned by, "British Nationals", treatment in the matter of compensation in respect of war damage to property in Egypt not less favourable than that which is accorded to Egyptian nationals under the provisions of Egyptian legislation. For the purpose of this exchange of Notes—

(a) the expression "British Nationals" means all citizens of the United Kingdom and colonies and all British protected persons belonging to territories for whose international relations His Majesty's Government is responsible;

(b) the term "British Nationals" also includes all legal persons partnerships or associations deriving their status as such from the laws in force in any of the territories mentioned in sub-paragraph (a) above.

British claimants, in order to benefit by the provisions of the agreement, should submit their claims without delay direct to the Department of Compensation, Ministry of Public Works, 3 Sharia El Sherifein, Cairo.

The registration of property or claims in respect of damage in Egypt, with the Foreign Office, Trading with the Enemy Department, or any other Government agency or with any British Chamber of Commerce, His Majesty's Embassy at Cairo or any of His Majesty's Consular Officers in Egypt does not constitute the lodgment of a claim with the competent Egyptian authorities, nor can His Majesty's Embassy at Cairo or any of His Majesty's Consular Officers in Egypt act as agents in presenting and pursuing individual claims.
