The Commissioner of Police is empowered to make special arrangements and vary the charges for periods of less than eight hours.

Application for the services of police for any private purpose, which can only be supplied when the exigencies of the service permit, should be made to the police officer in charge of the district concerned.

When any person wishes to engage the services of a constable for a definite period of not less than three months, application should be made to the Commissioner of Police. The charge for the hire of a constable for a period of this duration is Sh. 120 per month. In the event of a hirer wishing such services to be discontinued one month's notice must be given to the Commissioner of Police.

Government will accept no responsibility for loss or damage to property, however caused, during the employment of police for private purposes.
