## SITES FOR HOTELS, AZANIA DRIVE, MOMBASA

## Duties and Qualifications Required.—

The duties and qualifications of the post are as follows:—

- (a) Booking of passages to various destinations and checking the passage privileges for which officers are eligible, including refunds and recoveries.
- (b) To deal with all correspondence received from all heads of departments of Kenya and Uganda, Crown Agents for the Colonies, South African Agency, shipping and airways companies and other Governments, including Tanganyika, Zanzibar, Seychelles and Mauritius relating to all passage matters.
- (c) To examine all passage claims submitted by European officers and make observations thereon.
- (d) To check all passage accounts received from the shipping and airways companies and the South African Agency and effect settlement thereof.
- (e) To complete passage particulars of leave and last pay certificates of European officers of Kenya and Uganda and forward same to the Secretary of State for the Colonies and the Crown Agents for the Colonies.

To perform the duties of this post satisfactorily, the holder must possess, in addition to the knowledge of the history of all past cases and the experience of passage work, a very sound knowledge of the Code of Regulations of Kenya, Uganda and Tanganyika, knowledge of Colonial Office Regulations, Crown Agents' system of dealing with passages and knowledge of passages and passenger shipping in general (i.e. passage rates, method of calculations, rebates, routes and break of journey, etc.), and various special somewhat complicated rulings over the past 25 years appertaining to the department.

The work is closely liaisoned with the Establishment Sections of Kenya and Uganda Governments.

## Clerk in Charge, Clearing and Forwarding Section

The duties and qualifications of the post are as under:—

- (a) The Clerk in Charge must possess tact and a strong sense of responsibility in his dealings with the other members of the Asian and African staff of the section for whose discipline he is responsible, subject to the direction of the Government Coast Agent.
- (b) He is required to possess a good knowledge of shipping, marine insurance and claims, customs declaration, port and railway tariffs, dealing with all importations of Government cargoes.

## (a) Senior Cashier (Traffic)

The officer concerned is required to have a very intimate knowledge of the 16 Ordinances under which the various types of licences are issued. Chief Clerk, Mombasa

(Special Grade)

## Qualifications and Duties.—

(1) Supervision of a staff of approximately 18 Asian and African officers.

(2) Responsibility to His Honour the Resident Judge for all Probate and Administration, Divorce and Admiralty causes, their preparation and presentation to the court.

(3) Responsibility for East African Court of Appeal work at Mombasa.

(4) Drafting and typing all general correspondence particularly all confidential correspondence from His Honour the Judge.

(5) Arranging the daily cause list for the Supreme Court, including all contacts with Mombasa advocates relating to litigation filed by them.

(6) Dealing with all inquiries by the public.

(7) The holder of the post must have a thorough knowledge of bankruptcy, civil and criminal work, both in the Supreme and Subordinate Courts, including a sound knowledge of local Ordinances and subsidiary legislation, law reports, etc.

## LABOUR DEPARTMENT

(Special Grade)

## Chief Clerk and Cashier, Headquarters Offices

(a) He must be able to draft letters for the consideration of the European officers in charge of sections and have a thorough knowledge of departmental instructions, Colonial Regulations, Code of Regulations, Financial Orders, the Labour Laws of the Colony and the Workmen's Compensation Ordinances.

(b) He must possess tact and a sense of responsibility as he is required to organize and supervise the duties of a large Asian clerical staff.

(c) He must be able to maintain records of officers' personal emoluments, vote ledgers for all expenditure of the Labour Department; income tax, motor car and other advance accounts and reconciliation with the Treasury at regular intervals.

(d) (1) He must have an advanced knowledge of accountancy as he must check all accounts and payment vouchers;

(2) Draft routine correspondence in connexion with accounts;

(3) Maintain the department's cash book and be responsible for the issue of receipts for cash received from the general public;

(4) Maintain numerous accounts for disbursement of cash and railway warrants issued to natives to return to their place of employment, submission of bills and statements to their employers for repatriation to their reserves;

(5) Maintain numerous deposits and personal accounts involving large sums of money received for wages and compensation, scrutinize and pay claims.

(e) Maintain the register of recruiters and be responsible for the issue of recruiting licences.

(f) Assist in the preparation of draft annual estimates of revenue and expenditure and submission of special warrants.

## (2) Statistical Assistant, Statistical Section

(a) Organize the routine work of the annual census of employees. This covers the dispatching of the forms, the initial analysis of the completed returns and the preparation of the draft schedules.

(b) Be responsible for the extraction of statistics from the employment records maintained by the statistical section. This function will become more wide and varied if and when the Hollerith or Power-Samas machine aids are employed.

(c) Supervision of statistical section staff numbering six Asians and 32 Africans.

(d) Arrange for the preparation of prosecutions of deserters and help the general public to trace employees.

(e) Check all inward and outward correspondence.

(f) Maintain liaison with the Registration Section for the exchange of information on identity and employment cards.

## (3) Assistant Registrar in Charge of Records, Registration Section

The duties of this post include a thorough knowledge of:—

(a) The Registration of Persons, Domestic Employment (Certificate of Registration) and Employment Ordinances.

(b) The registration routine in the Central Registration Office, including liaison with the finger print section.

(c) Registration routine at district registration offices.

(d) Registration statistics and reports.

(e) Investigations, prosecutions and court procedure. In addition:—

(i) Be capable of controlling and supervising Asian and African staff.

(ii) Dealing with members of the public of all races.

## MEDICAL DEPARTMENT

(Special Grade)

## (a) Clerk in Charge, African Establishment

Maintaining records of African staff employed at hospitals, staff postings, leave movements, etc. Preparation of letters of appointment, incremental certificates and schedules of staff required in support of annual estimates. Drafting and typing all correspondence dealing with African staff.

He must be fully conversant with the regulations pertaining to African staff and in particular to trained medical personnel.

## (b) Clerk, Group Hospital, Nairobi

Responsibility for the maintenance of hospital expenditure accounts, in- and out-patient registers, preparation of hospital bills, submission of return of diseases, etc. Correspondence, including report for which a knowledge of medical terminology is required.

Experience in hospital clerical duties and capacity to supervise the work of the clerical staff are essential.

## POLICE DEPARTMENT

## Senior Accounts Clerk (Asian), Special Grade

## Qualifications and Duties.—

To be able to compile the consolidated account of the Police Department for presentation monthly to the Accountant General and the Auditor.

To ensure that all departmental revenue and expenditure is properly allocated and accounted for.

To maintain advance and deposit accounts and see that R.B.C. and I.D.C. accounts are properly and promptly cleared.

To check all charges in the Railway Warrant Account and control accounts with the Military and other Governments.

A practical knowledge of Police Standing Orders would be of great advantage.

## PRISONS DEPARTMENT

(Special Grade)

## (a) Chief Clerk in Charge of Establishment and Accounts, Prisons Headquarters

The holder of this post must have a thorough knowledge of Prisons Standing Orders, the Prisons Ordinance and Rules, the Detention Camps Ordinance and Rules, and the procedure peculiar to the organization of the Kenya Prisons Service.

He must also have knowledge of the Juveniles Ordinance and Rules dealing with approved schools, the Probation of Offenders Ordinance and Rules, the Vagrancy Ordinance and other laws of the Colony, including the Penal Code and Criminal Procedure Code affecting the working of the prisons and detention camps.

He must be fully conversant with the Code of Regulations, Financial Orders, and other Government regulations dealing with the revised terms and conditions of service resulting from the Salaries Commission Report.

He must be able to deal with correspondence and matters connected with establishment and accounts relating to the personnel of the department concerning appointments, promotions, increments, transfers, leave, passages, housing, deduction of rent, departmental examinations, provident fund, advances and deposits accounts, income tax, revenue from prison industries and hire of convict and detainee labour, etc.

He must possess a thorough knowledge of the organization of the filing system at headquarters as he is frequently required to produce at short notice previous rulings and correspondence including those from the Secretary of State and the Government. He is responsible for the prompt rendition of all returns required by the Accountant General and the Government in connexion with staff, prisoners, etc.

He will be required to maintain complete statistics dealing with the administration of 35 prisons, 10 prison camps, 43 detention camps, two approved schools, and the probation services, and to compile Blue Book returns and other statistical information required by the Government for submission to the Secretary of State and/or for transmission to the United Nations Organization.

He will also be required to assist in the preparation of annual estimates of expenditure, and revenue from the prison industries and hire of convict labour, in the compilation of the necessary statistics for the departmental annual report, in the preparation of notices for publication in the Official Gazette in respect of establishment and closing of prisons and detention camps, and in the preparation of Prisons Service Orders.

He will be responsible for the control of imprest accounts, and the internal administration of the headquarters. He is required to keep up to date all sets of Ordinances and Rules dealing with prisons, detention camps, juveniles, vagrants, and probation services.

He will be responsible for the supervision and training of junior members of the Asian staff and must possess ability to do so. Must be a good typist and have a thorough knowledge of English and capable of drafting letters on all the above matters.

He will deal with confidential correspondence as directed by the Commissioner of Prisons.

(b) *Chief Clerk, Nairobi Prison*

The holder of this post must have a thorough knowledge of Prisons Standing Orders, the Prisons Ordinance and Rules. He must be fully conversant with the Code of Regulations, Financial Orders and other Government routine work.

He will be responsible for the safe custody and checking of all commitment warrants of persons admitted to prison, the calculation of their dates of release on remission or licence, the alteration of such dates due to revisions, appeals or to punishments inflicted for prison discipline, the receipt of all cash property of admissions and the refund of such property on release.

He will be responsible for the accurate record of admissions, transfers and discharges of daily average population of approximately 2,000 persons, and submission of the necessary returns to head office.

He will be responsible for the proper maintenance of all prison registers as prescribed by the rules, and other books of account dealing with prisoners' deposits, maintenance of civil prisoners, imprest and general cash, and miscellaneous receipts.

He must be able to conduct routine correspondence affecting prisoners' warrants, criminal records, finger prints, etc.

He will be required to train junior clerks of the department, including administration clerks sent for refresher course.

PUBLIC WORKS DEPARTMENT

(Special Grade)

(1) *Chief Stores Clerk*

The Chief Stores Clerk is required to possess the following qualifications:—

(a) Must be able to deal with correspondence and conduct the typing, filing and supervision of the clerical personnel employed in the Stores Branch.

(b) Must have a thorough knowledge of engineering materials peculiar to a Public Works, and be able to cost and prepare indents for local and overseas purchases.

(c) Must have a knowledge of the Code of Regulations, Financial Orders, and stores accounting methods.

(2) *Chief Accounts Clerk*

The Chief Accounts Clerk is required to supervise the consolidation of accounts section of the Chief Accountant's Office, and should possess the following qualifications:—

(a) Must be able to supervise and train junior staff and deal with the correspondence and any audit observations connected with consolidation of accounts.

(b) Must be fully conversant with the accounting procedure peculiar to a self-accounting department, and be in a position to analyse the various revenue and expenditure accounts, and reconcile the inter-departmental remittance-between-chests, and imprest accounts.

(c) Prepare from the various accounts of revenue and expenditure the final monthly account, in typed form, for submission to the Accountant General, Nairobi.

(3) *Chief Salaries Clerk*

The duties applicable to the post of Chief Salaries Clerk are as follows:—

(a) Ability to supervise the preparation of the monthly pay-sheets of all personnel paid from headquarters.

(b) The rendering of returns in respect of all the recoveries from an officer's emoluments, i.e.:—

(i) Income tax.

(ii) Provident fund.

(iii) Widows' and orphans' pensions schemes.

(iv) Family remittances.

(v) House rents.

(vi) Personal advances.

(vii) Court attachments.

(c) To deal with correspondence arising from any inquiries or observations on salaries payments.

(d) Supervision and training of junior clerical staff.

(4) *Establishment Clerk*

The duties applicable to the post of Establishment Clerk are as follows:—

(a) Must have a thorough grasp of Government regulations affecting personnel, and be able to produce promptly departmental and extra-departmental rulings affecting Public Works personnel.

(b) Must be fully acquainted with the classification of the various scales of salary for permanent staff and the rates of pay and terms of service applicable to casual employees on hourly or daily basis in the Public Works.

(c) Must be able to deal with routine correspondence affecting European, Asian and African staff on a variety of terms

and conditions of service peculiar to the Public Works and assist in the compilation of the Annual Draft Estimates in regard to personnel.

(d) Must be in a position to train junior staff and be courteous in dealing with the numerous inquiries that arise on matters affecting personnel.

(5) *Chief Correspondence Clerk*

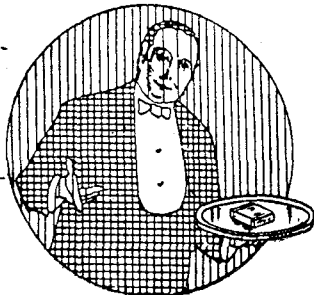
