A BILL ENTITLED

AN ORDINANCE TO AMEND THE INCOME TAX **ORDINANCE**

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows—

1. (1) This Ordinance may be cited as the Income Tax Short title (Amendment) (No 3) Ordinance, 1951, and shall be read and construed as one with the Income Tax Orcinance, hereinafter Cap 254 referred to as the principal Ordinance

- (2) This Ordinance shall apply to assessments for the year of assessment commencing on the 1st January, 1952, and each subsequent year of assessment
- 2. Paragraph (b) of sub-section (1) of section 24 of the Amendment of principal Ordinance is amended in the following respects—

- (a) by substituting for the words "eighty pounds" and 10 "forty pounds" the words "one hundred and twenty pounds" and "sixty pounds" respectively,
 - (b) by substituting for the words "fifty pounds" in paragraph (11) of the proviso the words "seventy-five pounds"

MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to increase by fifty per cent the existing child's and children's education allowances

No additional expenditure of public money will be incurred if this Bill becomes law, but some loss of revenu amounting approximately to forty thousand pounds will result

1. (1) This Ordinance may be cited as the Customs Tariff (Amendment) (No 2) Ordinance, 1951, and shall be read and construed as one with the Customs Tariff Ordinance, hereinafter referred to as the principal Ordinance

MEMORANDUM OF OBJECTS AND REASONS

The principal object of this Bill is to increase the revenue to meet the Colony's increased recurrent expenditure. Opportunity has also been taken to amend Item 11 of the Tariff in order to admit duty free human milk substitutes and to reduce the duty pavable under Item 105 on soap, soap powders and extracts from S1 10 per 100 lb or 40 per cent ad valorem, whichever is greater, to Sh 5 or 20 per cent ad valorem

No additional expenditure of public money will be incurred if the provisions of this Bill become law

Short title and commencement Cap 267

- 1. (1) This Ordinance may be cited as the Beer (Amendment) Ordinance, 1951, and shall be read and construed as one with the Beer Ordinance hereinafter referred to as the principal Ordinance
- (2) This Ordinance shall be deemed to have come into 5 operation on the 31st October, 1951

Amendment of section 4 of the principal Ordinance

2. Section 4 of the principal Ordinance is amended by substituting the words "one hundred and eighty" for the words "one hundred and twenty"
