The Governor deeply regrets to announce the death of Dr Alan McKinstry Fleming, M.C. Senior Medical Officer in Charge, Nairobi Are, which occurred on 17th October, 1951, at the age of 56 years

Dr McK Fleming first joined the Colonial Medical Service in 1929 and was posted as lecturer in medicine to the Mulago Hospital Medical School, Uganda, until 1933 He rejoined the Service as Nedical Officer at Gibraltar in 1936 and was transferred to Kenya in 1942 By his untimely death the Government has lost the ervices of a loyal and efficient officer

A BILL ENTITLED

AN ORDINANCE TO AMEND THE HINDU MARRIAGE, DIVORCE AND SUCCESSION **ORDINANCE**

ENACTED by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof, as follows —

This Ordinance may be cited as the Hindu Marriage, Short title Divorce and Succession (Amendment) Ordinance 1951, and shall be read and construed as one with the Hindu Marriage, 5 Divorce and Succession Ordinance, hereinafter referred to as Cap 149 the principal Ordinance

2. There shall be substituted for section 6 of the prin- Repeal and cipal Ordinance the following section—

replacement of section 6 of the principal Ordinance

Notwithstanding the provisions of section 15 of Application of the Subordinate Courts (Separation and Maintenance) Ordinance, the provisions of that Ordinance shall apply Courts to any husband and wife whose marriage is deemed to be a valid marriage under section 3 of this Ordinance or Ordinance whose marriage, if contracted without the Colony, is a valid Hindu marriage

section 15 of the Subordinate (Separation and Maintenance)

MEMORANDUM OF OBJECTS AND REASONS

Section 6 of the Hindu Marriage, Divorce and Succession Ordinance (Cap 149) (hereinafter referred to as the principal Ordinance) applies the Subordinate Courts (Separation and Maintenance) Ordinance (Cap 6) to husbands and wives who, under section 3 of the principal Ordinance, are deemed to have contracted valid Hindu marriages The aforesaid section 3 however only applies to Hindu marriages contracted in the Colony Since it is believed that it was not the intention to exclude from the provisions of the Subordinate Courts (Separation and Maintenance) Ordinance (which provides for the making of separation and maintenance orders) persons who contracted a valid Hindu mairiage outside the Colony, this Bill will amend section 6 of the principal Ordinance to provide for this

No additional expenditure of public moneys will be incurred if the provisions of this Bill become law
