Public notice of an application to be made for extension of the area of supply the subject of Distributing Licence No 9 dated 11th March 1932 (Eldoret Municipality) to include a further area surrounding the same

NOTICE is hereby given to all whom it may concern that on the 10th day of July, 1952 the East African Power and Lighting Company, Limited (a limited liability company incorporated in the Colony and Protectorate of Kenya and having its registered

office at Nairobi in the said Colony) will make application to His Excellency the Governor in Council under section 35 of the Electric Power Ordinance for extension of the area of supply the subject of Distributing Licence No 9 dated 11th March, 1932 (which at present comprises the Municipality of Eldoret and in respect of which the applicant is licensee) to include a further area surrounding the Municipality of Eldoret for the reasons that such further area is now sufficiently developed to justify inclusion thereof in the said area of supply, and that the applicant is now in a position to supply electrical energy within such further area, and that such extension will be equitable to the licensee and consumers in every area concerned or affected and that no licensee or consumer will be unduly prejudiced thereby

The area which it is proposed that the said area of supply should be extended to include is shown on a plan marked ELD 1 (copies of which are now deposited at the offices of Messrs Hamilton, Harrison & Mathews advocates, Nairobi House Nairobi, and at the offices of the applicant at Coryndon Street, Eldoret) and thereon bordered red and is bounded as follows —

By a circle measured on the said plan as having a radius of $7\frac{1}{2}$ miles from Eldoret Railway Station

The public or local authorities, companies, persons or bodies of persons affected by the grant of this application will be as follows —

- (a) The Municipal Board of Eldoret—to the extent envisaged by section 19 of the Electric Power Ordinance
- (b) Companies, persons and bodies of persons resident or carrying on business in the proposed area of extension—in that they will be entitled to requisition a supply of electrical energy as provided by the Electric Power Ordinance
- (c) Other companies persons and bodies of persons desiring to supply electrical energy in the same area on sale—in that such supply will by the grant of this application be precluded except as far as authorized under section 4 of the Electrical Power Ordinance
- (d) The Provincial Commissioner, Rift Valley Province, and the District Commissioner, Eldoret—to the extent of the general interest of Government in the development and welfare of the areas concerned

3 Except as hereinafter specifically provided, this Order shall apply to every farm within the area of the Council and to all such portions of forest area, within the area of the Council, as abut upon and lie within one mile of any farm

4 The minimum number of days in a year on which a resident labourer shall work and for which he shall receive wages shall be two hundred and seventy

5 (1) In the Molo, Mau Summit and Turi Wards of the area of the Council, no resident labourer or African (including a Somali) shall, after the 30th day of September, 1952, keep any stock on any farm

(2) In the Njoro Ward of the area of the Council, no resident labourer or African (including a Somali) shall, after the 30th day of September, 1952, keep any stock on any farm

Provided that not more than two sheep may be kept at any one time in a *boma* or pen

(3) In the Ravine Ward of the area of the Council no resident labourer or African (including a Somali) shall, after the 30th day of September, 1952, keep any stock on any farm

Provided that not more than five sheep may be kept

(4) In the Solai Ward of the area of the Council, no resident labourer or African (including a Somali) shall, after the 30th day of September, 1952, keep any stock on any farm

Provided that—

(i) until the 30th day of September, 1953 not more than ten sheep may be so kept,

(ii) after the 30th day of September, 1953, and until the 30th day of September, 1954, not more than six sheep may be so kept,

(iii) after the 30th day of September, 1954, and until the 30th day of September, 1955, not more than three sheep may be so kept,

(iv) within that portion of the ward lying to the west of the Nakuru-Solai Police Post-Whiterocks Road, not more than ten goats may be so kept,

(v) the Council may, in its absolute discretion and subject to such conditions as it may think fit to impose, by permit in writing authorize the keeping of any specified number of donkeys on any specified farm

(5) Elsewhere in the area of the Council to which this Order applies no resident labourer or African (including a Somali) shall, after the 30th day of September, 1952, keep any stock other than sheep not exceeding fifteen in number on any farm

6 (1) In the Molo, Mau Summit and Turi Wards of the area of the Council, it shall, after the 30th day of September, 1952, be a condition of the employment of any resident labourer on any farm that he shall not cultivate, otherwise than for the benefit of his employer, an area of the farm exceeding one and a half acres

Provided that the Council may, if in its opinion exceptional circumstances exist, by annual permit in writing, extend the area to two acres

(2) In the Londiani Ward of the area of the Council, it shall, after the 30th day of September, 1952, be a condition of the employment of any resident labourer on any farm that he shall not cultivate otherwise than for the benefit of his employer, an area of the farm exceeding two acres
