



Such plans, etc., shall be submitted in triplicate to the Town Clerk, Kisumu, within three months of the date of the commencement of the term.
- (iii) In the event of the grantee failing to comply with any condition herein contained, any proceedings that may be

necessar, will forthwith be instituted for the recovery of the land. Moneys that may have been paid in respect of the plot will be forfeited to the Crown.

- (iv) No buildings erected on the said land may be occupied until the grantee shall have submitted a block plan with the position of such buildings clearly defined and showing a system of drainage for disposing of surface and sullage water on the said land to a soakage pit to the satisfaction of the Local Authority and the Commissioner of Lands, and the grantee shall also sat sfy the Local Authority and the Commissioner of Lands that such system of drainage has been properly constructed, such sa isfaction to be expressed in writing.
- (v) The grantee shall, at his own expense, duly and suitably connect such drainage system with any town drainage system when, in the opinion of the Local Authority, the latter system is so far completed as to enable the grantee reasonably so to do.
- (vi) Any building erected on the plot shall conform to a building line decided upon by the Local Authority.
- (vii) he grantee shall not sell or transfer the plot nor enter into any mortgage charge (other than with the consent of the Commissioner of Lands for the raising of a loan for building purposes) or agreement for sale in respect thereof within ten years of the date of the commencement of the term.
- (viii) Subject to Special Condition No. (vii), the grantee shall not at any time during the continuance of the term of the grant subdivide the land or assign, sub-let or otherwise dispose of any portion without prior consent in writing of the Governor.
- (ix) I ll out-buildings, offices, etc., shall be properly sited and screene I from view to the satisfaction of the Local Authority or such p rson as may be appointed for the purpose and shall be kept so screened during the continuance of the grant.
- (x) The Governor or such person or authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, sewers, pipes and drains, telegraph and telephone wires and electric mains of all descriptions whether overhead or underground, and the granter shall not erect any building in such a way as to cover or interfere with any existing alignment of mains, sewers or service pipes or the telegraph or telephone, wires and electric mains aforementioned.
- (xi) he grantee shall pay such rates, taxes, charges, duties, assessments or out-goings of whatever description as may be imposed, charged or assessed, by any Government or Local Authority upon the land or buildings erected thereon, including any contribution or other sum paid by the Government in lieu thereof.
- (xii) The use of the plots shall be restricted to residential purposes only or for the combined purposes of residence and busines and for no other purpose whatsoever. The business will be restricted to that of general retail trade and a residence shall to deemed to be a building for the use of one family only, with one kitchen only.

(xiii The site coverage of the plots shall be restricted to 50 per cent of the area of each plot.

(xiv) In the event of the plots being used for residential and business purposes, not more than two shops will be permitted on each plot, provision being made for a separate store for each shop and residential accommodation will be restricted to the upper storeys.

(xv) At no time during the term of the grant shall any plot or po tion thereof or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by a notice in the Kenya Official Gazette.

(xvi) A veranda may be erected within the road reserve with the previous consent of the Local Authority and must conform to a building line decided upon by such Authority.
