#### A BILL ENTITLED

# AN ORDINANCE TO PROVIDE FOR THE LEVY OF A TEMPORARY SPECIAL TAX ()N THE MEMBERS OF THE AFRICAN TRIBE KNOWN AS THE KIKUYU

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

1. (1) This Ordinance may be cited as the Special Tax short title and (Temporary Provisions) Ordinance, 1953.

duration.

- (2) This Ordinance shall be deemed to have come into force on the 1st day of January, 1953, and shall continue in <sup>5</sup> force until the 31st day of December 1954, and shall then expire.
- (3) Upon the expiry of this Ordinance sub-section (3) of section 13 of the Interpretation and Cieneral Clauses Ordin- Cap. 1. ance (which relates to the effect of repeals) shall apply as if 10 this Ordinance had been repealed.
  - 2. In this Ordinance, unless he context otherwise Interpretation. requires-

"adult male Kikuyu" means a male Kikuyu of or over the apparent age of eighteen years;

"Kikuyu" means a member or apparent member of the Kikuyu tribe;

"present emergency" means the public emergency referred to in Proclamation No. 38 made by the Governor on the 20th day of October, 1952;

"scheduled area" means an area leclared as a scheduled area under the provisions of sub-section (1) of section 3 of this Ordinance?

"special tax" means the specia tax imposed by this Ordinance:

- "year" means the twelve months ending on the 31st day of December.
- 3. (1) Whenever it appears to the Governor in Council Application. that the amount or nature of crime in any area in the Colony is, or has, whether before or after the commencement of this 30 Ordinance, recently been, abnormal, the Governor in Council may, by order published in the Gazette, declare any such area to be a scheduled area for the purposes of this Ordinance.
- (2) The Governor in Council may by any subsequent order, published as aforesaid, without prejudice to any other 35 power of revocation or amendment vested in him, extend, diminish or otherwise vary any scheduled area or the limits thereof, and upon the coming into force of any such subsequent order the provisions of this Crdinance shall apply to the scheduled area as so extended, ciminished or varied.
- 4. Every adult male Kikuyu who, at any time in any special tax. year during which this Ordinance is in operation, is in a scheduled area shall pay in respect of that year a special tax of twenty shillings.

Date on which tax due and penalty for non-payment.

5. (1) Subject to the provisions of section 7 of this Ordinance, the special tax shall become due and payable to a collector on or before the 30th day of April in each year at the place appointed for the purpose under the provisions of section 6 of this Ordinance:

Provided that, in the case of any adult male Kikuyu who is not in a scheduled area on or before the 30th day of April in any year but becomes liable to pay the special tax in that year by reason of the fact that he enters a scheduled area after the aforesaid 30th day of April, the special tax shall become 10 due and payable on the date on which such adult male Kikuyu so enters a scheduled area as aforesaid.

(2) Any person who fails to pay the full amount of the special tax due in respect of any year within six months of the date upon which the same becomes due shall, subject to the 15 provisions of this Ordinance, be liable, in addition to his liability for payment of such special tax, to a penalty of ten shillings which shall be deemed to be special tax for the purposes of this Ordinance and recoverable accordingly.

Appointment of places for receipt of tax.;

6. The special tax shall be paid at the office of the 20 district commissioner of any district for the time being within a scheduled area or at any such other place as the district commissioner may appoint for the purpose.

Payment of instalments.

7. Payment of the special tax shall not be made and a collector shall not be obliged to receive payment thereof 25 otherwise than in the full amount thereof paid at one time:

Provided that a collector exercising his functions under this Ordinance within the Municipality of Nairobi may accept payment of the special tax due in any year from any person by way of equal instalments payable on any two or more of the 30 following dates, namely, the 31st day of January, the 30th day of April, the 31st day of July and the 31st day of October, of that year.

Remission of

- 8. Whenever a district officer is satisfied that any person liable to pay any special tax under this Ordinance—
  - (a) is without sufficient means to pay the whole amount thereof: or
  - (b) is deserving of the remission of the whole or any part thereof by reason of his having, whether before or after the commencement of this Ordinance, actively 40 supported the maintenance of law and order in the Colony or any part thereof in the present emergency;

such officer may allow the remission of the whole or any part of such special tax:

Provided that in such case the officer shall give to such 45 person a certificate in such form as may be prescribed relieving him from liability to pay such portion of the special tax as may be specified in such certificate.

Incorporation of certain provisions of the African Poll Tax Ordinance, Cap. 252.

9. All the provisions of the African Poll Tax Ordinance, except the provisions of sections 1, 3, 4, 5, 6 (1), 8, 9, 50 10 and 11 thereof, are hereby incorporated and shall be deemed to form part of this Ordinance:

Provided that the provisions so incorporated shall, as so incorporated, have effect—

- (i) as if all references therein to poll tax and to any 55 penalty in respect of non-payment thereof were construed as references to the special tax and the penalty prescribed by section 5 of this Ordinance;
- (ii) as if there were substituted for the word "African" wherever that word appears therein, the word 60 "Kikuyu"; and

- (iii) as if such of those provisions as are specified in the first column of the Schedule o this Ordinance were modified in the manner set forth in the second column of that Schedule.
- 5 10. Nothing in this Ordinance contained shall pre-Savings. judicially affect the provisions of the African Poll Tax Ordin- Cap. 252. ance or the African Poll Tax (Urban Areas) Ordinance, 1950. No. 55 of 1950.

# MEMORANDUM OF OBJECTS AND REASONS

It is considered that, since the present e nergency has been directly caused by the subversive and criminal activities of large numbers of the Kikuyu tribe, some portion of the extra cost which would otherwise have to be borne by the general revenues of the Colony should be met by members of the Kikuyu tribe in the areas particularly affected. This Bill accordingly makes provisions for the imposition of a special tax of Sh. 20 which will be payable in both the years 1953 and 1954 by all adult male Kikuyu in "scheduled areas".

Clause 1 provides for the temporary operation of the Ordinance and clause 2 deals with the interpretation of expressions used therein.

The application of the Ordinance is governed by clause 3 under which the Governor in Council may declare to be "scheduled areas" such areas as appear to the Governor in Council to be areas in which the amount or nature of crime is or has recently been abnormal.

Clause 4 imposes the special tax of S<sub>1</sub>. 20 per annum on every male adult Kikuyu in a scheduled area. Clause 5 provides for the date upon which the special tax becomes pay ble and for a penalty in respect of non-payment, on the same line as the African Poll Tax Cap. 252. Ordinance, and clause 6 deals with the places appointed for payment of the tax.

It is considered that, in the Municipality of Nairobi, payment might be made by instalments and clause 7 provides accordingly; elsewhere the tax will be payable in one sum.

The remission of tax is dealt with in clause 8, whereunder remission may be given, in the discretion of a district officer, on the grounds of poverty or active loyalty in the present emergency.

Clause 10 incorporates, with the necessary modifications, certain provisions of the African Poll Tax Ordinance, mainly dealing with the Cap. 252. administration of the Ordinance.

It is not possible to estimate the amount of revenue which will accrue if the provisions of this Bill become law.

#### A BILL ENTITLED

# AN ORDINANCE TO AMEND THE DISTRIBUTION OF GERMAN ENEMY PROPERTY ORDINANCE, 1951

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

Short title.

1. This Ordinance may be cited as the Distribution of German Enemy Property (Amendment) Ordinance, 1953, and shall be read and construed as one with the Distribution of German Enemy Property Ordinance, 1951, hereinafter referred to as the principal Ordinance.

No. 32 of 1951.

2. Section 3 of the principal Ordinance is amended in the following respects—

Amendment of section 3 of the principal Ordinance.

- (a) by inserting, immediately at the commencement of sub-section (1) thereof the words "Subject to the provisions of section 7 of this Ordinance";
- (b) by re-lettering paragraph (g) of sub-section (2) thereof as paragraph (h) and inserting the following new paragraph as paragraph (g) of that sub-section—
  - (g) the charging of fees in respect of the collection and realization of German enemy property 15 hereunder;

Repeal and replacement of section 7 of the principal Ordinance.

Power to exempt certain property.

3. There shall be substituted for section 7 of the principal Ordinance the following section—

7. The Governor may, subject to such conditions as he may think fit to impose—

he may think fit to impose—

(a) by Order, exempt from the provisions of this

- Ordinance any property of any Christian religious mission;

  (b) dispose of, or direct the disposition of, any such
- (b) dispose of, or direct the disposition of, any such property to such person and in such manner as 25 he may think fit.

### MEMORANDUM OF OBJECTS AND REASONS

No. 32 of 1951

Experience has shown it to be desirable that the Distribution of German Enemy Property Ordinance, 1951, should be amended in certain respects, and this Bill is designed to effect such amendments.

Section 3 of the principal Ordinance provides that the Governor may by order provide for the collection and realization of German enemy property, the payment of claims out of the proceeds by the administrator, and the charging by the administrator of fees in respect of the payment of such claims. The section does not permit the administrator to charge fees for the collection and realization of such property, although the Custodian of Enemy Property, who exercises similar powers under the Trading with the Enemy Ordinance, 1939, is empowered under that Ordinance to charge such fees. Clause 2 of the Bill will remedy this inconsistency.

No. 21 of 1939.

Section 7 of the principal Ordinance enables the Governor by order to exempt from the provisions of the Ordinance any property of any Christian religious mission. In certain cases it may be undesirable or impracticable to return the property to the mission, but it may, nevertheless, be desirable that the property should be made available to another mission which is able and willing to carry on the work for which such property was formerly used, in order that a local need for medical or educational facilities may continue to be met. Clause 3 of the Bill will, whilst retaining the right to exempt in suitable cases, enable property to be disposed of for this purpose.

It is not expected that any additional expenditure of public moneys will be incurred if the provisions of this Bill become law.

#### INCOME TAX COMMITTEE

THE Income Tax Committee, notice of whose appointment and terms of reference was given in the Kenya Official Gazette under General Notice No. 2637 of 24th November, 1952, are prepared to receive representations from organizations and individuals on any matter falling within their terms of reference, which are:-

"To study the Act of the High Commission to provide for the management and collection of income tax by the East African Income Tax Department and to make recommendations for amendments which should be made to the Act under Clause 97, which should be to the general benefit of the Colony."

Clause 97 of the East African Income Tax (Management) Act, 1952, reads:—

"The Governor of any of the Territories may, with the approval to be signified by resolution of the Legislative Council of that Territory and by order published in the Gazette, amend the provisions of this Act in its application to that Territory."

Representations should in the first place be in writing. The Committee will decide later from whom they wish to take oral evidence and will advise such persons or organizations accordingly and of the place and time when they wish to take such evidence. The Committee will meet principally in Nairobi but may hold meetings elsewhere for the purpose of hearing oral evidence, depending upon the written representations feceived. Meetings of the Committee at which evidence is taken will not be in public.

Written representations may be made in any form and on any matter concerning which provision is contained in the Act. It will, however, be of material assistance to the Committee if, when representations are made, they are given under one or more of the following main headings, as appropriate, and if reference is made specifically to the particular section or sections of the Act to which reference is intended.

- A.—Administration of the Act (Sections 3–7).
- B.—Imposition of Tax (Sections 8–10).
- C.—Exemptions (Sections 11-13 and Third Schedule) (see note below).
- D.—Deductions and Related Matters (Sections 14-21, but excluding Section 14 (1) (k) and Second Schedule).
- E.—Capital Expenditure (Section 14 (1) (k) and Second Schedule).
- F.—Treatment of Certain "Private" Companies (Section 22).
- G.—Avoidance of Tax (Sections 23 and 24).
- H.—Personal Allowances (Sections 25–35) (see note below).
- J.—Rates of Tax, etc. (Sections 36-44) (see note below).
- K.—Double Taxation (Sections 45-48 and "Arrangements", vide Section 47).
- L.—Miscellaneous (Sections 1, 2 and 49 to 99 inclusive, and First, Fourth and Fifth Schedules).

(With reference to Heads C, H and J above, these are matters more specifically dealt with or to be dealt with by Territorial Legislation. The Committee's terms of reference do not include examining into or making recommendations concerning the actual rates of tax or the actual amounts of personal allowances and reference to such matters should be avoided in representations made to the Committee save to the extent that such reference is essentially relevant to representations made in other directions.)

It further proposes to levy an unloading charge to 5 cents per 100 lb. or part thereof on bagged, baled and cased goods and 10 cents per 100 lb. or part thereof on bricks or similar loose goods in respect of the initial unloading of the goods in the port transit sheds or stacking grounds when the goods have been carried at specifically rail export rates from up-country centres.
