IN RELATION TO TROUT FISHING IN THE KERICHO DISTRICT

IN EXERCISE of the powers conferred upon me by section 4 of the Trout Ordinance, I hereby declare that—

2. The following waters are opened for the purpose of trout fishing:—

- (a) The Kimungu River down-stream from the south-western Mau Forest Reserve's western boundary till it becomes part of the Jamji River.
- (b) The Dimbilil River down-stream from the south-western Mau Forest Reserve's western boundary till it becomes part of the Jamji River.
- (c) The Saosa River down-stream from the south-western Mau Forest Reserve's western boundary till it becomes part of the Jamji River.
- (d) The Jamji River from the confluence of the rivers Kimugu, Dimbilil and Saosa down-stream till it joins the Chemosit River.
- (e) The Maramara River from the south-western Mau Forest Reserve's western boundary down-stream till it joins the Chemosit River.
- (f) The Kipteget River from the south-western Mau Forest Reserve's western boundary down-stream till it joins the Itare Rivers and becomes part of the Chemosit River.
- (g) The Itare River from the south-western Mau Forest Reserve's western boundary down-stream till it is joined by the Kipteget River and becomes part of the Chemosit River.
- (h) The Chemosit River from the confluence of the Kipteget and Itare Rivers down-stream till it meets the Kipsonoi River and becomes the Sondu River.
- (i) The Kipsonoi River from the south-western Mau Forest Reserve's western boundary till it is joined by the Chemosit River and becomes the Sondu River.

3. On that portion of the Kimugu, Dimbilil, Saosa, Jamji, Maramara, Kipteget and Chemosit Rivers as demarcated under Paragraph 1 of these Rules no trout less than ten inches in length shall be killed.

4. On that portion of the Itare River down-stream from Kipsoi's Mill and marked by a notice board no trout less than twelve inches shall be killed.

5. On that portion of the Kipsonoi River as demarcated in Paragraph 1 (i) of these Rules no trout less than twelve inches in length shall be killed.

6. On that portion of the Kipteget River as demarcated in Paragraph 1 (f) of these Rules no person shall retain more than eight fish in any one day.

7. On that portion of the Itare River as demarcated in Paragraph 1 (g) of these Rules no person shall retain more than eight fish in any one day.

8. On that portion of the Kipsonoi River as demarcated in Paragraph 1 (i) of these Rules no person shall retain more than eight fish in any one day.

9. No bait or lure other than an artificial fly dressed on a single hook shall be used on that portion of the Kipteget River from its junction with the Itare River up-stream to Reach 12 and marked by a notice board.
