## THE LEGISLATIVE COUNCIL ORDINANCE (Cap. 38)

SEMI-ANNUAL REVISION OF REGISTERS OF VOTERS

PURSUANT to rule 6 of the Second Schedule to the Legislative Council Ordinance, notice is hereby given that all persons desirous of having their names inserted in the Revised Registers of Voters for 1955 should forward their claims to the Registering Officer for the Electoral Area in which they claim to be entitled to be registered as voters on or before the 30th day of January, 1955.

Every claim should be made on the prescribed form printed copies of which may be obtained from the Registering Officers.
