FOR THE YEAR ENDED 31ST DECEMBER, 1958

In paragraph 2 of my report for 1957, I drew attention to the fact that the registers required to be kept under Section 6 of the Asian Officers' Family Pensions Fund Ordinance do not record details of contributions paid and pensions payable, and that this matter was being considered in conjunction with a report by the Organization and Methods Unit. I understand that a decision has not yet been reached. The figures for Sundry Debtors—Personal Contributions have been obtained from returns submitted by Departments and Ministries and those for Sundry Creditors—Widow's and Orphans' Pensions from the pensions cards.

2. Section 9 of the Asian Officers' Family Pensions Fund Ordinance requires that the Fund shall be valued at intervals of not less than five years. The last valuation was carried out in 1952. I am informed that it is proposed to amend the legislation to provide for a valuation at intervals of not more than ten years.

3. With reference to paragraph 3 of my report for 1957 on the question of election by certain officers of the East Africa High Commission and the East Africa Land Forces Organization I am informed that it is expected that the necessary amendments to the Ordinance will be drafted shortly.

**KENYA CULTURAL CENTRE**  
REPORT FOR YEAR 1958

The last Meeting of the Members of the Board of Management was held on 30th December, 1958. It had been intended to hold a Meeting in April, 1959, but owing to delay in obtaining the Audited Accounts it was decided to postpone the Meeting until they were ready. Also, in April the Council were not in a position to report progress on the next phase of the Cultural Centre as there had been certain delays over the arrangements concerning the siting of the new building.

Your Council met on six occasions during the year and in addition a Meeting was held in December, 1958, with representatives from the Constituent Members to discuss the plans of the next phase.

At the last Meeting discussions took place concerning amendments to the Ordinance to facilitate the easy management of the Cultural Centre, but so far these had not come up for consideration by Legislative Council.

The main items that concerned the Council during the year were:—

**1. Alteration to the System of Charging for the Theatre**

The basis of charging required amendment to endeavour to assist certain theatre users without, at the same time decreasing the expected revenue. After very careful consideration had been given by the Members of the Theatre Committee an amended set of terms and conditions for renting the theatre was agreed upon and came into effect in the latter part of the year.

**2. Planning of the next Phase**

Plans of the next phase of the Cultural Centre had now been agreed and also confirmed by the City Council. These plans were discussed by representatives of the Constituent Members at a Meeting in December. Delays were caused in progressing with the plans due to certain questions raised by the Technical College as to the site. These matters have now been satisfactorily resolved. The plans are now with the Quantity Surveyors so that specifications can be drawn up for obtaining tenders. Finance for the project has been arranged by the Council. The monies that will have to be borrowed will be repaid out of rentals over a period of approximately 18 years. Until final contracts are agreed it is impossible to give exact rental figure which will have to be charged, but it should be lower than the normal commercial rate.

**3. Alteration to Bar**

The Council received requests from the tenant of the Bar for certain alterations to be made in order to improve the bar and to attract more custom. In order to improve the facilities of the theatre for the public and also to prevent noise from the bar interfering with performances in the theatre, the Council agreed to proceed with these alterations. These alterations have now taken place since the end of the year and have cost £850.

**4. Performances**

During the year the following number of performances took place in the theatre:—

In addition to the above the theatre was used for Film Censorship and rehearsals.

**5. Accounts for the Year**

The Audited Accounts for the year are attached to this Report and you will note that Mr. Ord has signed as Hon. Auditor in the absence on overseas leave of Mr. K. A. Jeremy, his partner. The Accounts for the year show a net loss of Sh. 10,788 after allowing for depreciation amounting to Sh. 42,705. This was more favourable than the estimated budget which showed a deficiency of Sh. 80,900. Although there is a deficiency after depreciation there was an excess cash income during the year which has enabled the Centre to build up further funds. However, it must be remembered that monies will be required from time to time for extensive repairs and replacements to the fabric and equipment of the theatre.

Finally, the Council would like to record their very grateful thanks for all the very considerable assistance that has been given voluntarily by the Constituent Members, Members of the public and Members of the various committees without whose help the Centre could not carry on satisfactorily and also to the valuable assistance given by the Hon. Auditors. They would also like to record their thanks for the conscientious and loyal assistance given by the full time employed staff of the theatre.
