CONTRACT FOR PROVISION AND OPERATION OF A FERRY SERVICE AT KILIFI

THE MINISTRY of Works is interested in entering into a contract for the provision and operation of a Ferry Service at Kilifi for a minimum period of five years with the prospect of renewal.

Kilifi Ferry is a free public ferry 37 miles north of Mombasa on the main North Coast Road across a tidal creek approximately a quarter of a mile across. A 24-hour service will be required though at present the greater bulk of the traffic crosses during the hours of daylight. As an indication of the volume of traffic, Ministry of Works' records show that some 11,000 vehicles used the Ferry during the month of August, 1960.

The Ferry ramps would be provided and maintained by the Ministry of Works but the operator would be required to provide, operate and maintain the ferry craft. New modern craft are required capable of carrying a total load of 60 tons and single vehicles of up to 40 tons.

Companies or persons interested are invited to contact the Permanent Secretary for Works for further details with a view to making proposals. It is emphasized that the service is to remain a free public service on the basis of annual payments by the Government to the operator and is not a toll service.

A pre-requisite for the successful tenderer would be experience in the management and operation of ferry services.

In accordance with the provisions of Section 16 (b) of the Hospital Treatment Relief (European) Ordinance, No. 33 of 1951, the European Hospital Fund Authority established under the Ordinance is required to furnish as soon as possible after the expiration of each year a Report upon the administration of the affairs of the Authority during such year together with a Balance Sheet and Statement of the Receipts and Payments of the Authority, duly audited by the Government Auditor.

The Authority now has pleasure in submitting its Report for the year ended 31st December, 1959, supported by Audited Accounts.

AUTHORITY

2. The Hospital Fund Authority constituted in accordance with clause 3 (2) of the Ordinance, at present comprises of the following members:—

REPORT OF THE ACTING CONTROLLER AND AUDITOR-GENERAL ON THE ACCOUNTS OF THE EUROPEAN HOSPITAL TREATMENT RELIEF FUND
FOR THE YEAR ENDED 31ST DECEMBER, 1959

In my reports on the accounts for the years 1956, 1957 and 1958 I stated that no adjustments had been made in connexion with the contributions received from Government which were incorrectly calculated in respect of the former Hospital Services (European) Ordinance, Chapter 126. The Authority agreed to accept all calculation of Government's liability on the basis of that obtaining under Section 13 of the Hospital Treatment Relief (European) Ordinance No. 33 of 1951, and to waive its claim to any increase in contributions due in respect of assessments under Section 12 (2) of the former Ordinance, Chapter 126. It had also been pointed out to the Authority in this connexion that Government's contribution did not appear to have been received on certain contributions paid over by the Commissioner of Income Tax in 1954. These matters are still the subject of correspondence.

2. I have seen Schedules of Default amounting to £4,913-19s.-65cts. in respect of contributions payable to the Fund by the Commissioner of Income Tax which relate to the period up to 30th June, 1959. These amounts have been written off under the provisions of Section 8 (d) of the Hospital Treatment Relief (European) Ordinance, No. 33 of 1951.




