THE WATER ORDINANCE 1951
(No 56 of 1951)

In terms of section 153 of the Water Ordinance the Prairie Co-operative Society Limited being a water undertaker for the purposes of the Ordinance has made the following Regulations with the approval of the Minister which are hereby published for general information

REGULATIONS COVERING WATER SUPPLIES MAINTAINED BY THE PRAIRIE CO-OPERATIVE SOCIETY LIMITED

1 The Water (Undertakers) Rules 1953, apply to this Society

2 Any person owning land within the area for which the Prairie Co-operative Society Limited (hereinafter called "the Society") is from time to time declared by the Official Gazette to be the Water Undertaker under the said Rules and desiring to take water from the Society shall upon becoming a Member of the Society and entering into a formal Agreement with the Society in the prescribed form be entitled to the connexion of his premises by a water pipe not exceeding 1½ inches in diameter to the Society's watermain nearest to his land. All current Agreements with such landowners are hereby confirmed

3 The installation of such connexion as aforesaid together with the fixing of a meter thereto (which meter shall not exceed a nominal size of 1' and shall remain the property of the Society) shall be effected by or on behalf of the Society at the expense of the landowner (hereinafter called "the Consumer") who shall pay the amount thereof to the Society prior to the commencement of the supply of water to his land. If the amount paid by the Consumer in respect of such connexion shall be an estimated amount a corrected account shall upon completion of the work be rendered to the Consumer and any overpayment or underpayment shall be adjusted between the Society and the Consumer

4 The Consumer shall be entitled to a regular water supply for domestic purposes and/or minor irrigation (interruption by a mechanical breakdown act of God or other unavoidable cause always excepted) of 1 000 gallons of water per day. Such water supply shall be subject to any contingencies occurring on the works of the Society and to its ability to continue the same and shall not be required during the time that any repairs to the pipes or works of the Society are being carried out

5 The Consumer will pay to the Society for the water supplied to the Consumer as measured by the Society's meter at the rate from time to time fixed by the Society and approved by the Minister for Agriculture the said payment to be made on the last day of each calendar month and in case the sum payable in any one month shall be less than the price of five thousand gallons the Consumer will pay that sum as a minimum. The Consumer shall also pay such meter rent as shall from time to time be fixed by the Society

6 The following scale of charges has been fixed by the Society and shall be applicable, subject to revision from time to time, with the approval of the Minister for Agriculture —

Scale of Charges

	<i>Sh cts</i>
(1) For the first 5 000 gallons or part thereof of water supplied to a Consumer in any month a minimum charge of	17 50
(Note —It shall be assumed that water has been supplied unless a Consumer's meter shall have been disconnected from the Society's main supply for the whole of such month)

2 The grantee shall within six months of the commencement of the term submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of a petrol service station and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of Her Majesty to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of Her Majesty, the Governor or the Commissioner in respect of any antecedent breach of any condition herein contained.

3 The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4 Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. The land and buildings shall only be used for the purposes of a petrol and service station which shall include only the greasing, washing and oiling of vehicles. Adequate car-parking facilities are to be provided on the plot for those cars which are serviced at the station.

6. The grantee shall comply with the provisions of the Petroleum Ordinance (Chapter 304) and any amendment thereto or re-enactment thereof for the time being in force and the rules made from time to time thereunder.

7. The buildings shall not cover a greater area of the land than may be prescribed by the local authority.

8. The grantee shall not subdivide the land.

9. The grantee shall not sell, transfer, sublet or charge the land or any part thereof except with the prior consent in writing of the Governor; no application for such consent (except in respect of a loan required for buildings purposes) will be considered until Special Condition No. 2 has been performed.

10. The grantee shall not erect on the land any hoarding, placard, poster sign or advertisement except a notice advertising the presence and products of the grantee's business.

11. The grantee shall pay to the Commissioner of Lands on demand such sum as the Commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

12. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner may assess.

13. Should the Commissioner of Lands at any time require any road serving or adjoining the land to be constructed to a higher standard the grantee shall pay to the Commissioner on demand such proportion of the cost of such construction as the Commissioner may assess.

14. The grantee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon including any contribution or other sum paid by the Governor in lieu thereof.

15. The Governor or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether overhead or underground and the grantee shall not erect any building in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.

16. No covenant, condition or requirement will be entered into, imposed or made whereby the ownership or occupation of the land or any part thereof is restricted to persons of a particular race or races or class or classes of race, or whereby such persons are excluded from such ownership or occupation.
