KERICHO MILK PRICES ORDER

IN EXERCISE of the powers conferred by the Dairy Industry (Prices of Dairy Produce) Regulations, 1961, the Kenya Dairy Board hereby orders as follows —

- 1 The Dairy Industry (Prices of Dairy Produce) Regulations, 1961, shall apply to the area of the Township of Kericho
- 2 For the purpose of regulation 3 the prices to be paid by retailers for the categories of milk specified in Part I of the Schedule hereto shall be the respective fixed prices specified in sub-columns (A) and (B) of the second column of Part I
- 3 For the purpose of regulation 4 the prices to be paid to retailers for the categories of milk specified in Part II of the Schedule hereto shall be the respective fixed prices specified in the second column of Part II
- 4 The Board may on application give special written authority to purchase or sell milk at prices other than those prescribed by this Order
- 5 This Order shall take effect from 1st September, 1961
