THE LEGISLATIVE COUNCIL (CONSTITUENCY MEMBERS) (REGISTRATION OF ELECTORS) RULES, 1960 (L.N. 355/60)

NOTICE OF REVISION OF REGISTERS OF ELECTORS

NOTICE is hereby given that the register of electors for every constituency is to be revised, and that all persons who desire to be registered as electors in any particular constituency, and who are entitled to be so registered, or would be entitled to be so registered if they were not already registered in another constituency, may make application to be so registered. Application shall be made by attending personally before the Assistant Registration Officer for the registration area in which they are entitled to be registered (or a person deputed by him for the purpose) not later than the 2nd day of November, 1961, and by then producing to such officer or person a completed application in the prescribed form.*

The names of the constituencies into which Kenya has been divided, with their official abbreviations, are specified in the first column below. Each of these constituencies has been divided into the registration areas, or constitutes the registration area, as the case may be, specified in relation thereto in the second column below. Attendance must be made at one of the places specified in the third column below, according to the constituency and registration area in which the applicant is entitled to be registered: provided that, when a place of registration is closed, application may be made at the District Commissioner's Office during the times notified for attendance thereat:—
