## EAST AFRICAN RAILWAYS AND HARBOURS

## TENDER FOR UNSEASONED PODO TIMBER

TENDERS are invited for the supply of Prime Grade Unseasoned *Podocarpus* timber to the Kenya/Uganda Section of the East African Railways and Harbours.

The total quantity required is approximately 312,000 running feet, but the Railways reserve the right to increase or decrease the quantities as may be necessary during the contract period.
