THE East African Railways and Harbours gives notice that with effect from 1st January, 1962, Tariff Book No. 3 (Part II) has been amended as follows:—

Page 19. Section 320

Delete paragraphs 1 to 5.

Insert the following:-

- (1) Large animals (horses, ponies, mules, donkeys, cattle, calves four months old and over and foals three months old and over) will be charged at the cattle wagon head rates stated in paragraph (6).
- (2) Small animals (sheep, goats, pigs, calves under four months old and foals under three months old)—except pigs and calves under four months old, carried by specified pig trains—will be charged as large animals on the basis of six small animals or part thereof equal one large animal, and all references to the charging of large animals throughout this tariff shall apply accordingly to the charging of small animals. Calves at foot accompanied by their dams will be allowed to travel free of charge.
- (3) A minimum charge of Sh. 20 or as for nine large animals, whichever is the greater, will be raised per wagon unit. Bogie wagons will be charged as two wagon units. The average number per wagon unit will be used in assessing the minimum charge per wagon unit where the consignment requires more than one wagon.
- (4) The minimum charge will be apportioned according to the number of large animals loaded by each consignor where two or more consignments are loaded in the same wagon and consigned between the same stations.
- (5) The maximum charge for any wagon loaded with more large animals than are prescribed hereunder will be as for the stated maximum charging number of large animals, provided that—
 - (a) the animals are not overcrowded;
 - (b) the wagon is not loaded with a weight exceeding its marked carrying capacity.

- (a) an annual rent tendered per acre. There will be no royalties payable on the volcanic ash removed;
- (b) the required term of the licences based upon the tenderer's estimate of the life of the quarry for which he is prepared to pay the tendered rent; and
- (c) where an application is made for a large area a plan showing the proposed phasing of their quarry operations.
- 3. The rent due will be payable within seven days of being notified of the acceptance of the tender and thereafter on the 1st day of January in each succeeding year.
 - 4. The highest or any tender will not necessarily be accepted.

General Conditions

- 1. The land shall only be used for the purposes of quarrying and removing volcanic ash only save as in hereinafter provided.
- 2. The land shall not be quarried within 100 feet of any road or road reserve.
- 3. Quarrying will commence on the lower part of the plot, provided that this is not within 100 feet of any road or road reserve.
- 4. No excavation will be effected below the level of the commencing point.
- 5. The floor of the quarry will have a slight upward grade towards the working face, and will be so drained as to be clean and free from mosquito-breeding areas to the satisfaction of the Medical Officer of Health and the Commissioner of Lands.
- 6. Spoil will be used (a) to level the quarry floor after quarrying; (b) to fill excavations on the plot outside the actual quarry, as directed by the Commissioner of Lands or such officer as he may appoint to act on his behalf. No spoil will be removed from the site.
- 7. At all times the licensees will comply with the requests of the Commissioner of Lands, or such officer as he may appoint to act on his behalf, in respect of the proper conduct of quarrying operations.
- 8. Housing for Africans employed on the site may be erected on the plot in accordance with the requirements of the Labour Officer.
- 9. Proper sanitary arrangements will be provided in accordance with the requirements of the Medical Officer of Health.
- 10. The licensees shall ensure that the labour employed shall at all times be under the supervision of a responsible person while on the site.
- 11. The sides of the quarry will be left vertical or sloped outwards to the quarry floor to prevent any subsequent fall of earth or stone.
 - 12. The licensees will maintain the road leading to the quarry.
- 13. The licensees will mark out the boundaries of the plot with posts at 50-ft. intervals.
- 14. In the event of the above conditions not being complied with the Commissioner of Lands shall have power to cancel the licences at 30 days' notice and any moneys paid by the licensees shall be forfeited.
- 15.
