3. The terms of reference of the Committee are as follows:—

To inquire into the present position in regard to rent restriction (arising from the operation of the Rent Restriction Ordinance, 1959 (now Cap. 296) and the Eviction of Tenants (Control) (Mombasa) Ordinance, 1956 (now Cap. 298)); to advise whether or not there is a need that it should continue after 1962 and, if so, to what parts of the country and in what manner it should be applied; and to consider whether any further legislation relating to rent restriction is required.

4. In the meantime, pending the completion of the Committee's inquiry, the life of both Ordinances was on 12th December extended by resolution of the Legislative Council. The extension is for one year until 31st December, 1963, but the Ordinances will not be retained in force for the whole of this period if as a result of the Committee's recommendations changes in the law are decided upon by the Government and can be made before the end of 12 months.

5. The Committee will be pleased to receive written memoranda on the subjects covered by its terms of reference not later than 31st January, 1963. Such memoranda should be addressed to the Secretary, Rent Restriction Committee of Inquiry, P.O. Box 30016, Nairobi, and the envelope should be marked "Rent Restriction Committee". The Committee will be prepared to hear oral evidence at certain selected places at dates and times to be notified later.

NOTICE TO TRADERS

AN Inspector of Weights and Measures will open a Stamping Station at the places mentioned hereunder, for the purpose of assizing and stamping traders' weighing and measuring apparatus, on the dates stated.

2. All Traders, within a radius of twelve miles of the places mentioned are required, under the provisions of the Weights and Measures Ordinance, 1951, to produce to the Inspector of Weights and Measures, all weights, measures of length and capacity, and weighing instruments which they have in use for trade, for verification and stamping.
