#### KENYA CULTURAL CENTRE

REPORT FOR YEAR 1961

Your Council present herewith the Balance Sheet and Accounts of the Kenya Cultural Centre for the year ended 31st December, 1961, and report as follows

#### 1. Kenya National Theatre

In regard to the letting of the Theatre for the year 1961, the year has been one of the worst in the annals of the Theatre.

The Accounts show an excess of expenditure over revenue of ... .. Sh. 44,593 .. Sh. 37,724 which, after providing for depreciation of .. .. 00 Results in actual excess cash expenditure of .. Sh. 6,869 00 . .

The income from the Theatre decreased in comparison with the previous year by Sh. 19,925.00 and this was not entirely compensated for by a reduction in expenditure of Sh. 12,182.00.

Apart from the reduced use of the Theatre, income was also lost through a regular tenant of the Rehearsal Room moving to another part of the Centre which although benefitting a Constituent Member did not help the Kenya Cultural Centre.

The expenses of the Theatre are being maintained at their absolute minimum.

The current year shows a slight but not material improvement on the previous year.

#### 2. Kenya Cultural Centre Buildings

There is little to report on the operation of the Kenya Cultural Centre building which has proved its value in the regular use made by all the tenants and tenant purchasers.

There was a surplus of income from rents and interest receivable over expenditure of Sh. 3,313.00 which has all been utilized in repayments of principal to the Kenya Building Society. This is after providing for the Cultural Centre's share of the running expenses amounting to Sh. 6,120.00.

In regard to the cost of recurrent expenditure of the building, these costs are shared amongst the tenants and tenant purchasers and show a fund at the end of the year amounting to Sh. 10,848.00. Out of this fund future costs of maintenance will have to be provided and therefore it is not proposed, at the present time, to reduce the subscription costs which are made on a basis of area used.

#### 3. Executive Officer for the Kenya Cultural Centre

During the course of the year, meetings were held and suggestions made concerning the necessity of a full time Executive or Director of the Kenya Cultural Centre being appointed a proposal which the Council has always agreed as being necessary. It will be readily realised however from a study of the Accounts of the Centre that such an appointment cannot be made until there is a guarenteed minimum income from one source or another to meet the consequential costs. The Council have made many approaches to various Trusts and Organisations who might be of assistance including Government, in an endeavour to obtain finance for such an appointment but so far without success. I have also made many written and verbal appeals to leading business houses but with little sucess to date.

The Council take this opportunity of recording their gratitude to the many persons who have given so much time and thought voluntarily to this organisation during the course of the year and who continue to do so.

They would also like to specifically mention Mr. Alan Bramley whose voluntary work over a period of many years was outstanding. His leaving Kenya has meant a great loss to the Cultural Centre.

## THE CROWN LANDS ORDINANCE (Cav. 280)

NAKURU MUNICIPALITY—SHOPS, OFFICES AND FLATS (EXCLUDING A PETROL STATION)

THE Commissioner of Lands gives notice that two plots in Nakuru Municipality, as described in the Schedule hereto, are available for alienation and applications are invited for the direct grant thereof.

- 2. A plan of the plots may be seen at the Public Map Office situated in the Lands Department Building, City Square, Nairobi, or at the office of the Town Clerk, Nakuru, or may be obtained from the Public Map Office, P.O. Box 30089, Nairobi, on payment of Sh. 3 per copy, post free.
- 3. Applications should be submitted to the Commissioner of Lands, Nairobi, through the Town Clerk, Nakuru.
- 4. Applications must be sent so as to reach the Town Clerk, Nakuru, not later than noon on 28th January, 1963.
- 5. Applications must not be sent direct to the Commissioner of Lands.
- 6. Applicants must enclose with their application their cheque for Sh. 1,000 as a deposit, which will be dealt with as follows:—
  - (a) If the applicant is offered and takes up and pays for a plot within a period of 14 days as required in paragraph 8 below, the deposit will be credited to him.
- (b) If the application is unsuccessful the applicant's deposit will be refunded to him.
- (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in the following paragraph, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.
- 7. Applicants should also enclose a banker's statement or other suitable document showing the funds that they have immediately available to cover the cost of developing a plot in the event of their application being successful.
- 8. Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved the assessed stand premium and proportion of annual rent, together with the survey fees, the fees payable in respect of the preparation and registration of the grant (Sh. 225) and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent). In default of payment within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot.
- 9. The grant will be issued in the name of the allottee as stated in the letter of application.

#### General Conditions

- 1. The ordinary conditions applicable to township grants of this nature, except as varied hereby, shall apply to this grant.
- 2. The grant will be made under the provisions of the Crown Lands Ordinance (Cap. 280 of the Laws of Kenya) and title will be issued under the Registration of Titles Ordinance (Cap. 281). The term of the grant will be 99 years from the first day of the month following the notification of the approval of the grant

#### Special Conditions

- 1. No buildings shall be erected on the land, nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the Local Authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2. The grantee shall within six months of the commencement of the term submit in triplicate to the Local Authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of Her Majesty to re-enter into and upon the land or any part thereof in the name of the whole

and thereupon the term hereby created shall cease, but without prejudice to any right of action or remedy of Her Majesty, the Governor or the Commissioner in respect of any antecedent breach of any condition herein contained.

- 3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.
- 4. Should the grantee give notice in writing to the Commissioner of Lands that he/she/they is/are unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

- 12. Should the Commissioner of Lands at any time require the said roads to be constructed to a higher standard the grantee shall pay to the Commissioner on demand such proportion of the cost of such construction as the Commissioner may assess.
- 13. The grantee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or Local Authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the Governor in lieu thereof.
- 14. The Governor or such person or authority as may be appointed for the purposes shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.
