NOTICE OF INTENTION TO DECLARE AS PROTECTED AREAS THE  
SASAMUA AND RUIRU DAMS

IN ACCORDANCE with section 150 (2) of the Water Ordinance, the Minister for Land Settlement and Water Development hereby gives notice of his intention to make an order under section 150 (1) of the said Ordinance declaring the areas adjoining the Sasamua and Ruiru Dams, which areas are more particularly described in the Schedule hereto, to be protected areas.
