With reference to my previous report the sum of £6,552-0-13 representing the total of defaults in Nairobi in respect of 1960/61 has now been verified.

I have seen schedules of Default amounting to £5,672-5-15 in respect of taxpayers contributions payable to the Fund by the Commissioner of Income Tax, which were irrecoverable as at 30th June, 1962. Of these amounts written off under the provisions of Section 8 (d) of the Hospital Treatment Relief (European) Ordinance, Cap. 249, the sum of £884-5-15 representing the total defaults in Nakuru and Eldoret remains to be verified.
