Kenya Union of Commercial Food and Allied Workers—

International Computers and Tabulators (E.A.) Limited—  
Respondents.

2. The Parties were heard in Nairobi on the 22nd of March 1966, and relied on their written and verbal submissions. The Court members visited the Respondents' workshops and offices on the 23rd of March 1966, and saw the various employees working on their machines.

## GENERAL BACKGROUND

3. A Recognition Agreement exists between the Parties and was signed on 2nd December 1965. The Claimants approached the Respondents in June 1963, for recognition but, as their membership amongst the Respondents' employees was only 8 out of a total of 56, recognition was not granted. The Claimants submitted that after their first approach the Respondents employed delaying tactics and put off recognition on one pretext or another. The Respondents on the other hand maintained that after the initial approach nothing further was heard from the Claimants until 1965, when, following discussions, it was confirmed on 1st November 1965, that the Claimants represented a reasonable number of employees. This resulted in a Recognition Agreement being negotiated and signed on 2nd December 1965.

Following the Recognition Agreement the Claimants forwarded their demands on 6th December 1965, for Wages and Terms and Conditions of Service Agreement. Joint meetings were subsequently held on 28th and 29th December 1965, and again on 7th January 1966, whereby a certain measure of agreement was achieved on several issues. However, 11 items were still in dispute and the Claimants, on 8th January 1966, reported the existence of a dispute to the Ministry of Labour. On 7th January 1966, a Conciliator was appointed and as the result of a number of meetings the matters in dispute were reduced to 6. It was agreed that the remaining 6 items should be referred to the Industrial Court in accordance with the Trade Disputes Act, 1965. The Parties signed the Industrial Court Notification of Dispute Form "A" on 1st February 1966.

## MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. (1) *Wages*.—The Claimants submitted that the wages which were being paid by the Respondents were very poor when compared with the wages/salaries paid by other international companies in the country. They stated that the Respondents had very little competition in their field of operations and were doing extremely good business. An increasing number of firms were switching on to mechanized accounting systems and the Respondents were making large profits and were in a good position to pay wages and salaries over and above "a living wage".

The Claimants submitted that, although a Job Classification had been agreed, the Respondents' offers on minimum wage rates for the various jobs were ridiculously low and not acceptable to them. They pointed out that a Punch Operator was paid less than some Office Messengers yet was required to speak English fluently and be in possession of a K.P.E. Certificate or its equivalent. The other jobs entailed a high technical knowledge and the Respondents' offers were not commensurate with the degree of skill and ability required from the employees engaged in these jobs.

The Claimants stated that they had demanded minimum rates for the various jobs as follows:—

In further support of their demands the Claimants submitted that the cost of living had gone up considerably in the country and that if the employees did not get appropriate increases they would suffer a real hardship. They stated that the Respondents were practising racial discrimination in their salary structure as temporary European staff employed by them earned a salary of Sh. 800 which was far more than that earned by the full-time African employees. They submitted that the Sh. 200, as offered by the Respondents for Trainee Beginners was by no means adequate to cover their bare necessities. The Court was also informed that since September 1965, no member of the Claimants' Union had been given any increment nor appropriate promotion after having passed various tests laid down by the Respondents. The Claimants submitted that in the above circumstances their demands were reasonable and fair and requested the Court to award accordingly.

(2) *Leave Travelling Allowance*.—The Claimants submitted that although leave travelling allowance had been agreed in respect of all other categories of employees a dispute remained in respect of those employees who were earning between Sh. 400 and Sh. 800 per month. They argued that their demand of Sh. 150 under this issue was a very reasonable demand and was in line with many other agreements which had been negotiated by them with other employers.

(3) *Acting Allowance*.—An acting allowance was demanded by the Claimants for an employee who had acted in his superior duties for a minimum period of 15 consecutive days. This again, they submitted, was fair and reasonable.

(4) *Maternity Leave*.—The Claimants stated that there were only two female employees involved in this dispute and it was absurd for the Respondents to resist the demand made by them on this issue. They submitted that in Kenya there were no State schemes whereby female employees received benefits during the period of confinement, and that, therefore, it fell on the Respondents to allow paid maternity leave to their female employees. They submitted that their demand for 30 days' leave on full pay and the next 30 days without pay was just and requested the Court to make an award on these lines.

(5) *Redundancy*.—For every completed year of an employee's service the Claimants demanded two weeks' pay in the event of his being declared redundant. This they stated was not unreasonable and that the Court had made various similar awards.

(6) *Date of Implementation*.—The Claimants stated that they had first approached the Respondents in 1960 for a Recognition Agreement but had only obtained it on 2nd December 1965. They considered that they had a good case for asking that the implementation date should be from some time in 1962 as they had by then enrolled sufficient members to merit recognition. However, in order to be quite fair, they requested the Court to award the effective date of the agreement and the Court's award as from September 1965. They also requested the Court to fix the duration of the award for 12 months.

## MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. (1) *Wages*.—The Respondents submitted that it should be clearly recorded that negotiations on wages were based on the understanding that all wages quoted would be consolidated and inclusive of housing. They strongly refuted the Claimants' allegations that they were practising racial discrimination and stated that all employees received their remuneration in accordance with the work they performed.

Although the Job Classification had been agreed with the Claimants, agreement on the various minimum rates could not be achieved, the Respondents pointed out, due to the Claimants' negative attitude during negotiations. They submitted that their offers were reasonable and sensible and compared favourably with wage levels to be found in the country for similar jobs.

Their present minimum wage rates and offers were stated by the Respondents to be as follows:—

The Respondents further submitted that the Claimants proved obstinate and did not desire to negotiate in a spirit of compromise. This was unfortunate as with reasonable negotiations agreement could have been reached on some of the items. They drew the Court's attention to the various job descriptions and submitted that the Court should endorse their offers which were realistic.

(2) *Leave Travelling Allowance.*—It was submitted by the Respondents that agreement had been reached on this issue as follows:—

- Earnings up to Sh. 400 an allowance of Sh. 75.
- Earnings from Sh. 800 to Sh. 1,200 an allowance of Sh. 200.
- Earnings from Sh. 1,201 to Sh. 2,000 an allowance of Sh. 400.
- Earnings from Sh. 2,001 to Sh. 4,000 an allowance of Sh. 800.
- Earnings above Sh. 4,001 an allowance of Sh. 1,200.

The only category on which agreement had not been reached had been in respect of employees earning from Sh. 401 to Sh. 800. They stated that they had offered an allowance of Sh. 100 as against the Claimants' demand of Sh. 150 and submitted that their offer was generous and higher than average and should not be increased.

(3) *Acting Allowance.*—On acting allowance the Respondents stated that they had offered to pay an acting allowance provided the employee acted in his superior duties for a minimum period of one month. During negotiations they had reduced their offer to 21 consecutive days but the Claimants had not moved from their original demand. The Respondents submitted that their final offer of 21 days was as low as they could be expected to go and would certainly cover the period offered by them of an annual leave of three weeks.

(4) *Maternity Leave.*—The Respondents submitted that they had offered 60 unpaid days' leave prior to, and 60 unpaid days' leave after, childbirth with no loss of service rights and that although during negotiations the Claimants had offered to negotiate on the basis of 30 days on full pay and the rest without pay they had not reached any compromise on this issue. They submitted that it was a recognized international practice as recommended by the I.L.O. office that any payment to be made in respect of maternity leave was the responsibility of Government and not of the employer. Various extracts from the I.L.O. Conference report held in Geneva 1965, were submitted by the Respondents in support of their argument. They requested the Court to make a nil award on this particular issue.

(5) *Redundancy.*—Offers of severance pay on redundancy were claimed by the Respondents to have been made to the Claimants as follows:—

- (a) For employees with 1-5 years' service—1 week's pay for each year of service;
- (b) For years of service from 6-10—1½ weeks' pay for each year of service;
- (c) For years of service of 11 and over—2 weeks' pay for each year of service.

They submitted that this offer had not been accepted by the Claimants who had later reduced their demand to 10 days' pay for (a) and *pro rata* rate for (b) and (c). The Respondents stated that their offer was in accordance with established custom and that the Claimants had not in their evidence proved why the Respondents' employees should receive a higher redundancy pay than normal.

(6) *Date of Implementation.*—It was the Respondents' submission that as this was the first agreement between them and as recognition was agreed as recently as December 1965, there had been no undue delay in conducting negotiations. In these circumstances they requested the Court to follow the normal custom which was that for the first agreement to be dated from the first of the month following the date of signing of the agreement. They contended that any award should be applied from the first of the month following the publication of the Court's award and should be of 12 months' duration.

#### AWARD

6. The Court, having very carefully considered all the arguments and submissions put forward by the Parties, makes the following Award on the issues in dispute:—

(1) *Wages.*—The Court awards the following consolidated minimum rates for the undermentioned jobs:—

(2) *Leave Travelling Allowance.*—The Court awards a leave travelling allowance of Sh. 135 for those employees earning between Sh. 401 per month and Sh. 800 per month. This allowance to be payable on the conditions already agreed between the Parties.

(3) *Acting Allowance.*—The Court awards that an employee shall be entitled to the payment of acting allowance if he acts in his superior duties for a minimum period of 18 working days.

(4) *Maternity Leave.*—The Court awards that female employees shall be entitled to the benefit of sick leave under this issue to the extent of 15 days with full pay and 15 days on half pay only out of the current sick leave entitlement. Any leave in excess of 30 days shall be unpaid maternity leave:

Provided that the total maternity leave does not exceed 12 weeks.

(5) *Redundancy.*—The Court awards the following severance pay on redundancy:—

- (a) For employees with 1-5 years' service—10 days' pay for each year of service;
- (b) For years of service from 6 and onwards—14 days' pay for each year of service.

(6) *Date of Implementation.*—The Agreement between the Parties including this Award shall be with effect from 1st February 1966, and shall remain in force for a period of 12 months from that date.
