# THE WILD ANIMALS PROTECTION ACT (Cap. 376)

ESTABLISHMENT OF LAMBWE VALLEY GAME RESERVE

IN EXERCISE of the powers conferred by section 3 (2) of the Wild Animals Protection Act (Cap. 376), the Minister for Natural Resources, Wildlife and Tourism hereby declares the area of land in the South Nyanza District of Nyanza Province, described in the Schedule below, to be a game reserve.
