THE INDUSTRIAL COURT Cause No. 9 of 1966

Parties:

Kenya Union of Commercial Food and Allied Workers and

Distributive Employers' Association-Kisumu

Issue in Dispute:

Wages.

- 1. Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and Distributive Employers' Association, Kisumu shall hereinafter be referred to as the Respondents.
- 2. The parties were heard in Kisumu on 12th April 1966, and relied on their written and verbal submissions.

GENERAL BACKGROUND

3. On 16th January 1965, the then Kenya Distributive and Commercial Workers' Union reported the existence of a trade dispute to the Ministry of Labour with regard to 25 employers engaged in the wholesale and retail distributive business in Kisumu. The Permanent Secretary informed the Claimants that, as the employers were not organized, separate disputes with individual employers would have to be registered. However, with the help of the Federation of Kenya Employers the Respondents' Association was formed with approximately 60 members. The Association was registered in October 1965 as an Employers' Trade Union and joined the Federation of Kenya Employers on the 22nd October 1965.

Following Membership of the Federation of Kenya Employers a Negotiating Committee was formed and after various meetings a certain measure of agreement was reached between the Claimants and the Respondents. On 7th January 1966, the Claimants reported the existence of a trade dispute to the Minister of Labour on the following five items:-

- (a) wages
- (b) annual leave,
- (c) leave travel allowance,
- (d) severance pay, (e) maternity leave.

A conciliator was appointed and agreement was reached on all matters except wages. The parties decided to refer the dispute on wages to the Industrial Court in accordance with the Trade Disputes Act, 1965, the notification form having been signed on 17th February 1966.

MAIN SUBMISSION ON BEHALF OF THE CLAIMANTS

4. The Claimants submitted that, after the job classification had been agreed with the Respondents, agreement could not be reached on the various rates for these jobs due to the employers' extremely poor offers made during negotiation and conciliation. The Respondents had offered increase of Sh. 5, Sh. 7 and Sh. 10 for the various 20 odd jobs. The Claimants had demanded Sh. 50, Sh. 60 and Sh. 70 which, during negotiations, they had reduced to Sh. 40, Sh. 50 and Sh. 60.

They submitted that the Respondents' Association was composed of hardware merchants, grocers, a night watchmen's organization, butchers, flour millers, etc. All these firms were engaged in lucrative businesses and were making good profits. They were the counterpart in Kisumu of the D.A.T.A. Group in Nairobi. The Claimants drew the Court's attention to the Nairobi rates of D.A.T.A. which were established by the Court award and also cited other Court awards which, they claimed, established that the wages being paid by the Respondents in Kisumu were very much on the low side. They stated that the cost of living had considerably increased during the last three years and that there was no reason why employers engaged in the same business in Mombasa, Nairobi and Kisumu should be allowed to pay different rates. In these circumstances they requested the Court to award new rates of wages, which were exclusive of the statutory house allowance for Kisumu and which the Respondents had agreed to pay in addition to the rates which would eventually be settled between the parties, as follows:

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. The Respondents submitted that their Members were engaged in small family businesses and that the majority of them based their wages, at present, on the Wages Council Order for the Distributive Traders in Kisumu whilst others, particularly, those concerned with security or cinemas based their wages on a still lower scale—that of the General Minimum Wages Regulation Order. They submitted that Wages Council Orders were framed to deal with a particular type of employer who was a member of the Respondents' Association and that the Claimants should not be allowed to bring pressure on them with a view to enhancing these rates.

They drew the Court's attention to the fact that Kisumu had been through a period of depression and only in recent months had business commenced to improve. The Tanzania and Uganda trade restrictions on Kenya goods had affected business in Kisumu adversely. It was, therefore, with the greatest difficulty that the Kisumu merchants had been able to maintain their labour force and any undue increase in wage rates would only result in redundancies and a further increase in the serious problem of unemployment. The Respondents strongly refuted that their members were in competition with international companies. Finally, they submitted that their members should be compared with traders in Nairobi who operated in Grogan and River Roads. In these circumstances they requested the Court to make the following award:

- 6. In my report for the year 1963, in paragraph 7 of that report, I stated that the Authority in consultation with the Minister for Health and Housing had agreed to introduce a scheme to cover Voluntary Contributors to the Fund. The legislation to bring this Voluntary Scheme into operation was eventually shelved by your Ministry in view of the Government's decision to bring into being a National Health Scheme on a non-racial basis. In order to help finance the starting of the National Scheme, the Authority was instructed by your Ministry to contribute a sum of £55,309 from its funds. The amount of £55,309 represents part of the Authority's accumulated reserves. The amount is considered to represent the proportion of the total of the Authority's reserve funds which were originally contributed by the Government to the Fund in accordance with para. 13 of the Hospital Treatment Relief (European) Act (Cap. 249).
- 7. In paragraph 8 of my 1963 report reference was made to a change of the name of the Fund, this change has not taken place as it formed part of the proposed legislation referred to in paragraph 6 above, which was shelved by your Ministry for reasons already mentioned.
- 8. The Authority has set aside a sum of £55,309 which sum is available for payment to your Ministry as soon as this money is called for by your Ministry.
- 9. It was with great sorrow that due to the death of Mr. K. A. Jeremy we lost the services of a hardworking and loyal member of our Authority. Mr. Jeremy had served the Authority for many years and had been Chairman for a number of years. The vacancy caused by Mr. Jeremy's untimely passing has been filled by Mr. Ian R. Leslie.
