ORDER UNDER SECTION 36—COLLECTION OF TRADE UNION DUES

- (e) notify in writing the Registrar of Trade Unions before the end of each month of the amounts of any payments made into the accounts of that trade union and of that Federation in that month.

- (b) Annual Paid Leave.
- (c) Shift Differential.
- (d) Housing Allowance.
- (e) Leave Allowance.
- (f) Terms for Casual Labour.
- 1. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and The Pyrethrum Marketing Board and Pyrethrum Processing Company of Kenya Limited shall hereinafter be referred to as the Respondents.
- 2. The Parties were heard in Nairobi on the 13th day of December 1966, and relied on their written and verbal submissions.

GENERAL BACKGROUND

3. An agreement between the Parties regulating the wages and terms and conditions of service of the Respondents' employees was signed on 30th August 1965, with effect from 1st July 1965, with a provision that it remained in force for 12 months or until amended by mutual agreement for which one month's prior notice was required from either Party.

At present the wage structure of all unionizable employees is as follows:—

It was further provided as follows:--

"Employees whose present wage or salary is more than the basic minimum rate shown above for their respective grades shall receive the same increase which shall be the difference between the new minimum basic scale and the old minimum scale for their respective grades. Any employee who is permanently or temporarily engaged will be paid not less than the appropriate rate for the grade into which his/her job is classified."

On 27th June 1966, the Claimants forwarded to the Respondents the workers' demands on various items and a Negotiating Committee meeting was convened on 5th August 1966, when all these demands were discussed and the Respondents made counter proposals. The Respondents made the following offers:—

On annual paid leave, leave allowance and shift differential the Respondents proposed no adjustments to the existing arrangement. On housing allowance the Respondents offered Sh. 40 per month. On the question of casual labour, the Respondents stated that they were prepared to pay the official Government rates only to such employees. After this meeting letters were exchanged between the Parties but they could not resolve their differences. Eventually on 19th September, the Claimants threatened strike action unless settlement could be reached within 14 days. On 22nd September 1966, the Respondents reported the existence of a dispute to the Permanent Secretary, Ministry of Labour. The dispute was accepted and the Tripartite Committee recommended its reference to the Industrial Court. The Claimants were very critical of the dispute being referred to the Industrial Court without any reference to conciliation. They stated that, this was indicative of the employers' attitude generally these days that they wanted to rush to the Industrial Court thus by-passing all the other

machinery available for the settlement of disputes. The Respondents, however, rejected this criticism and pointed out that, the Claimants in particular, invariably brought their disputes to the Industrial Court as was evident from the number of cases in which they had appeared before the Industrial Court this year.

The Parties had signed the notification of dispute form to the Industrial Court on 2nd November 1966, on the aforesaid six issues

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. (a) Wages.—The Claimants submitted that, pyrethrum industry was doing extremely well and, in fact, 60 per cent of the world supply was provided by Kenya. The Claimants handed to the Court the Annual Reports of the Pyrethrum Marketing Board of Kenya for the years 1962-63, 1963-64 and 1964-65 in support of their contention that the Respondents possessed the necessary financial ability to meet with their demands. The Claimants also requested the Court to go through paragraphs 137 to 140 of the Development Plan to ascertain and confirm the extremely healthy position which the pyrethrum industry enjoyed.

The Claimants stated that, although the grades had been established last year and their rates had been agreed, these rates did not represent a fair scale and were meant to be a start only and they had hoped to increase them every year until a fair rate was established.

The Claimants submitted that, they had originally demanded the following rates for the various grades but during conciliation in a spirit of compromise, they had amended and reduced these figures as follows:—

The Claimants found the attitude of the Respondents towards the workers' demands as being extremely discouraging which was due to the fact that, they had approached the negotiations with a fixed mind of making a certain offer and sticking to it.

The Claimants submitted that a wage increase was completely unavoidable for the following reasons:—

- (a) The workers had been expecting a higher standard of living as they had been exploited during colonial times through getting starvation wages.
- (b) With the achievement of political independence, the workers desired to enjoy better terms of service and conditions of life. The African workers had been denied reasonable wages because of the discriminatory practices during colonial times.
- (c) The cost of living had gone up considerably in the country during the last few years and the price of commodities had nearly doubled since 1964. It was, therefore, illogical for employers to expect their workers to meet their basic human requirements on the wages which had not been revised accordingly.
- (d) The Claimants were committed to encourage their members to work hard and to improve the productivity of the industry in which they were working; but increased production should go hand in hand with increased wages and the workers should have the means of satisfying their reasonable wants.

The Claimants gave details of various items which they considered were essential for a worker and which cost a sum of Sh. 354/95 for a single person and Sh. 744/90 for two people. The Claimants argued that the wages which should be paid to workers should be high enough for a worker to be able to get sufficient food, decent clothing, reasonable housing facilities and to make provision for security during old age or when the worker lost his job. The Claimants stated that, school fees and taxes had gone up tremendously whereas the wages had remained at the old level.

The Claimants drew the Court's attention to increases in salaries which had been granted to the Executive and Junior Management Staff and argued that, if these persons could get increments ranging from Sh. 50 to Sh. 150 and shift differential allowance between Sh. 100 and Sh. 500 and a house allowance between Sh. 150 and Sh. 200, there was no reason why their demands should not be met by the Respondents. The Claimants criticized the Respondents' action in declaring their employees redundant over the past few years and stated that, in 1962-63 they used to employ about 450 workers and now had only 231. The Claimants commented that, this was a manoeuvre on the part of the Respondents to frighten the workers and discourage them from joining the Claimants' Union.

The Claimants requested the Court to make an award as demanded by them with a proviso that, the increase so awarded, should be granted to all employees on their present salaries.

- (b) Annual Paid Leave.—The Claimants had demanded:-
- (a) An employee who had completed one year or more but less than four years' continuous service with the Respondents should be entitled to 21 working days' paid leave after the completion of every 12 months' continuous service.
- (b) An employee who had completed four or more years' service with the Respondents should be entitled to 28 working days' paid annual leave after the completion of every 12 months' continuous service.
- (c) In the event of Gazetted Public Holidays falling within the leave period such public holidays should be added to the leave entitlement.
- (d) Employees discharged by the Respondents after six months' continuous service with them should be entitled to payment in lieu of half the annual leave.

The Claimants argued that the Respondents were financially in a position to meet the aforesaid modifications suggested by them which were extremely reasonable and fair.

(c) Shift Differential.—The Claimants demanded that in addition to basic wages/salaries employees working as a team on a 24-hour shift cycle should be paid a shift differential of Sh. 100 per month to compensate them for the inconvenience involved in performing shift work and further submitted that, on gazetted public holidays if these employees were required to work, then they should earn overtime at the agreed rate. They stated that the present entitlement of Sh. 31 was grossly inadequate for the inconvenience involved.

- (d) Housing Allowance.—The Claimants submitted that, an employee could not secure decent accommodation at the present housing allowance of Sh. 35 per month and would not be able to do so even if it were increased to Sh. 40. They had, therefore, demanded a house allowance of Sh. 150 for all employees so that they could secure suitable and reasonable accommodation in which to live. The Claimants stated that, the figures which the Respondents had produced regarding the Nakuru Municipal housing, which showed monthly rents from Sh. 15 to Sh. 32/50, were in respect of houses made of mud and mud plaster; rents for stone houses ranged from Sh. 40/50 to Sh. 92/50.
- (e) Leave Allowance.—The Claimants demanded that an employee proceeding on authorized annual leave should be paid the following allowance:-

Sh. (a) From Grade 4 to Grade 1 100 (b) From Grade A 1 to Grade 5

The Claimants stated that their demands were reasonable and

the Respondents could afford them.

- (f) Terms for Casual Labour.—The Claimants stated that in accordance with clause 1 and clause 15 (ii) of the agreement dated 15th August 1965, they were entitled to represent the These two clauses provided as follows: casual workers.
 - "1. The terms and conditions set out in this Memorandum of Agreement shall be observed and implemented by the Board referred to above, and shall apply to all employees regardless of sex covered by the definition given by the Union's registered constitution, and as provided by the Memorandum of Agreement relative to Recognition and Negotiating Procedure.
 - 15. (ii) The Board agrees that casual labour will normally only be employed on casual work of a short-term or seasonal nature and for a maximum period of three months' service. In the event of national disaster, an emergency or abnormal seasonal fluctuations, the Board will consult with Union and discuss with the Union should it be necessary, to employ casual labour for a period in excess of three months."

The Claimants pointed out that, these casual workers should get the rate for the job which they do, such rate being the one which the Claimants had negotiated with the Respondents. Claimants stated that they would not accept the Respondents' stand of paying the statutory minimum to the casual workers and had demanded that they should be paid Sh. 15 per day as they were not entitled to any privileges granted to permanent employees. The Claimants also drew the Court's attention to the fact that, these casual workers were employed by the Respondents for a period of three months and were then discharged, after which they were immediately re-engaged. The Claimants submitted that, this was an unfair practice and the Respondents should employ these workers on monthly terms.

General.—The Claimants strongly resisted an attempt by the Respondents to get a ruling from the Court on the question of the duration of the Court's award and stated that, they would not be prepared to accept a ruling from the Court on

any matter which was not an issue before it. They stated that, as far as they were concerned, the effective date and duration had been agreed between the Parties and the Court should not try to interfere on matters on which the Parties had reached agreement.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. (a) Wages.—The Respondents stated that, under the provisions of the Pyrethrum Act 1964, which came into operation on 15th September 1964, two new Boards namely the Pyrethrum Board of Kenya and the Pyrethrum Marketing Board were established. The present position of these two organizations was very fairly summed up in the Annual Report of the two Boards published in Nakuru in January 1966. The Chairman of the Pyrethrum Board of Kenya, Mr. I. Kuria, and the Chairman of the Pyrethrum Marketing Board, Mr. G. L. Bellhouse, said in their joint statement: "The prospects for the future, with certain reservations, are good. Although the Kenya industry has by its own efforts and favourable circumstances, rehabilitated itself over the last two years, it is imperative that the constantly repeated aims of maintenance and high quality of production as stressed by the Boards, be achieved. Sales prospects continue good, but competition both in the production and marketing fields is increasing and must be met if Kenya is to retain its dominant position. Kenya has the great advantages of established growing and processing facilities with the potential and experience to respond rapidly to calls for increased producing; these assets may well need to be exploited to the full in the future and it is essential that the Boards receive the full support of growers in their efforts."

The Respondents stated that there were 40,000 pyrethrum growers out of which about 35,000 were African growers and that they were interested in increasing the return to the growers. They pointed out that 99.9 per cent of their production was exported and was exported in the face of competition from Ecuador, Tanzania, New Guinea, Ruanda and the Congo, all of whom were striving to increase their share of the world market. In addition to this, there was the existence of a new compound being developed in the United Kingdom which would offer a synthetic alternative and also synthetic pyrethrum powder produced in Japan. The Respondents stated that, they functioned as a co-operative and no profits were retained. This meant that they must absorb all internal cost increases and in so doing must reduce the price paid to the grower.

It was, in these circumstances, that the Respondents considered the Claimants' demands for a revision of the terms and conditions of service applicable to the 231 employees jointly employed by the two organizations. The Respondents stated that their offers on the wages were on the condition that, the increases were intended to include an element involving the discontinuation of tea breaks and the issue of uji. The Respondents would, however, continue to provide tea but this would be consumed on the job. This had come about in view of the abuse of the facilities and subsequent loss of productivity.

The Respondents stated that the Claimants had accepted the evaluation of the jobs by the point rating system and must, therefore, be deemed a party to the establishment of the rate for the job policy. The Respondents, therefore, strongly resisted the Claimants' demands that, whatever wage increases were offered to the various grades, should be applied to all employees irrespective of their current wage status.

The Respondents drew the Court's attention to para. 139 of the Development Plan and stated that, the Court should examine carefully that the incentive to production is the increased producer price. The Respondents also requested the Court to go through para. 193 in which was reflected the Government's thinking on the value to Kenya of co-operative movement.

The Respondents submitted that the Court should decide to what extent the job evaluation completed in September 1965, in agreement with the Claimants, produced unrealistic rates for the various grades and stated that these rates reflected a fair remuneration to the employees engaged in the various jobs.

The Respondents rejected the Claimants' arguments that the Executive and Junior Management staff had received big increases and pointed out that, the benefits being enjoyed by these persons had been constant due to the contractual obliga-tions. The Respondents had, however, granted merit increases to some of the Management staff, but these increases were not uniform as suggested by the Claimants. The Respondents stated that out of 40 Executives and Junior Management staff, 18 were Africans.

The Respondents stated that their offers were generous and increase in the cost of living had been taken into account when these offers were made. In view of this the Respondents requested the Court to accept their offer and award accordingly.

The Respondents also challenged the costings of the Claimants' table on foodstuffs and stated that, the information supplied therein was not correct and produced a counter document giving the actual prices.

(b) Annual Paid Leave.—The Respondents stated that the present provision read as follows:-

"For employees with less than four years' service, three weeks (21 calendar days) after completion of each 12 months'

For employees with four years' service and over, four weeks (28 calendar days) after completion of each 12 months'

Gazetted public holidays falling within the leave period were added to the entitlement. Employees who were discharged and had completed six months' continuous service were granted half the annual leave. The Claimants had sought to change these two figures in both instances to working days which could mean an increase of four to five days' paid absence per annum. This approach had been rejected from the outset by the Respondents as they maintained that, the present provision was

- (c) Shift Differential.—The Respondents submitted that the present entitlement under this heading of Sh. 31 per month was as high as the one the Claimants had negotiated with the other employers like the British Standard Portland Cement Company Limited, Mombasa. The Respondents, therefore, could not accede to the Claimants' demand that this be increased to Sh. 100 and requested the Court to reject it.
- (d) Housing Allowance.—The Respondents stated that, the present practice was to grant employees who were not housed free by them an allowance of Sh. 35 per month in face of the situation that under the statutory minimum wage regulations the Government minimum housing allowance for Nakuru was

The Respondents stated that, during the course of negotiations, they had offered to improve this present allowance by 15 per cent to take into account the increased cost of Nakuru municipal housing and, therefore, their offer stood at Sh. 40 per month. The Respondents stated that the rents for Nakuru municipal houses were Sh. 15, Sh. 30, Sh. 32/50, and Sh. 40/50 going up to Sh. 92/50. In these circumstances they maintained that their offer should be accepted by the Court.

(e) Leave Allowance.-The Respondents stated that presently they granted to employees allowances on the following basis:-

In addition to this leave allowance, the Respondents granted a leave bonus (not negotiable with the Claimants) paid on gratuitous basis as follows:

Employees with 3 to 4 years' service a bonus of 25 per cent of month's wages.

Employees with 5 to 6 years' service a bonus of 50 per cent of month's wages.

Employees with 7 to 8 years' service a bonus of 75 per cent of month's wages.

Employees with 9 years' service and over a bonus of 100 per cent of month's wages.

The Respondents stated that as the Claimants' demands involved an increase of 233 per cent over the existing rates they had rejected them. In any case the Respondents submitted that the present entitlement was in line with the current level in the country.

(f) Terms for Casual Labour.—The Respondents stated that, the official rate for the casual labour under the Minimum Wage Legislation was equivalent to Sh. 5/20 per day, but in practice the Respondents paid such employees Sh. 5/40 per day. The Respondents rejected the allegation that they employed casual labourers for three months and then after discharging them reengaged them and stated that, these employees at the most were engaged for about six weeks during the flush period and were paid on weekly basis. The Respondents submitted that their current practice was fair.

General.—The Respondents requested the Court to consider sympathetically their plea for giving a ruling on the duration of the Court's award. They pointed out that the Claimants had objected to the inclusion of the "effective date and duration" and had proposed as a bargain that the Respondents should delete these two items and the Claimants for their part, would agree to the deletion of job grading. The Respondents conceded that there was a certain merit in the deletion of the effective date as it was recorded that the effective date would be 1st August 1966, but pointed out that, duration period had not been resolved and must, therefore, remain a contentious issue if the Court was precluded from ruling on it. The Respondents submitted that the Claimants had argued that, it was customary for the two Parties to negotiate on an annual basis, but equally the Respondents were entitled to counter that agreements of 12 months' duration were "with the sub-stantial period of back-dating" in this day and age of economic progress inimical to the interests of employers and employees in Kenya and policy today was for the duration period to be of greater length than the customary 12 months. The Respondents requested the Court to specify the duration period of the Court's award.

AWARD

6. The Court has very carefully considered the various submissions made by both Parties. On the question of laying down the duration period of the Court's award, the Court although sympathizing with the Respondents, unfortunately cannot go beyond the issues which the Parties have submitted for adjudication by the Court. In these circumstances the for adjudication by the Court. In these circumstances the Court rejects the Respondents' plea for fixing the duration period of its award. On the other issues the Court's award is as follows:

(a) Wages.-The Court awards the following new rates for the various grades:

The Claimants' plea for granting an increase to all employees on their present wages is rejected.

The employees shall continue to enjoy the existing privileges granted to them like the issue of uji.

- (b) Annual Paid Leave .- Nil award.
- (c) Shift Differential.-Nil award
- (d) Housing Allowance.—The Court awards a housing allowance of Sh. 50 per month for employees in Grade AI and AII that is, those in receipt of Sh. 450 per month and over. Other employees shall get a house allowance of Sh. 40 per month.
 - (e) Leave Allowance.-Nil award.

- 1. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and African Diatomite Industries Limited shall hereinafter be referred to as the Respondents.
- 2. The Parties were heard in Nairobi on the 16th day of December 1966, and relied on their written and verbal submissions.

GENERAL BACKGROUND

3. In Cause No. 16 of 1964 between the Claimants and the East African Diatomite Syndicate Limited gratuity being an issue in dispute, the Court made the following award:—

"The Court while sympathizing with the demands of the Claimant is constrained in view of the aforesaid delicate situation of the Respondent to make a NIL award in this dispute. The Parties may, however, at the end of 12 months from the date hereof commence negotiations on the fresh terms and conditions of service."

In or about the middle of 1965 the Respondents were incorporated, and took over the business formerly carried on by the East African Diatomite Syndicate Limited on the 1st of August 1965. The Claimants had submitted various demands, Adjust 1903. The Claimants had submitted various demands, including the issue in dispute, to the East African Diatomite Syndicate Limited on 30th May 1965, but discussions on these demands took place with the Respondents on 13th October 1966. Agreement was reached on all items except gratuity payment for past services on which deadlock was recorded. The Parties decided to refer it to the Industrial Court and signed the notification of dispute form to the Industrial Court signed the notification of dispute form to the Industrial Court on 1st November 1966.

MAIN SUBMISSIONS ON BEHALF OF THE CLAIMANTS

4. The Claimants submitted that they considered this to be a very important dispute as the security of the workers was at stake. They pointed out that they had raised this issue as far back as 1962 and in pursuance of the Court award in Cause No. 16 of 1964 they had raised it again after a period of 12 months, but due to the delaying tactics employed by the East African Diatomite Syndicate Limited and their successors the Respondents, the matter could not be discussed until October 1966. The Claimants stated that some of the workers had been in service since 1951 and it would be extremely unfair if they were deprived of a benefit like gratuity for all these years of service up to the commencement of the National Social Security

The Claimants maintained that the Respondents were not a new concern and, in fact, the Directors of the Respondents were the same as those of East African Diatomite Syndicate The Claimants had made the following demands in respect of gratuity:-

- (a) On completion of one year of service up to five years, an employee of the Respondents should be entitled to gratuity payment of one month's pay for each completed
- (b) an employee who had completed five years' service and over but less than 11 years, should be paid a gratuity of 13 months' pay for each completed year of service;
- (c) an employee who had completed 11 years' service and over with the Respondents should be paid a gratuity of two months' pay for each completed year of service and that all gratuity payments should be made at the employee's basic rate of pay in the final month of such service.

The Claimants argued that the Respondents were responsible for rewarding employees for past services rendered to East African Diatomite Syndicate Limited for the following

- (a) That the present Management had been honouring the Recognition Agreement and had continued to pay the wage rates agreed with the former Management without raising any objection.
- (b) That when the Respondents took over the Management they did not advise the employees concerned that they would not recognize their past services to East African Diatomite Syndicate Limited, on the contrary when the employees had raised the matter with the present General Manager in 1965 at factory level, he had requested them to be patient and not to worry as the matter would be discussed jointly with the Claimants.
- (c) That the Respondents failed to advise the Claimants that they were taking over East African Diatomite Syndicate Limited, nor did they inform the Claimants that they were stepping in as a new entity and would not be responsible for employees' past services in spite of the fact that, they were aware that the issue of gratuity was in dispute.

The Claimants pointed out that the Industrial Development Corporation who were the major shareholders in the Respondents' concern had also controlled the East African Diatomite Syndicate Limited. Finally the Claimants stated that the Respondents had offered to pay gratuity to all workers as from 1st August 1965, but the Claimants could not accept this.

In these circumstances the Claimants requested the Court to order gratuity payment for all workers to be paid by the Respondents, even though prior to 1st August 1965, they were technically employed by East African Diatomite Syndicate Limited.

MAIN SUBMISSIONS ON BEHALF OF THE RESPONDENTS

5. The Respondents denied that the people originally interested in the previous employer company had any interest in the Respondents' concern and stated that they were an entirely separate legal entity from the said East African Diatomite Syndicate Limited. When the Respondents took over the business, members of the Board of Directors had explained to the employees what had happened and had granted a 10 per cent increase to all employees in their wages. The Respondents further stated that since they took over the business, they had maintained the number of employees despite their serious financial position due to the inability to find markets for their products because of the Government policy with regard to trade with the Republic of South Africa and Portuguese East Africa. The Respondents pointed out that despite this financial situation, a further increase of Sh. 25 was agreed with the Claimants to be granted to all employees as from 1st August

The Respondents submitted that they very strongly resisted the Claimants' proposals for the following reasons:

- (a) Due to their serious financial position they were quite unable to make the proposed payment.
- (b) The Respondents considered that it was unreasonable even if finance were available to require them to make payments in effect for services rendered to the Company from whom the Respondents had acquired the business.

The Respondents requested the Court to seriously consider their extremely difficult financial position in the first 11 months of operation. The Respondents had made a loss of just under Sh. 248,000 and total liabilities at the end of June 1966, amounted to just under Sh. 1,000,000. Their assets at the same date amounted to a little over Sh. 700,000. The Respondents pointed out that, these were approximate figures as the accounts to the 30th of June 1966, had not been finalized. They further submitted that the position since 30th June 1966, had not improved. In these circumstances the Respondents contended that they had been more than generous in granting contended that, they had been more than generous in granting contended that, they had been more than generous in granting the increases in wages as aforesaid and it was clear that they could not afford to set aside a sum of £4,000 to meet the Claimants' demands under gratuity. The Respondents submitted that, it was apparent that their position was no better than the position of their predecessors the East African Diatomite Syndicate Limited at the time of the nil award given by the Industrial Court in May 1065. Industrial Court in May 1965.

The Respondents accepted their responsibility for paying gratuity for services rendered as from 1st August 1965, and stated that they would be prepared to make such a payment. They pointed out that as from 1st November 1966, they had started contributing to the National Social Security Fund on the National Social Security Fund on behalf of the workers. In these circumstances they requested the Court not to penalize them in respect of services rendered by employees to East African Diatomite Syndicate Limited.

6. After hearing the submissions made by the Parties the Court is satisfied that the financial position of the Respondents does not permit an award on the issue in dispute. Furthermore the Respondents cannot be expected to grant any benefits for services rendered by the workers as employees of the East African Diatomite Syndicate Limited. In any case this Company as well, was not in a happy financial position and if it were possible, which it is not, the Court would not have made

In these circumstances the Court has no other option but to make an award on the lines indicated by the Respondents themselves and the Court, therefore, awards that all those employees who have completed one year of service from 1st August 1965, will be entitled to 15 days' pay by way of
