## THE INDUSTRIAL COURT

CAUSE No. 77 OF 1966

## Parties:

Kenya Petroleum Oil Workers' Union

and

Oil Industry of Kenya

## AWARD

In this dispute in addition to the three issues of Job Classification, Union Level of Representation and Increases on Wages and Salaries, the Parties had included a fourth issue, namely Revision of Terms and Conditions of Service. This issue involved going through each and every clause of the comprehensive agreement that exists between the Parties and is divided into seven parts. All the fringe benefits on which negotiations have been concluded in the past are included in this agreement. It is evident that both Parties have attempted to change practically all the existing clauses. As a result the Parties submitted memoranda running into hundreds of pages inclusive of various appendices. This has involved the Court in an extremely laborious and time-consuming exercise, as at times some very unnecessary changes are being sought, on some other items completely unrealistic demands have been made, yet on some others attempt has been made to reduce the benefits which the Claimants have won over the past years for their members. This attitude is highly reprehensible as the Parties ought to realize the futility of making unrealistic demands and of being able to persuade the Court, in the absence of some very special circumstances, of modifying in some cases the Court's own awards.

As it is, the Court was presented with a very comprehensive agreement which had expired with a new draft prepared by the Respondents in which some of the old clauses have been deleted, some have been simplified and some have been modified in accordance with their demands. The Claimants, on the other hand, submitted their version of what the new agreement should look like, reflecting their demands on practically every important item in the fringe benefits.

With this background the Court was left with no alternative but to peruse most carefully all the three agreements lest some worthwhile points made by either Party were overlooked. The Court would like to make it clear to the Parties that it is not the function of the Court to either draw up comprehensive agreements for the Parties or to go through the drafts prepared by the Parties and to approve or disapprove the same. The Court's proper function is to adjudicate on the important and fundamental points at issue; after that, it is up to the Parties to draw up the agreements incorporating all such decisions.

In view of the foregoing, and keeping in view the space that would be taken up when the award is published in the Kenya Gazette, the existing agreement has not been reproduced in this award. Further, if any points made by the Parties do not appear in this award, then it should be considered that the Court did not find them worthwhile mentioning.

It is hoped that in future the Parties will take notice of the remarks made by the Court as such practice ought not to be encouraged.

The Court has taken into consideration the various submissions made by both Parties and the evidence tendered in support thereof in making its findings.

(a) *Job Classification.*—The Court is satisfied that no case has been made out for a major revision to be carried out in job classifications just now. The few instances cited by the Claimants should be processed through the existing machinery. It should be noted that the Claimants did not give even one instance where this machinery had been used; therefore, it is too early to decide whether or not the present machinery is suitable.

The Court, however, feels in view of the number of workers who have been laid off progressively since 1962 when the original job classification was carried out that there might well be a case for a general revision of job classification to be carried out by

the Respondents in consultations with the Claimants. The proper time to do so would appear to be some time in 1969 before the next revision of the agreement.

(b) *Union Level of Representation.*—The Court awards that the case of approximately 200-odd employees who are at present not unionizable should be gone into by both Parties in consultation with F.K.E./C.O.T.U. after the latter have revised and agreed upon the definitions of various categories of non-unionizable employees.

(c) *Increases on Salaries/Wages.*—The Court has decided to reject the plea of the Respondents for consolidation of housing allowance and subsidy both for the operative and staff employees into the wages/salaries. In the absence of a clear directive from the Government on whether or not the policy of a clean wage should be followed, the Court does not deem it wise to give a decision just now on such an important issue.

The Court awards the following wage increases:—

(i) The various basic grades for the operative employees are increased by Sh. 15/68 per month.

(ii) The individual salaries of unionizable staff employees are increased by Sh. 15/88 per month.

(iii) The Court makes a nil award on the claim for increasing the minimum salaries of unionizable staff employees.

(d) *Revision of Terms and Conditions of Service.*—Under this issue it should be clearly understood that, where no specific reference is made to any existing clause, then such clause shall continue in force.

The Court rules that the distinction which exists at present between the operative and staff employees should continue.

## PART I—CLAUSES APPLICABLE TO BOTH UNIONIZABLE STAFF AND ALL OPERATIVE EMPLOYEES IN THE OIL INDUSTRY

*Duration of Agreement.*—The Court awards that this agreement shall remain in force for a period of three years with a wage/salary reopener clause after 18 months. The effective date as has been agreed between the Parties will be 1st November 1966.

*Sickness.*—The Court awards that the following paragraph should be added to the existing clause:—

"In addition staff employees who are members of the Subsidized Medical Insurance Schemes have the option of treatment by the doctor of their own choice within the limits of the insurance schemes."

*Grievance Procedure.*—The Court awards the following Stage V and the Note to the existing four stages:—

"Stage V.—If any matter has not been resolved on completion of the foregoing procedure, the grievance will be referred to the Grievance Committee of the Joint Industrial Council. This committee will consist of the Oil Industries Joint Secretary, the spokesman and a representative of the company involved. The Union will be represented by the Union's Joint Secretary, the General Secretary and/or his nominee and a Union representative from the company involved. All decisions of the Grievance Committee will be by mutual agreement. A request for a meeting of the Joint Industrial Council Grievance Committee will be forwarded in writing to the Joint Secretaries within 14 days of the receipt of the decision at Stage IV, the two Joint Secretaries will arrange the meeting of the Grievance Committee within seven working days after receipt of the relevant communication.

*Note.*—Matters affecting a group of workers within a branch or depot will normally be taken up at Stage II.

Both parties recognizing the importance of voluntary settlement of disputes in the interest of good industrial relations agree that no dispute shall be reported to the Ministry of Labour, the Industrial Court or other outside parties until the above grievance procedure has been exhausted. If a dispute is not settled after above grievance procedure has been followed, it will be dealt with in accordance with the Trade Disputes Act of 1965."

**PART II—CLAUSES APPLICABLE TO OPERATIVE EMPLOYEES OF THE MARKETING COMPANIES ONLY**

**Shift Differential.**—The Court awards that the shift differential be increased from Sh. 30 to Sh. 35 per month. All the other conditions shall remain as before.

**Meal Allowance/Safari Allowance.**—The Court awards that these two allowances should be amalgamated into Meal and Lodging Allowances and awards as follows:—

“Also applies to *East African Oil Refineries Ltd.* and *BP Shell Petroleum Development Company of Kenya Ltd.*”

When a staff or an operative employee is required by the Companies to work outside his normal working area for any period between 6 a.m. and 8 p.m. which includes a normal meal time or meal times, or to spend a night away from his base on Company duty, he will be paid the appropriate allowance(s) as listed below:—

**PART III—CLAUSES APPLICABLE TO STAFF EMPLOYEES OF THE MARKETING COMPANIES ONLY**

**Acting Appointment.**—The Court awards as follows:—

“Also applies to *East African Oil Refineries Ltd.* and *BP Shell Petroleum Development Company of Kenya Ltd.*”

Where an employee is required to act in a position of a higher category for a period of not less than 10 working days he will be entitled to be paid for the period so worked at not less than the minimum agreed for that category. If the acting appointment falls outside Union representation an acting payment of Sh. 10 inclusive per working day will be made.”

**Meal Allowance and Safari Allowance.**—The Court awards as mentioned hereinabove in Part II.

**Shift Differential.**—The Court awards a shift differential of Sh. 35 per month to employees employed on regular shift work.

**PART IVA—CLAUSES APPLICABLE TO OPERATIVE EMPLOYEES OF BP SHELL PETROLEUM DEVELOPMENT COMPANY OF KENYA LTD. (OTHER THAN SEA-GOING PERSONNEL)**

**Shift Differential.**—The Court awards that the existing figure of Sh. 41/6 cents per month be increased to Sh. 47 per month. All the other conditions to remain as before.

**Travel Allowance.**—The Court awards as mentioned hereinabove under Meal and Lodging Allowances.

**PART IVB—CLAUSES APPLICABLE TO STAFF EMPLOYEES OF BP SHELL PETROLEUM DEVELOPMENT COMPANY OF KENYA LIMITED (OTHER THAN SEA-GOING PERSONNEL)**

**Travelling Allowance.**—The Court awards same as above under Meal and Lodging Allowances.

**PART VA—CLAUSES APPLICABLE TO OPERATIVE EMPLOYEES OF EAST AFRICAN OIL REFINERIES LTD.**

**Work in a Higher Grade.**—The Court awards the same clause as hereinabove in Part III under Acting Appointment.

**Shift Differential.**—The Court awards the following new clause:—

“In addition to basic pay, employees working a regular shift will be paid a “shift differential” to compensate them for the inconvenience involved in performing shift work. These shift differentials will not be included in the basic pay and, accordingly, will not be taken into account when calculating Provident/Pension Fund contributions and overtime pay. As it is intended to compensate the individual for the inconvenience incurred in shift work, the shift differential will not be paid when the employee is absent from work through being sick, on leave, or for any other reason.

Rates of shift differential are:—

3-shift cycle—15 cents per hour (Sh. 35 per month).

2-shift cycle—7½ cents per hour (Sh. 17/50 per month).”

**Job Progression for Operatives.**—The Court rejects the Claimants' demand on this issue and awards as follows:—

**I. REFINERY OPERATORS**

1. The normal entry point for this stream will be as a Trainee Assistant Refinery Operator in Grade 9.

2. After three months' satisfactory service the employee will be promoted to Assistant Refinery Operator III in Grade 8, and after a further three months' satisfactory service to Assistant Refinery Operator II in Grade 6. At the end of another six months' satisfactory service he will be promoted to Assistant Refinery Operator I in Grade 5.

3. Promotion to the next higher level of Refinery Operator II in Grade 4 will be subject to vacancies. He will then be assuming jobs of greater responsibility in charge of a unit/group of facilities and may be required to supervise one or more Assistant Operators.

4. After two years' satisfactory service, and with the added experience gained during this time, the employee will be classified as a Refinery Operator I in Grade 3.

5. Promotion to this point will be into the staff stream and will be subject to vacancies.

**II. REFINERY CRAFTSMEN**

1. Entry to this stream will be subject to trade test and/or the possession of trade certificates considered satisfactory by E.A.O.R. The normal entry point will be as a Trainee Refinery Craftsman in Grade 6.

2. The following will be the progression after entry:—

Promotion to:—

(a) Refinery Craftsman III in Grade 5 after one year as a Trainee Refinery Craftsman plus passing Grade 5 E.A.O.R. trade test.

(b) Refinery Craftsman II in Grade 3 after two years as a Refinery Craftsman III plus Grade 3 E.A.O.R. trade test.

(c) Refinery Craftsman I in Grade 2 after one year as Refinery Craftsman II plus passing Grade 2 E.A.O.R. trade test.

3. Promotion to Leading Refinery Craftsman in Grade I will be subject to vacancies.

**III. LABORATORY TESTERS/TECHNICIANS**

1. The normal entry point for this stream will be as a Trainee Laboratory Tester in Grade 6.

2. The following will be the progression after entry:—

Promotion as:—

(a) Laboratory Tester II in Grade 4 after two years as Trainee Laboratory Tester plus passing E.A.O.R. Grade 4 test.

(b) Laboratory Tester I in Grade 3 after two years as Laboratory Tester II plus passing E.A.O.R. Grade 3 test.

3. Promotion to the next higher level of Laboratory Technician II in Category III will be subject to vacancies and the passing of E.A.O.R. Category III test. At this point the employee may be required to assume duties which involve supervisory functions in addition to the added responsibilities of the job.

After two years' satisfactory service as a Laboratory Technician II plus passing E.A.O.R. Category IV test, the employee will be promoted to Laboratory Technician I in Category IV.”

**Shift Differential.**—The Court awards that those employees employed on regular shift work should get the same shift differential as the operatives.

The Court rejects the Claimants' demands for the following new additional items:—

- (1) Dismissal.
- (2) Social Services, Recreational Facilities.
- (3) Transport.
- (4) Canteens.
- (5) Loans.
- (6) Medical.
- (7) Time Off with Pay.
- (8) Depot Operations.
- (9) Bulk Lorry Transport.
- (10) Contracting of Jobs.
- (11) Police, Arrest and Detention.
- (12) Dirt, Height, Heat Allowance.

Except for the amendments that may be necessary on account of the award made hereinabove, the Court rules that all the existing clauses shall continue as before.

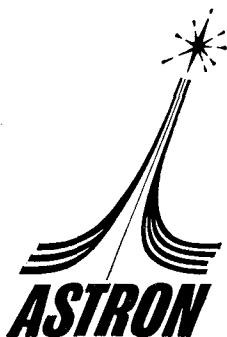
