Senior Internal Auditor (Head of Audit Unit), Ministry of Education (No. 101/67)

Salary scale.—£1,390 to £1,598. PENSIONABLE

Applicants must be civil servants of maturity with not less than five years' experience in a responsible position demanding extensive knowledge of audit and accountancy work. They should have passed the final examination of a recognized professional accounting body but applicants who have passed the intermediate examination of a recognized professional accounting body and who have had several years' experience of the Education Grant-in-Aid Rules related to the maintained and assisted schools may be considered. The successful candidate will be required, besides performing audit duties, to give advice and guidance to Headmasters/Principals of Boards of Governors Institutions and Provincial Education Officers on the preparation and submission of estimates and the introduction of a uniformed system of accounting at education institutions. He will be posted initially to the Headquarters in Nairobi, and will be required to travel extensively throughout Kenya, but may at a later date be posted to a Provincial Office.

Senior Executive Officer, Department of Veterinary Services (No. 102/67)

Salary scale.-£1,390 to £1,598. PENSIONABLE.

Applicants must be civil servants with a thorough knowledge of financial control, administration and personnel work, and experience of such work at a level not below Executive Officer Grade II. Duties include preparation of revenue and expenditure estimates, responsibility for all staff housing, the vehicle pool and the Brand Register at the Veterinary Department, Kabete. The successful candidate may be called upon to assist in preparing schemes to attract financial aid from outside sources.

Lecturer, Department of Co-operative Training, Kenya Institute of Administration (No. 103/67)

Salary scale.—£1,390 to £1,598 or £1,096 to £1,348, dependent on qualification. PENSIONABLE or AGREEMENT.

Applicants should possess a degree of an approved university or an appropriate professional qualification. In addition, experience of the management and supervision of co-operative societies is essential. Teaching experience would be an advantage. The successful candidate will be required to plan and conduct courses as well as to teach the following subjects: Management and Administration of Co-operative Societies, Co-operative Law and Principles and Economics.

Phamacist (Three Posts), Ministry of Health (No. 104/67) Salary scale.—£1,096 to £1,348. PENSIONABLE or AGREE-MENT.

Applicants must be registered or registerable in Kenya in accordance with the Pharmacy and Poisons Act, 1956. Duties include medical storekeeping, hospital pharmacy and the training of dispensers. Posting may be made to any Government hospital in Kenya.

Senior Vehicle Inspector (Supernumerary) (Road Transport Branch), Ministry of Power and Communications (No. 105/67)

Salary scale.—£850 to £1,060. PENSIONABLE or AGREE-MENT.

Applicants must be persons of maturity who are of Cambridge School Certificate standard of education. They must have served a recognized apprenticeship in motor engineering and thereafter have had five years subsequent experience in a vehicle workshop; part of which should have been in a responsible position. Possession of a National Certificate in Motor Engineering or similar qualification would be an advantage. Duties include inspection of motor vehicles as prescribed under the Traffic Act, Cap. 403.

Architectural Draughtsman Grade II, Ministry of Works (No. 106/67)

Salary scale.—£700 to £1,060—AGREEMENT only.

Applicants should be educated up to Cambridge School Certificate standard of education and must have a minimum of four years' experience as a draughtsman in an Architect's office, excluding any time spent as an apprentice, or must have passed or been exempted from the Building Technician's

Examination of the East African Institute of Architects. A sound knowledge of building construction and practice is essential and applicants must have the ability to work up sketch plans and prepare full working drawings for various types of buildings ranging from small domestic buildings to large multi-storied building. They must be capable of a certain amount of simple design work. Applicants who have passed, or have been exempted from, the Intermediate Examination of the East African Institute of Architects would be eligible for appointment as Architectural Draughtsman Grade I, Scale £850 to £1,060.

Water Bailiff, Department of Water Development, Ministry of Natural Resources (No. 107/67)

Applicants must be at least 20 years old, of Cambridge School Certificate standard of education with fluency in spoken and written English and thorough knowledge of Swahili. They must be able to write concise reports of a technical nature relating to flow measurements of streams and rivers, to use a Dumpy level and to read survey plans. They should be able to control Water Guards, to carry out inspections of rivers, gauging of flows and control of water diversions and extensive safari along rivers. Administrative duties involve the scrutiny of legal documents relating to water rights and permits. Water Bailiffs must have a good personality and ability to deal with the public with tact and, when required, firmness.

## THE GOVERNMENT LANDS ACT

(Cap. 280)

Industrial Area, Nairobi: Light Industrial Plots, Burnley Road

THE Commissioner of Lands invites applications for plots of land in the Light Industrial Area, Nairobi, for light industrial purposes as described in the Schedule hereto. A plan of the area may be seen in the Lands Department.

- 2. Applications must be sent so as to reach the Commissioner of Lands not later than noon on 5th May 1967.
- 3. Applicants must enclose with their applications their cheque for Sh. 1,000 drawn on the applicant's own banking account (no other cheques will be accepted) made payable to the Commissioner of Lands as a deposit, which will be dealt with as follows:—
  - (a) If the applicant is offered and takes up and pays for the plot within the period of 14 days as required by Condition No. 5 below, the deposit will be credited to him
  - (b) If the application is unsuccessful the applicant's deposit will be returned to him.
  - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required by Condition No. 5 below the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.
- 4. Each application should be accompanied by a statement indicating—
  - (a) the amount of capital it is proposed to spend on the project;
  - (b) the amount of actual capital available for development with a banker's letter, or other evidence of financial status in support;
  - (c) the manner in which it is proposed to raise the balance of the capital required for development, if any;
  - (d) full details of the proposed trade(s) should be submitted.
  - (e) whether the applicant runs an established business or whether it is proposed to start a new business or sell/ sublet the premises.
- 5. The successful allottee of the plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been successful the stand premium and proportion of the annual rental together with survey, conveyancing, stamp duty and registration fees, contribution in lieu of rates and provisional service charges. In default of payment within the specified time the Commissioner of Lands may cancel the allotment and the applicant shall have no claim to the plot.

## General Conditions

The grant will be made under the provisions of the Government Lands Act (Cap. 280 of the Laws of Kenya) and title will be issued under the Registration of Titles Act (Cap. 281).

- 2. The grant will be issued in the name of the allottee as given in the letter of application and will be subject to the Special Conditions set out below.
- 3. The term of the grant will be for 99 years from the 1st day of the month following the issue of the letter of allotment.

#### Special Conditions

- 1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2. The grantee shall within six months of the commencement of the term submit in triplicate to the local authority and the Commissioner of Lands, plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water) drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

### THE INDUSTRIAL COURT

Wages.

(2) Employees in Acting Capacity.

(3) Annual Paid Leave.

(4) Gazetted Public Holidays.

(5) Gratuity Payment.(6) Leave Allowance.

(7) Termination of Employment.

(8) Maternity Benefits.(9) Casual Labour.

(10) Effective Date and Duration.

After a careful consideration of all the submissions made by both Parties, the Court awards as follows:

- (1) Wages.-The Court awards an increase of Sh. 30 per month on the existing rates for the six grades. The Claimants' application for this increase to be applied on the individual wages of the employees is rejected.
- (2) Employees in Acting Capacity.—The Court confirms the present practice whereby if a person is required to act for a period of more than one week, he is granted the higher remuneration by way of acting allowance.
- (3) Annual Paid Leave.-The Court finds that in 1964 the Parties had agreed to 21 consecutive days' annual paid leave in respect of those employees with less than six years' service and 28 consecutive days for those employees who had completed more than six years' service. In view of this the Court awards both these benefits as agreed in 1964.
- (4) Gazetted Public Holidays.—On this issue as a gazetted public holiday is a worker's statutory right the Court cannot make an award modifying it in any way.
- (5) Gratuity Payment.-The Court awards that where in any of the constituent member firms of the Respondents a provident fund scheme did not exist, employees should be entitled to gratuity. The Court, therefore, awards the following gratuity scheme in respect of those employees who were not covered by a provident fund scheme prior to the National Social Security Fund:-
  - (a) An employee on completion of four years' continuous service with the Respondents shall be entitled to ten days' pay for every completed year of service by way of gratuity to be based on the employee's wages at the time of the termination of his service.
  - (b) An employee who is dismissed for misconduct shall not be entitled to gratuity.
  - (c) The effective date for the purpose of working out the benefits under this scheme shall be 1st January 1960, i.e. an employee shall not be entitled to any gratuity for services prior to 1st January 1960.
  - (d) This scheme shall cease with the implementation of the National Social Security Fund. Employees shall, however, continue to benefit under this award for services ever, continue to benefit under this award for services rendered up to the date of the implementation of the National Social Security Fund; for example, if an employee who started working in 1963 retires after eight years of service, then he shall be provided for the years of service up to the commencement of the National Social Security Fund on the basis of this award.
- (6) Leave Allowance.—The Court awards a leave allowance of Sh. 80 for Grades 1 and 2 and Sh. 50 for Grades 3 to 6.
- (7) Termination of Employment.—The Court awards as follows on this issue:
  - (a) An employee shall be on probationary period not exceeding three months from the date of engagement and during this period, such employee shall be subject to one week's notice or one week's pay in lieu.
  - (b) On completion of the probationary period, an employee shall be regarded as on the establishment of the Respondents and shall be subject to one month's notice or one month's pay in lieu of such notice. This condition will apply to an employee whose services are terminated other than for gross misconduct or other lawful cause, provided that such employee may be given warnings in writing, up to three in number, being registered on his employment card, which the employee has signed.
  - (c) An employee who receives three such warnings shall be liable to summary dismissal, provided that all such warnings shall be erased from the history card of an employee after a period of 12 months from the date of the last warning.
  - (d) An employee may be summarily dismissed for gross misconduct as defined in the Employment Act.
  - (8) Maternity Benefits .- Nil award.

- (9) Casual Labour.—The Court awards that any person employed as a casual labourer shall be paid on the basis of this award, that is, he shall get the appropriate rate for the job on which he is employed and his daily rate shall be worked out by dividing the appropriate rate by 26. The Court rejects the Claimants' demands that fringe benefits should be extended to casual labourers.
- (10) Effective Date and Duration.—The Court rules that this award shall be with effect from 1st October 1966, and shall remain in force for a period of 18 months from that date.

Overalls.

#### AWARD

In the Engineering Industry generally in Kenya overalls are issued by the majority of employers. The Claimants submitted that, some of the Respondents' competitors in Mombasa also issued overalls. The Court accepts these facts and on the information gained by the Court members when they visited the Respondents' workshops in Mombasa, the Court finds that the clothes of the workers are exposed to abnormal and heavy wear and tear, moisture, dust, oil and grease. Moreover, one of the Respondents employing about 600 workers has offered the facility to his employees of buying their overalls from them which they buy in bulk. Another Respondent has actually got the overalls in his store which he intended to issue to his workers, but did not do so on account of the present

The Court has carefully gone through the offer made by the Respondents during the hearing of this dispute but finds that, in some cases it is not adequate.

The Court has given anxious thought to the Respondents' contention that if an award was made on generalization, then it would create an unreasonable precedent. It was particularly in view of this submission that the Court decided to visit and see the workers actually at work. The Respondents need have no fear on this score as every issue before the Court is considered on its merits.

In view of the foregoing and after having carefully considered all the submissions of the Parties, the Court awards that all the workers (excluding clerks) who are specified in the list submitted by the Respondents who are affected by this dispute other than labourers and gardeners and yard cleaners, should be issued with two pairs of overalls to be replaced as and when necessary but not earlier than 12 months. The labourers should be issued with aprons. The gardeners and yard cleaners do not benefit by this award.

The Court further lays down that, if an employee is found not wearing his overalls or apron, as the case may be, without good reason on more than three occasions in any one month, he shall forfeit his right to the overalls or the apron.

Finally those workers employed on cleaning ships, tanks and bilges will be allowed to continue with the current practice but without prejudice to their right under this award.


